## Executive Summary

2205 N Broadway presents a rare opportunity to acquire a freestanding commercial building in the heart of Lincoln Heights, one of Los Angeles' oldest and most culturally rich neighborhoods. The property features 1,950 SF of ground-level space plus a 566 SF basement, with high ceilings and a flexible layout. Currently operating as a pool hall and beer bar, it includes a grandfathered Type 40 liquor license permitting onsite and offsite beer sales from 9 AM to 1 AM daily.

Built in 1896, the property combines historic character with zoning benefits under the LAC2 State Enterprise Zone and Opportunity Zone, offering potential tax incentives and redevelopment flexibility. Its prime Broadway frontage provides strong visibility and proximity to Downtown LA, Chinatown, Echo Park, and Frogtown, alongside major projects like the Lincoln Heights Jail redevelopment and the \$1B LA River restoration.

2205 N Broadway is more than just a bar—it is a one-of-a-kind neighborhood asset with historic roots, modern potential, and significant upside for owner-users or creative retail operators in one of LA's most authentic and evolving submarkets.
