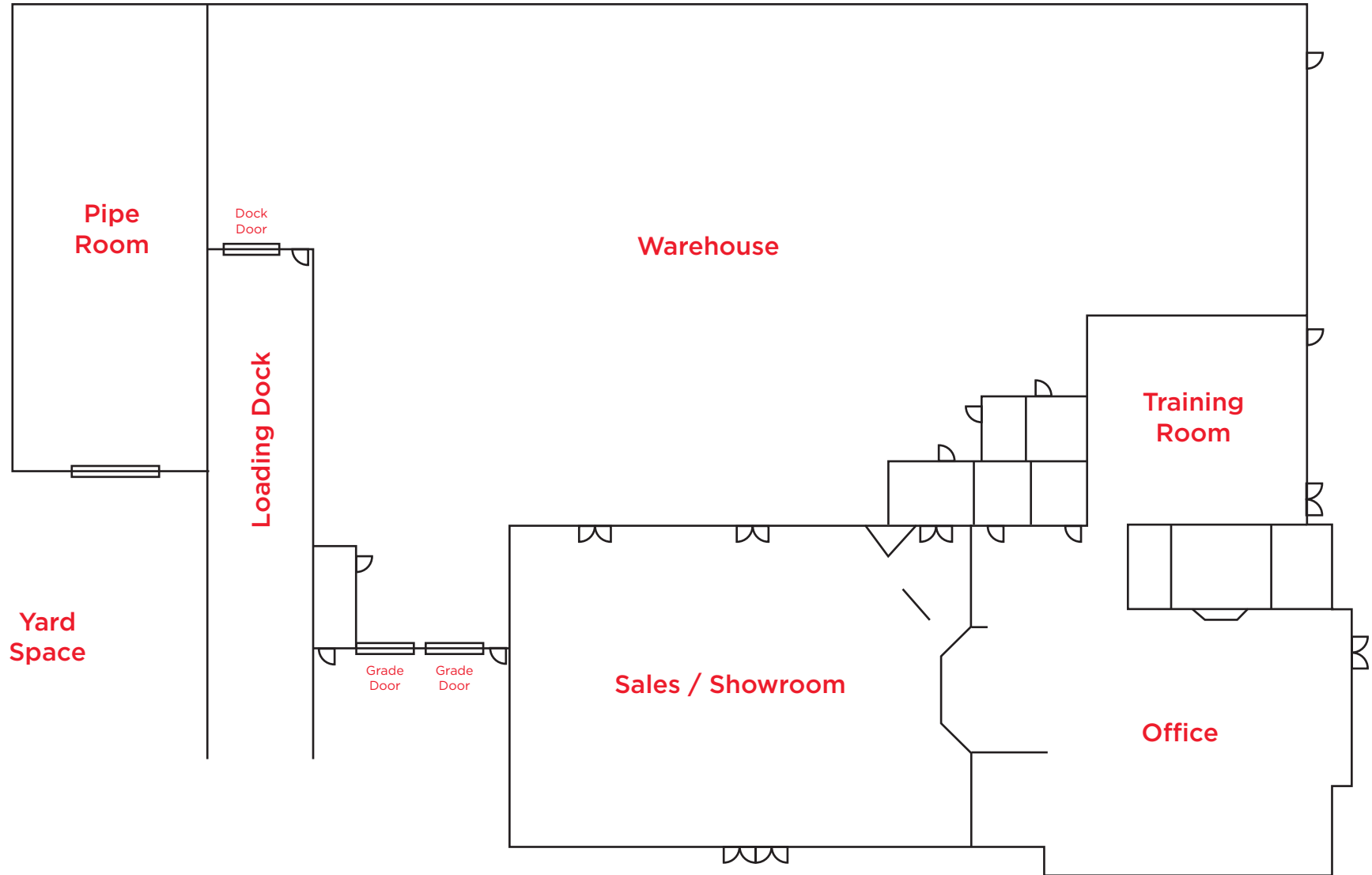

FLOOR PLAN: 2025 W 2nd AVE, EUGENE OR

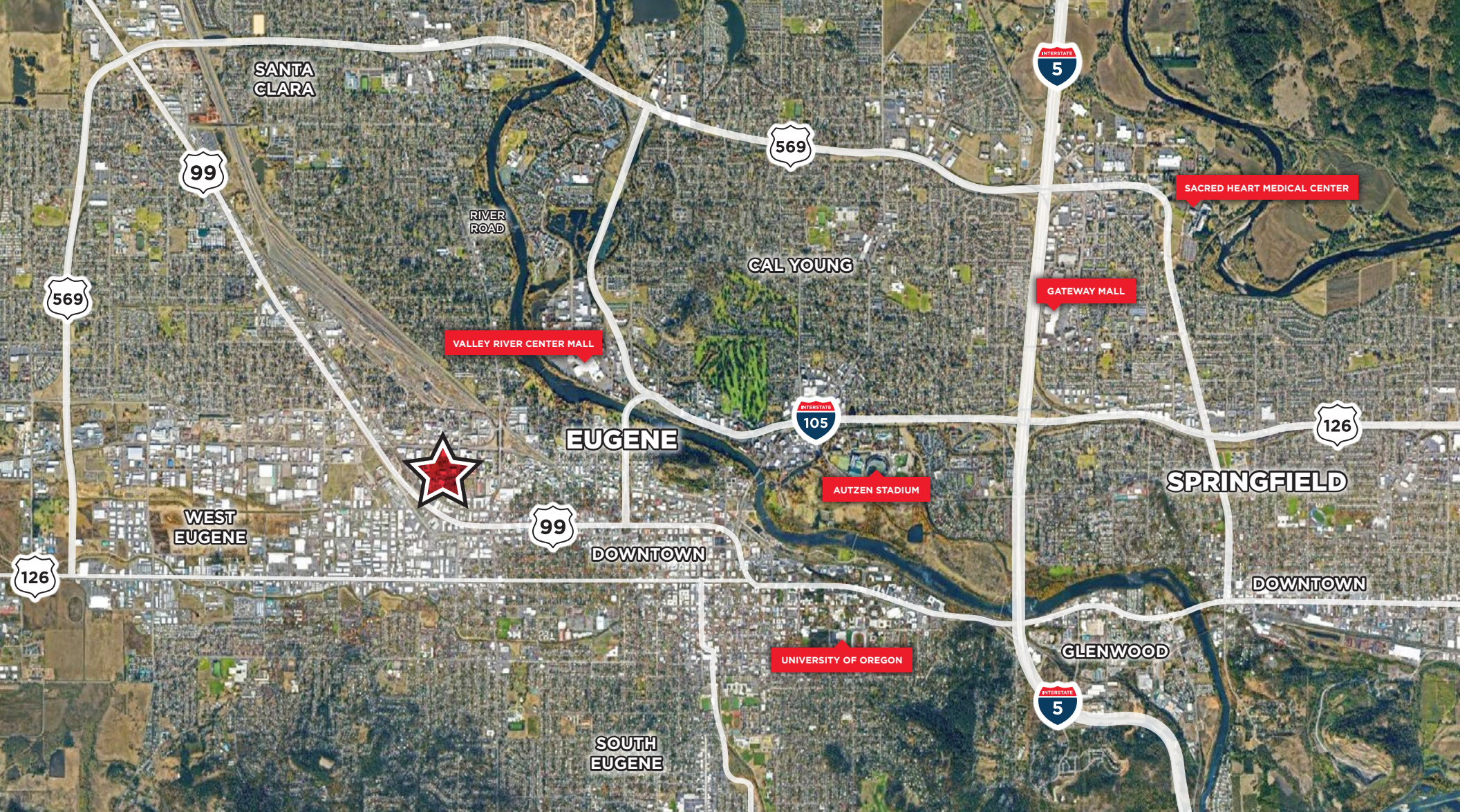
