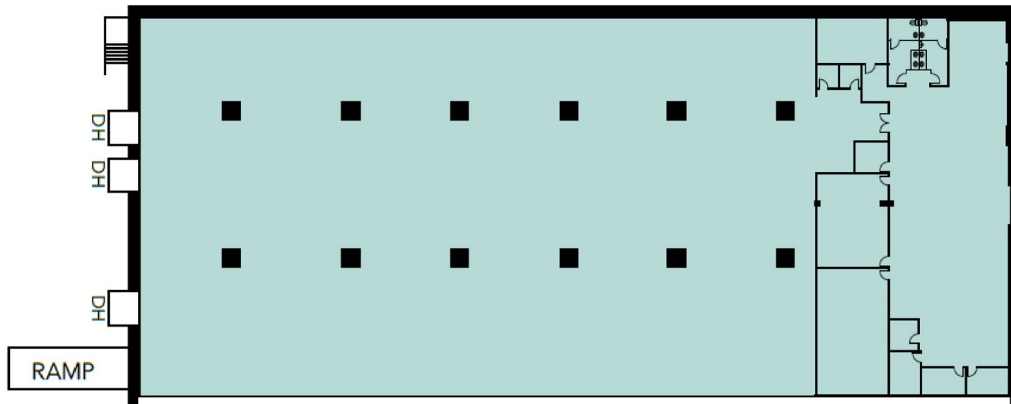
Property Description
