

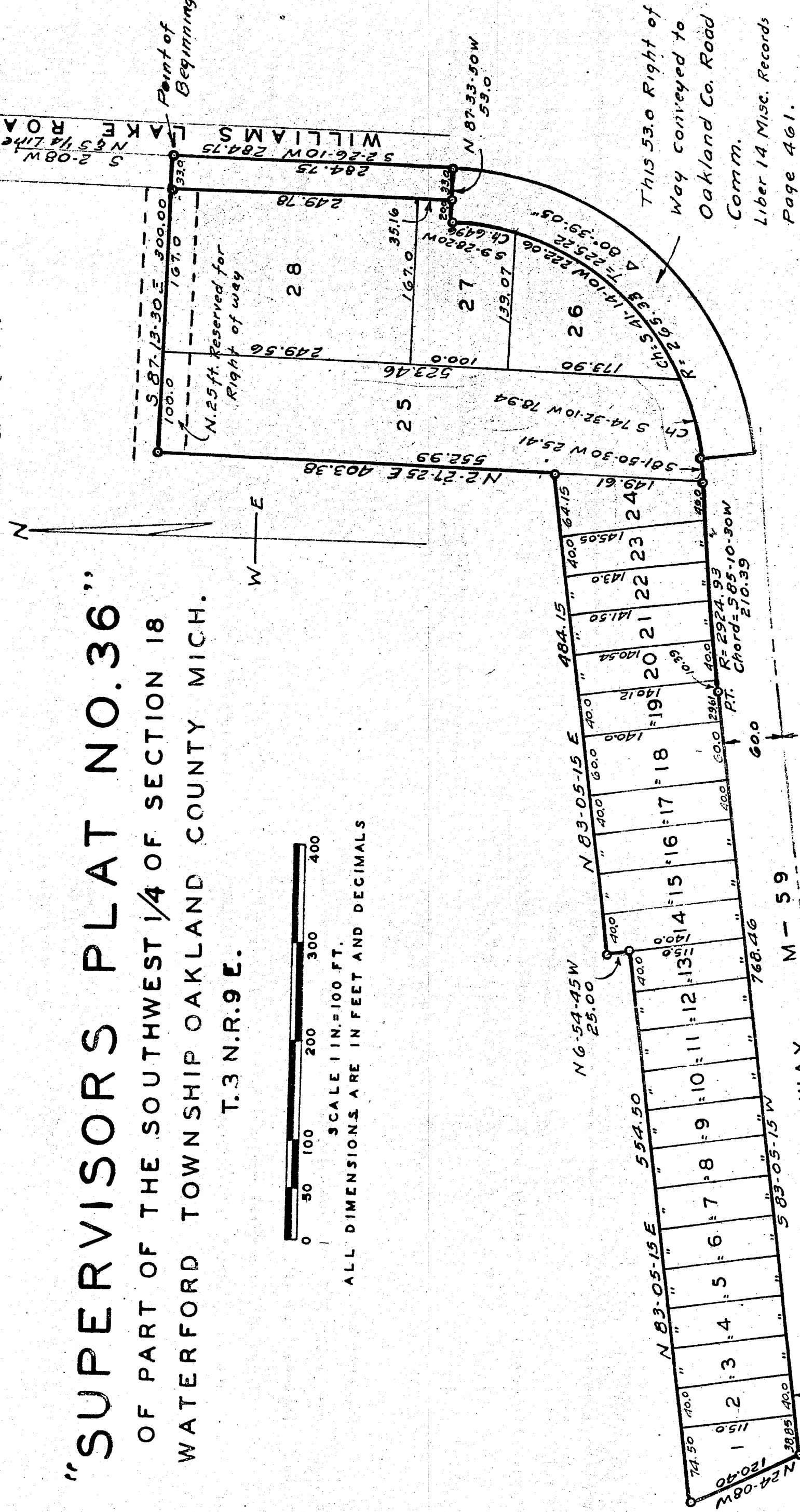

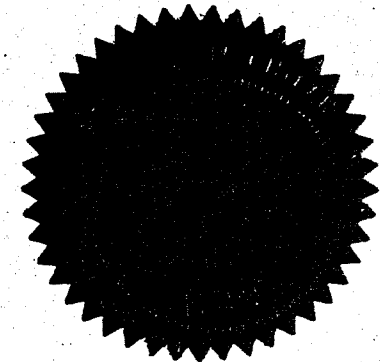

DESCRIPTION OF LAND PLATTED.

The land embraced in the annexed plat of "SUPERVISOR'S PLAT No. 36" of part of the southwest 1/4 of section 18 Waterford Township Oakland County Michigan, T. 3 N. R. 9 E. is described as follows: - Beginning at a point on the north and south 1/4 line of section 18 located S 2° 08' W 1304.41 feet from the center of section 18 and running thence S 2° 26' 10" W 284.75 feet, thence N 87° 33' 50" W 53.00 feet, thence southerly and westerly on a curve to the right having a radius of 265.33, a central angle of 80° 39' 05" and a tangent length of 225.22 feet, by the following courses, S 9° 28' 20" W 64.96 feet, S 41° 14' 10" W 222.06 feet and S 74° 32' 10" W 78.94 feet to the end of said curve, thence S 81° 50' 30" W 25.41 feet to a point on the northerly line of State Highway M-59 which is a curved line having a radius of 2924.93 feet and whose long chord bears S 86° 10' 30" W 210.39 feet, thence continuing westerly along said curved line to its point of tangency, thence S 83° 05' 15" W 769.46 feet, thence N 24° 08' W 120.40 feet, thence N 83° 05' 15" W 554.50 feet, thence N 6° 54' 48" W 25.00 feet, thence N 83° 05' 15" W 484.15 feet, thence N 2° 27' 25" W 403.89 feet, thence S 87° 13' 30" W 300.00 feet to the point of beginning.

SURVEYOR'S CERTIFICATION.

I hereby certify that the plat hereon delineated is a correct one and that permanent metal monuments consisting of bars not less than 1/2 inch in diameter and 48 inches in length enclosed in concrete cylinders at least 4 inches in diameter and 48 inches in depth have been placed at points marked thus 'o', as thereon shown at all angles in the boundaries of the land platted and at all intersections of streets with the boundaries of the plat as thereon shown.
