New Mission-Critical Building

2039 S Broad Street was built in 2019 and serves at Continental Aeospace Technologies U.S. headquarters.

Mobile Aeroplex at Brookley

The Property is located on campus at the Brookley Aeroplex, a thriving industrial complex, supports Mobile International Airport and Airbus' operations and accommodating more than ninety businesses including supply chain providers and others supporting the transportation industry.

Port of Mobile

The Port of Mobile is on track to becoming the largest port in the Gulf of Mexico with more than \$1 billion in capital projects underway statewide. The Army Corps of Engineers is actively deepening the Mobile ship channel to 50 feet. Other projects include constructing an interterminal connector bridge to create on-dock rail access at the container terminal, developing a logistics park, and modernizing general cargo piers.




