Resolution for Saugerties Planning Board Site Plan Approval for Bevehrcort, LLC S.B.L – 18.1 – 3 – 57.2

Whereas, Bevehrcort LLC, represented by John Fuller, P.E. requests Site Plan Approval for an Inn on Washington Ave. in the Recreational Business (RB) Zoning District; and

- 4) The applicant must submit a letter of approval from the Village of Saugerties Water Department for inclusion into the Village water district.
