

# Executive *Summary*







# Park Infrastructure



## WATER

On site well, drilled in 1975. New water filtration system complete with submersible pump supplying up to 235L/min. Average daily flow rate of the park is 20L/min. New storm water drains, drainage wells and pumps. New man hole covers and risers.



## SEPTIC SYSTEM

As per ECA issued 2012, Turnberry estates meets all regulation requirements. Significant upgrades have been made in the last 2 years. New septic pumps and floats, all new septic lines. Annual Environmental Engineering Reports are available. Current septic system is designed for enough capacity for an additional sites.



## ELECTRICAL SYSTEM

All sites are separately metered. Each site is serviced with 200 amps. The property is complete with 7 ground-mounted distribution transformers.

## SHED

30 X 60 ft, 12 ft tall small workshop storage for spare equipment, ground keeping equipment, pool filter and treatment room. New door and roof.



# Park Infrastructure Cont'd.



## POOL

20 X 40 kidney shaped pool, 3ft shallow end, 7ft deep end. 24,000 gallons, chlorinated, propane heated pool. New heater and new resurfacing in 2024.



## CLUBHOUSE

Late 1970's 1,800 SF office, kitchen with recent upgrades, common room, exercise/ game room, mens and womens washrooms, water treatment room. New windows & flooring throughout.



## ROADS

All new roads paved in 2023/2024. 3/4" drainage stone topped with 63mm of HL# asphalt.

## EXPANSION POTENTIAL

Various Renderings are available upon request. Most viable site plan for the property estimates an additional 10 sites to the property making the potential total 60 sites. The site plan to the right shows an option for an additional 41 sites.
