The Ballou Team is pleased to present 107–109 Court Street a fully approved redevelopment opportunity in the heart of Downtown New Haven. The City Plan Commission has approved plans to expand and convert two adjoining mixed-use buildings into four-story structures with 40 total residential units and two retained street-level commercial spaces.

The existing site includes a two-story brick building at 107 Court Street and a four-story mixed-use building at 109 Court Street, currently home to retail tenants Greg's Tailoring and Formals and Noir Vintage & Company, along with a mix of apartments and single-room occupancy units.

The approved plan will introduce five new ground-floor dwelling units and add upper stories for a unified height and improved layout. Of the 40 total units, five will be affordable under the Inclusionary Zoning Ordinance, and three will be reserved for Housing Choice Voucher residents. Two on-site parking spaces will be provided for building maintenance use.

Situated steps from City Hall, the New Haven Green, Yale University, and Union Station, the property benefits from exceptional walkability, transit access, and proximity to major employment drivers. The project's approved entitlements, downtown location, and flexible mixed-use design position 107–109 Court Street as a, shovel-ready investment aligned with the city's ongoing demand for well-located, efficient urban housing.
