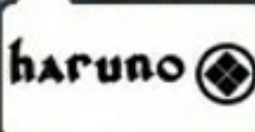

LOCATION MAP & TRAFFIC COUNTS

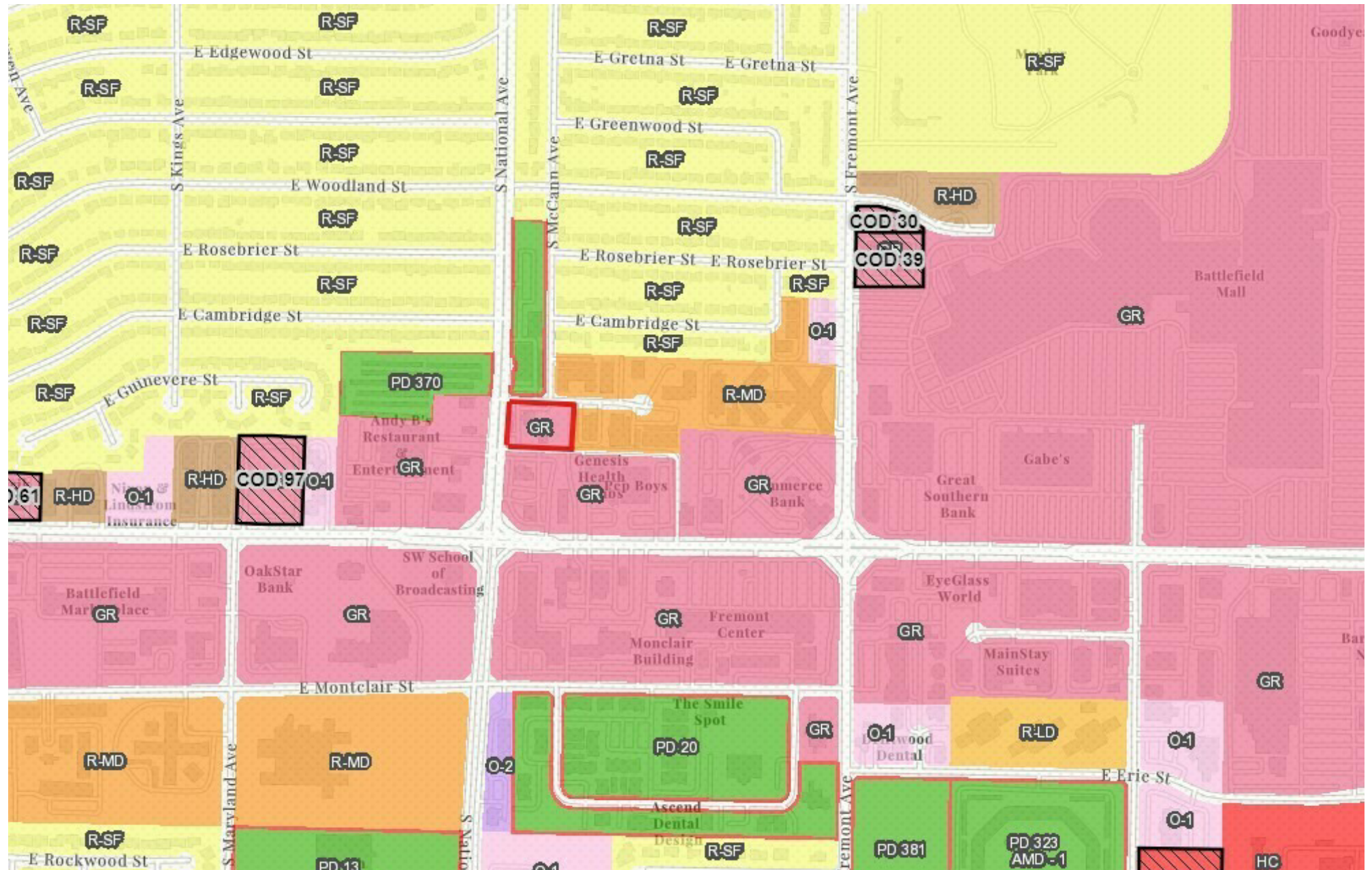
