



Area Overview - Oakland Park





The Urban League's **Village at Oakland Park** will bring a vibrant, intergenerational neighborhood to the City's west side. The City Commission approved the first step of the project in February to create area median income aligned housing stock as part of a larger initiative, alongside projects like the Sky Building and the Horizon of Oakland Park, to provide attainable housing opportunities for all.
