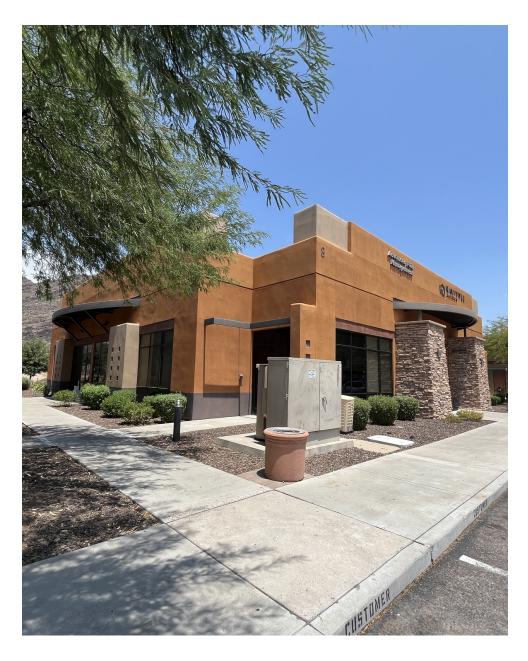

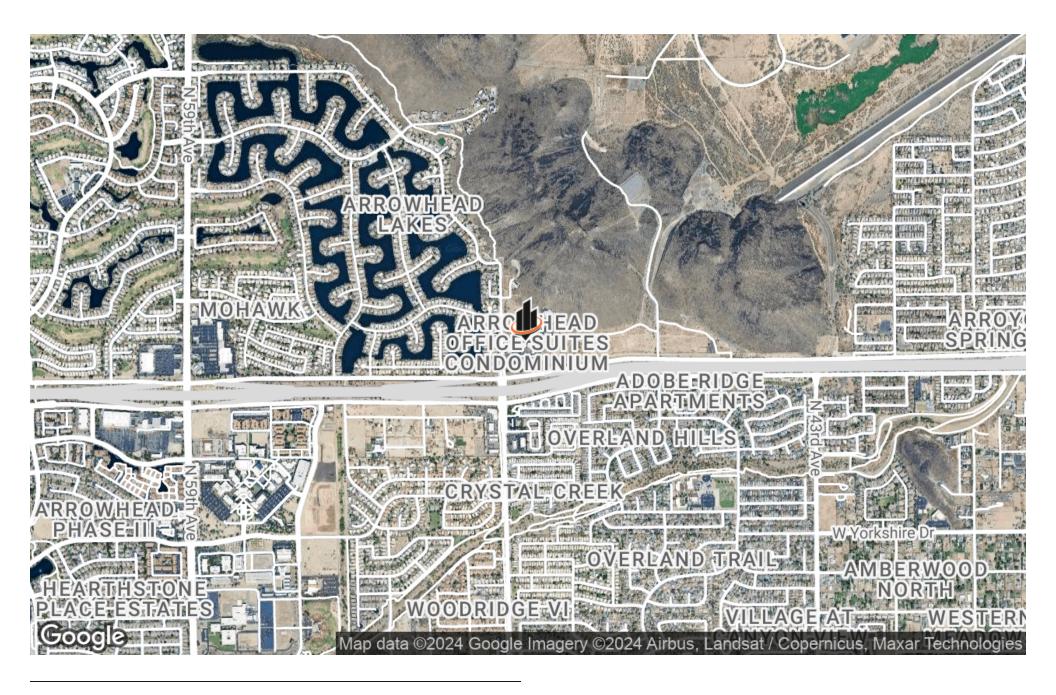
LOCATION DESCRIPTION
