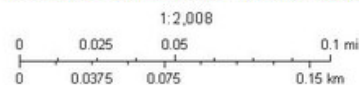
TOPOGRAPHIC MAP | DEVELOPMENT OPPORTUNITY

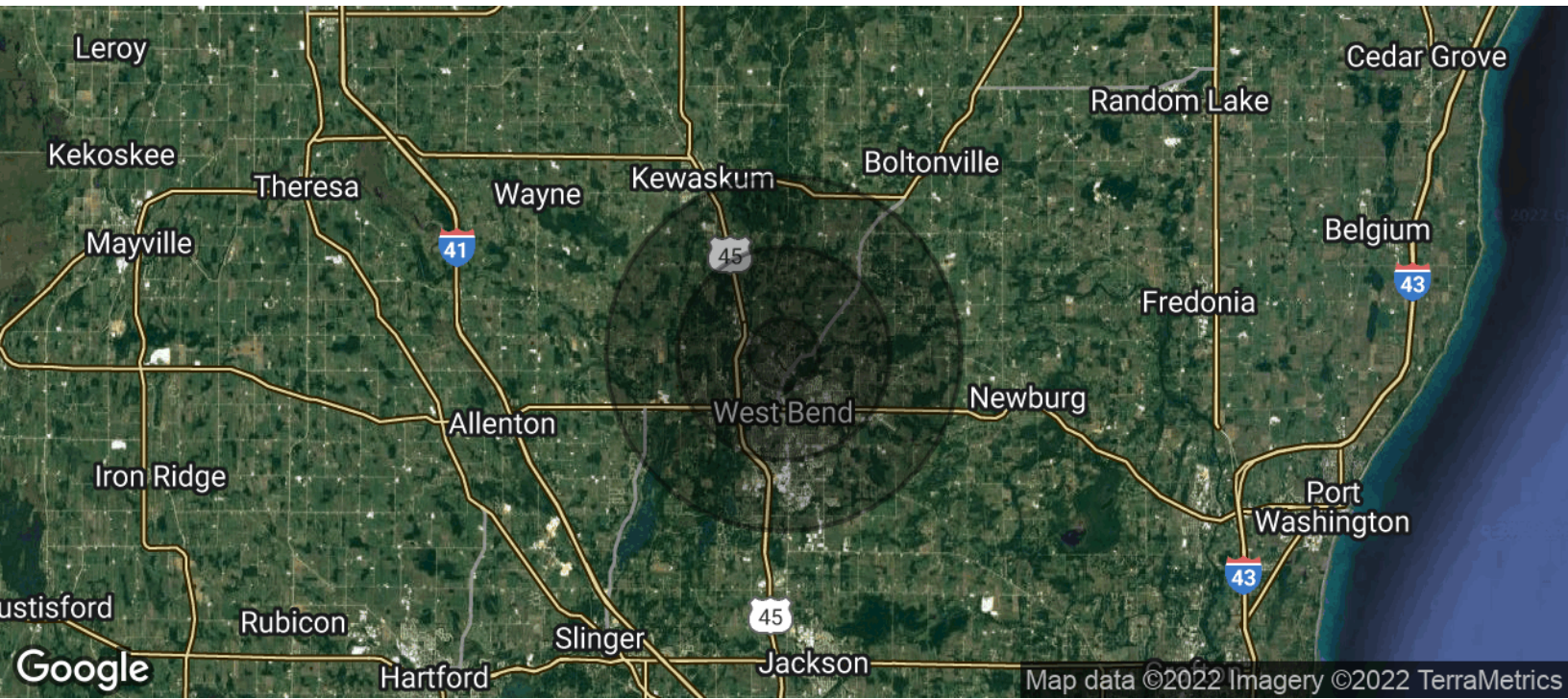
