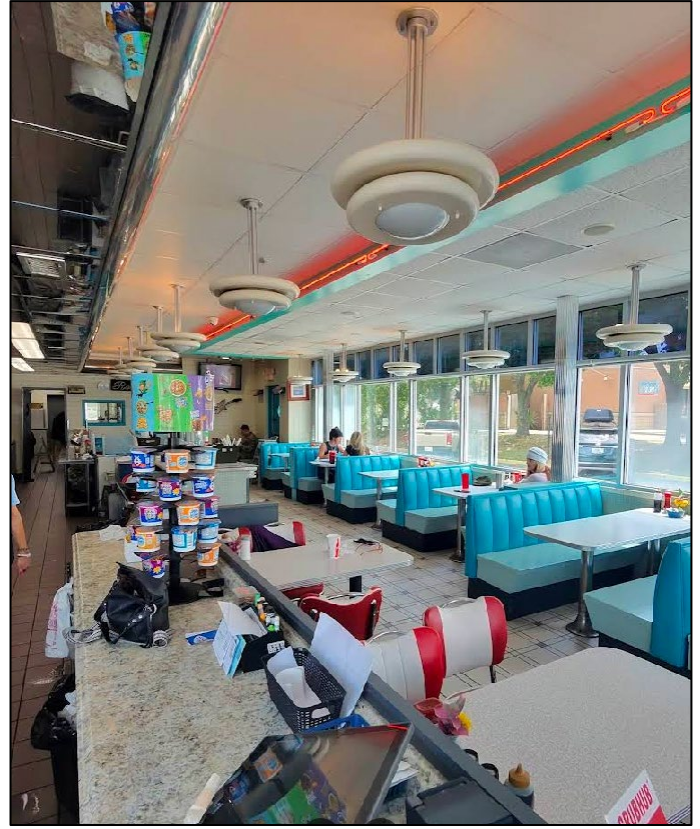


FOR LEASE- 7202 Abercorn St., Savannah, GA 31406

This is a rare opportunity to lease a fully functional freestanding restaurant on Abercorn St. The leased area will consist of an approx 1,716sf building on approx 0.38ac of land. The property has easy access to two driveways onto Abercorn. There's a possibility of cross access being established in the future between this property and the neighboring Convenience Store which would allow for cross access to Eisenhower Blvd. The property owner also owns all of the adjacent properties shown in highlight on the attached aerials. The adjacent property to the north is currently a vacant retail building that could be combined with this site for a possible redevelopment. In addition to the vacant building, it is possible that additional property could also be made available for lease. The current City of Savannah B-C zoning classification allows for a wide range of uses. All traffic counts shown are 2023 GDOT counts.

Current median household income is \$53,554 in the area, compared to \$79,068 for all U.S. households. Median household income is projected to be \$65,901 in five years, compared to \$91,442 all U.S. households.

Currently, 42.8% of the 67,911 housing units in the area are owner occupied; 44.7%, renter occupied; and 12.5% are vacant. Currently, in the U.S., 57.9% of the housing units in the area are owner occupied; 32.1% are renter occupied; and 10.0% are vacant. In 2020, there were 67,167 housing units in the area and 13.0% vacant housing units. The annual rate of change in housing units since 2020 is 0.26%. Median home value in the area is \$298,126, compared to a median home value of \$355,577 for the U.S. In five years, median value is projected to change by 6.74% annually to \$413,171.
