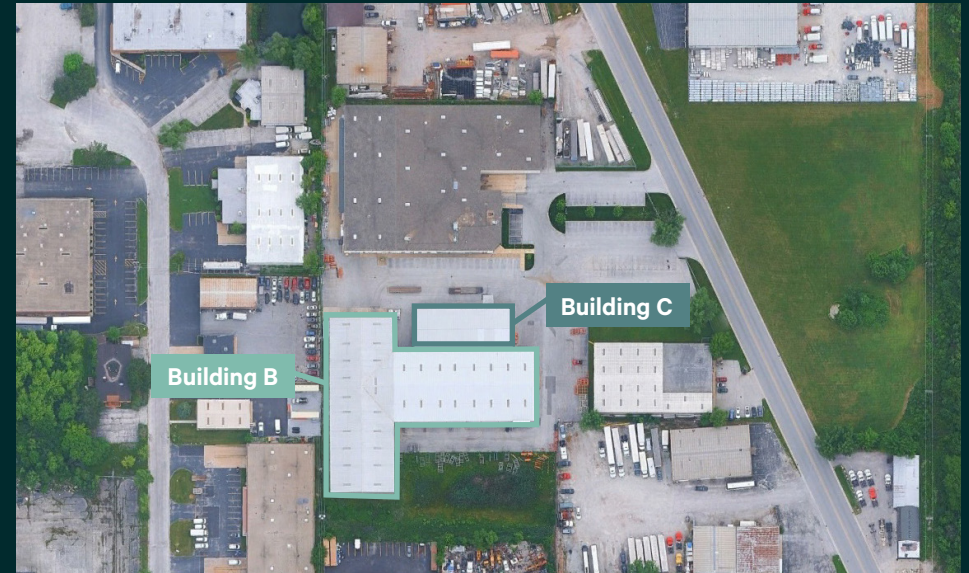

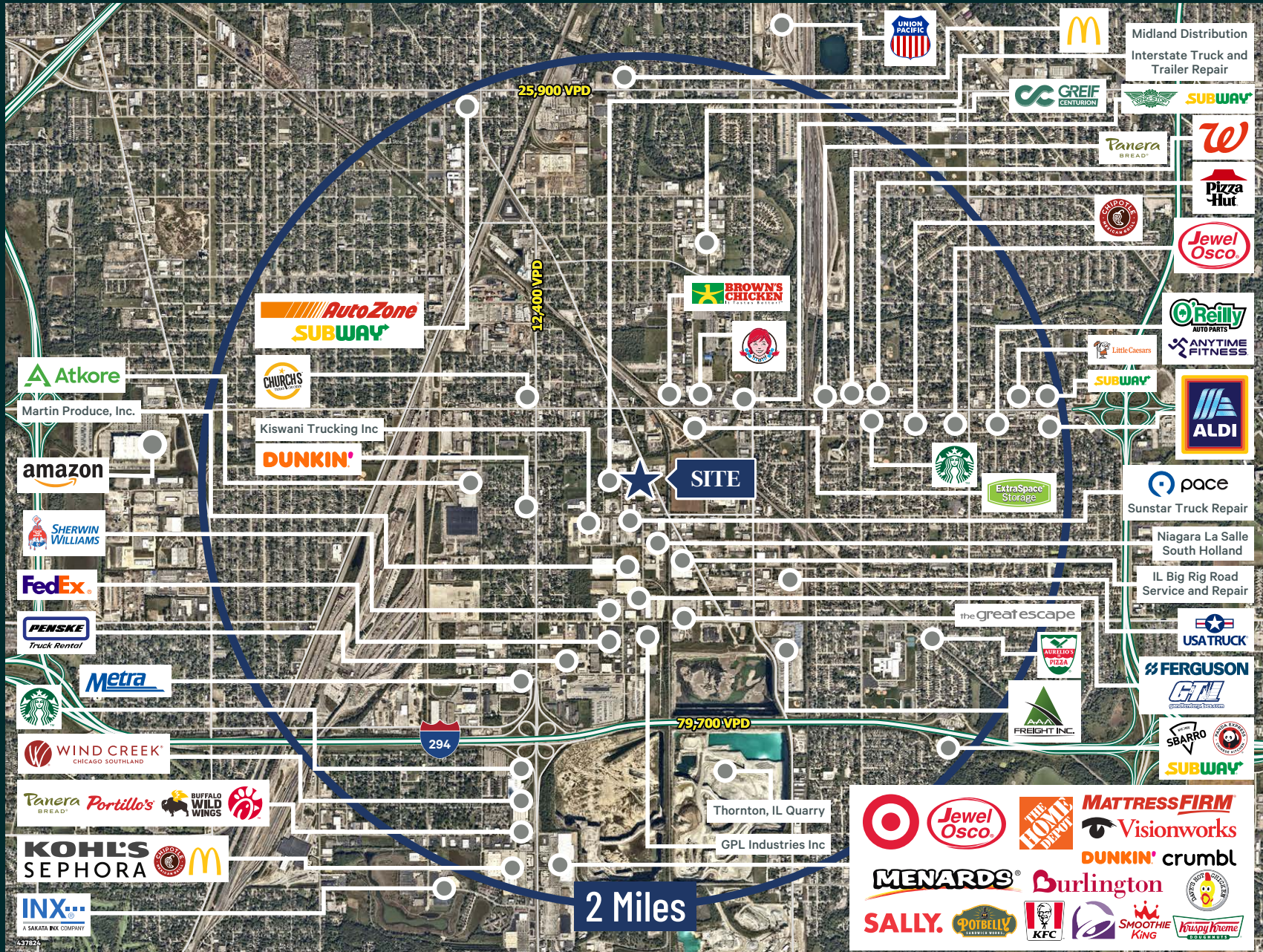

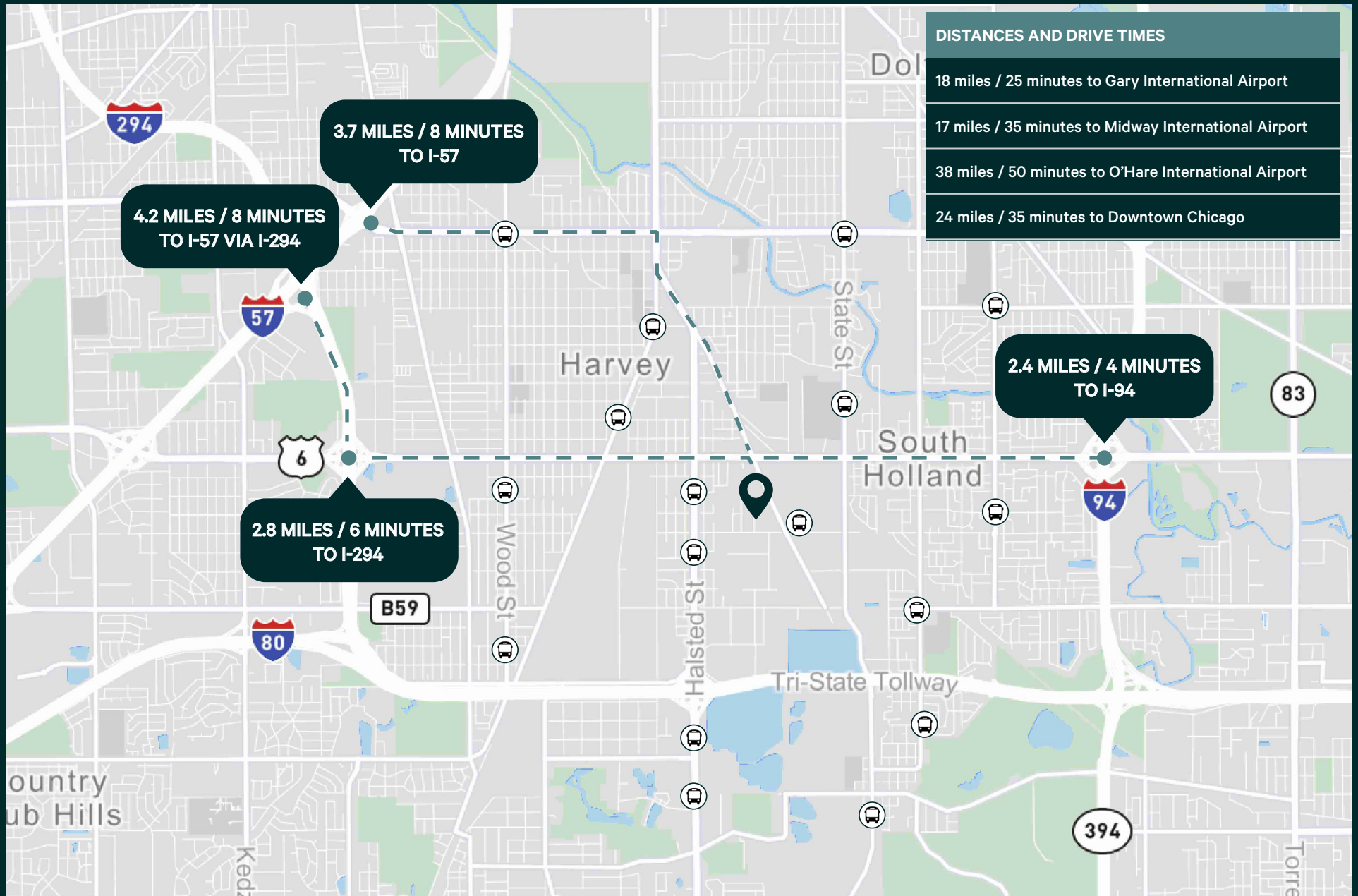

Access Map

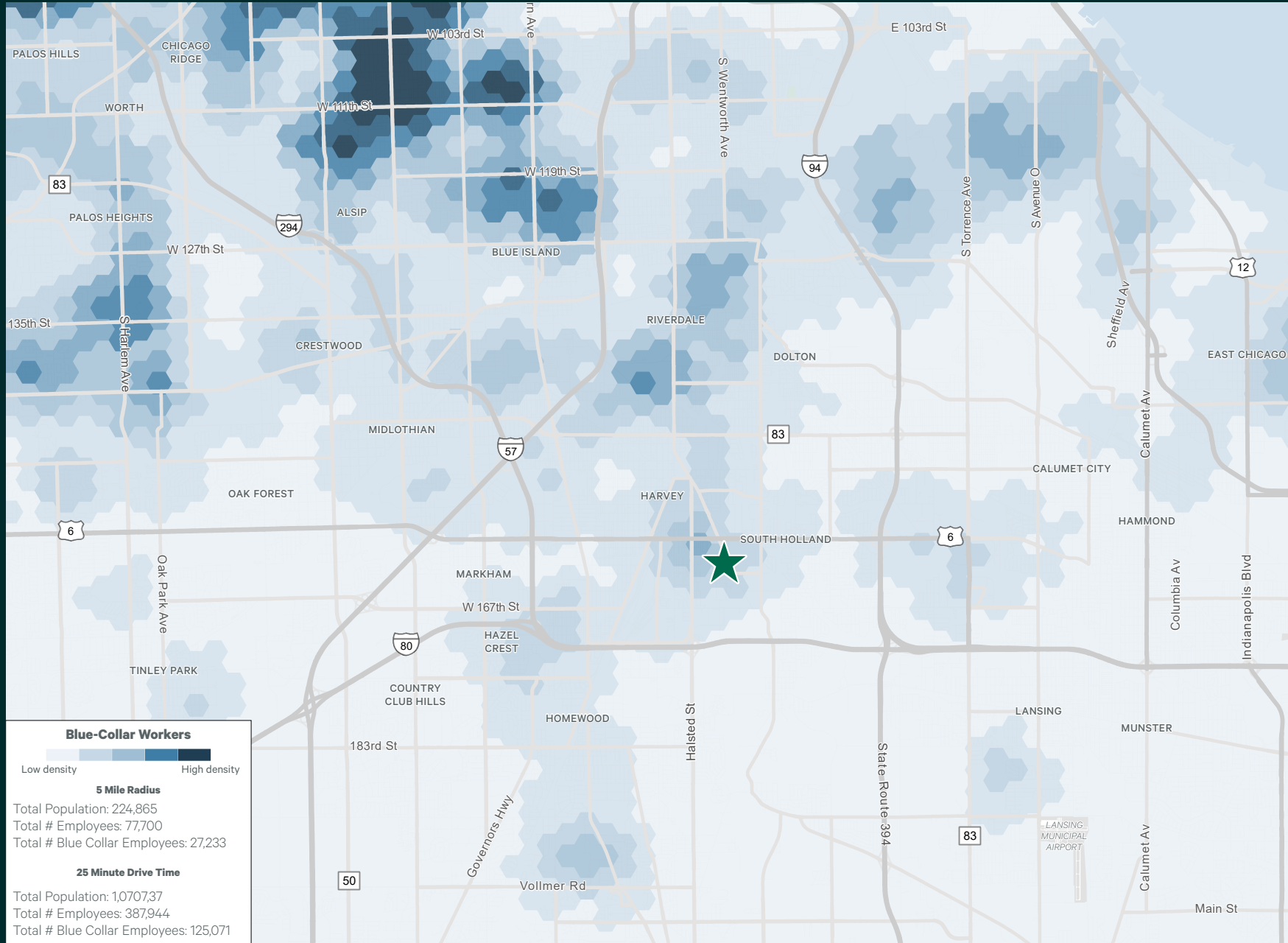
