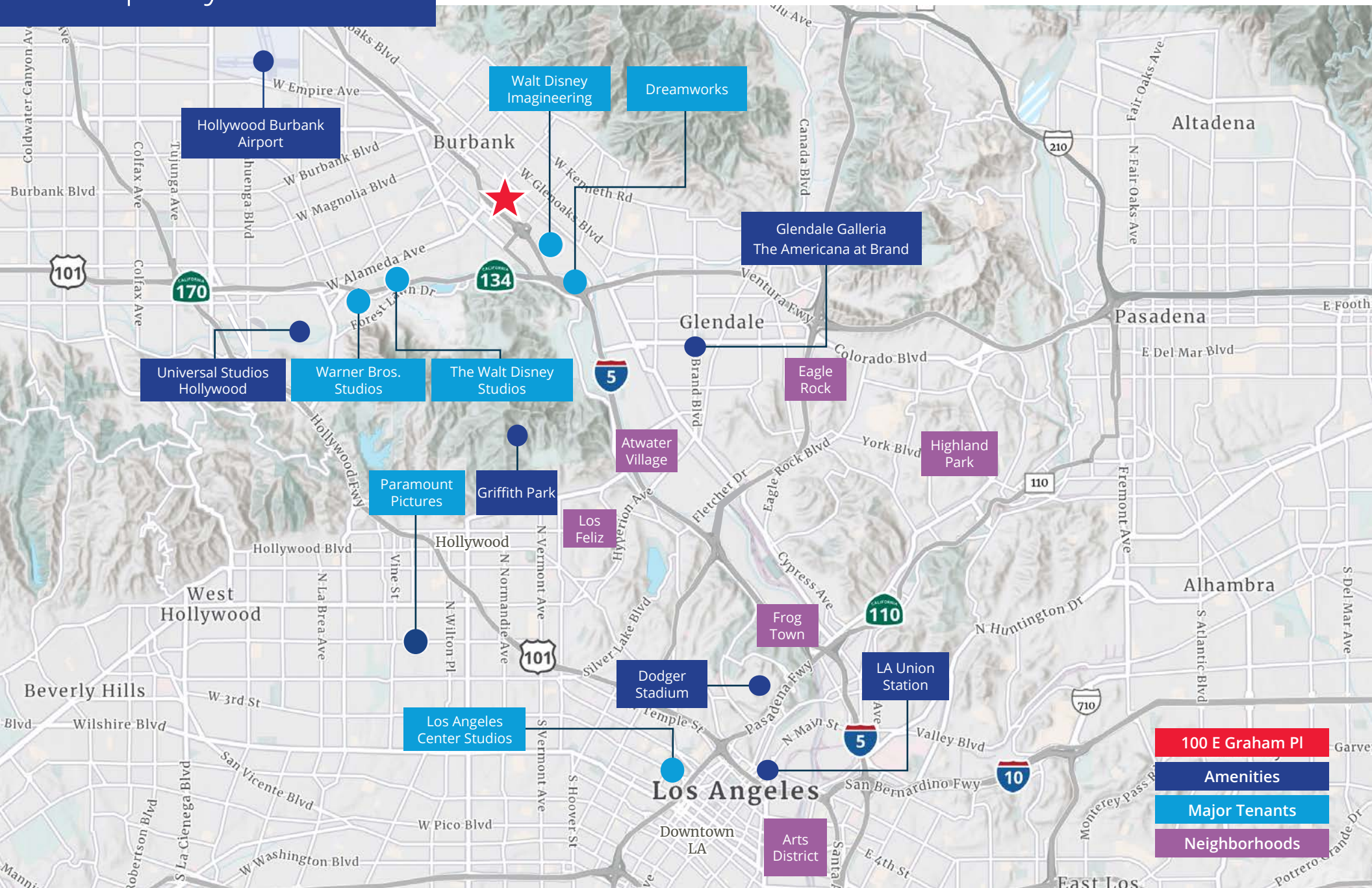

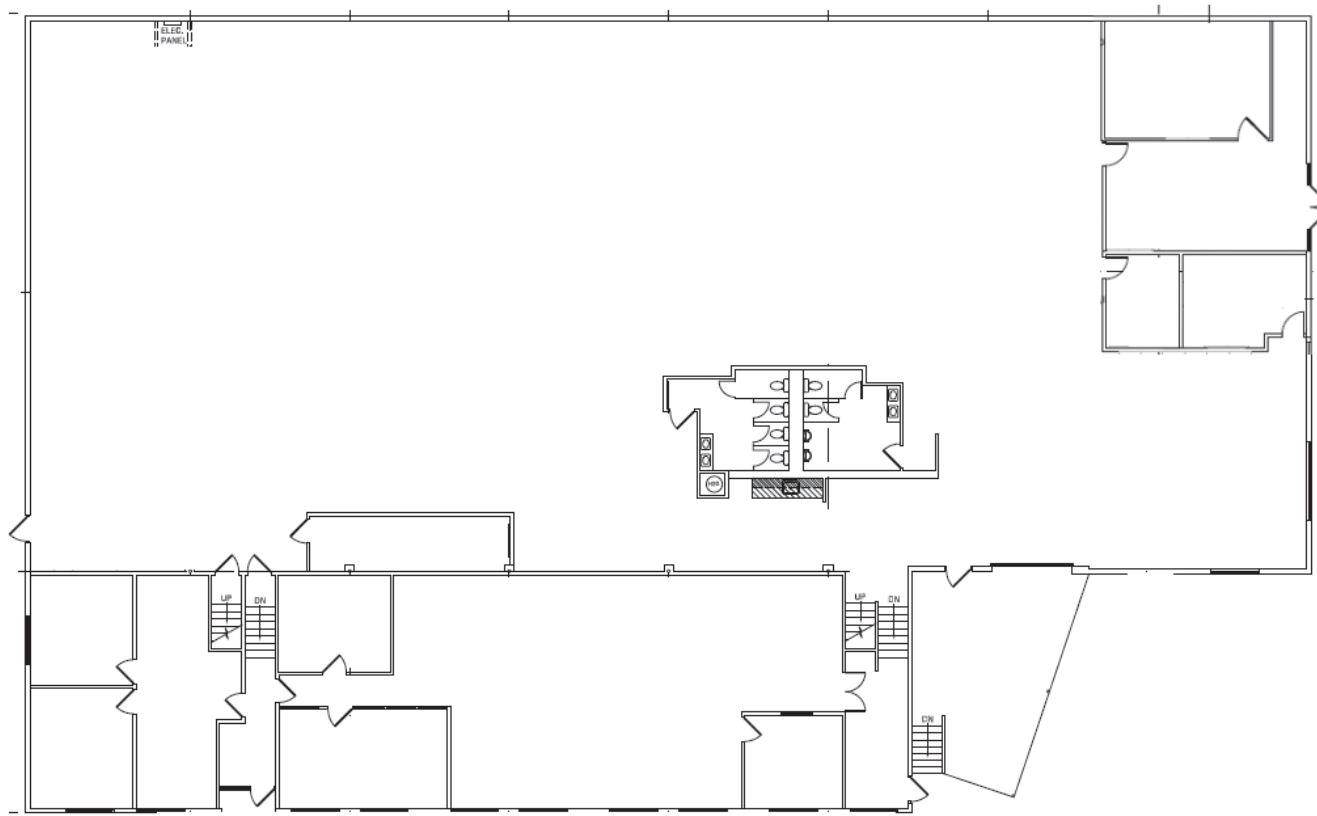

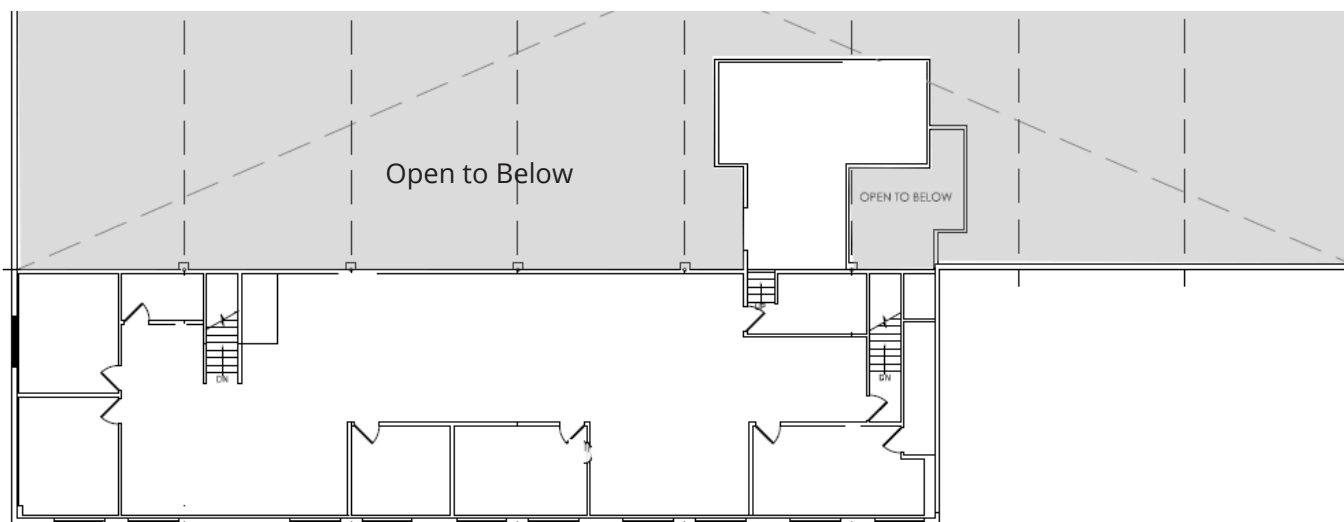
Property Location
