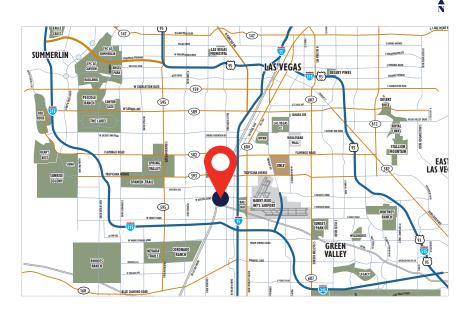

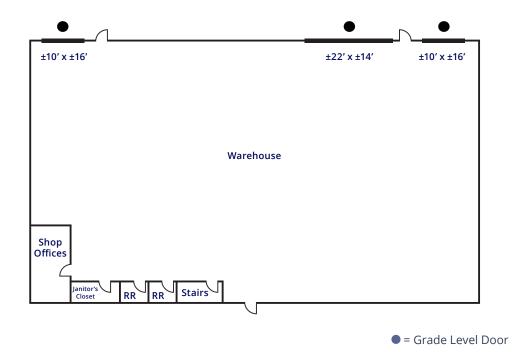

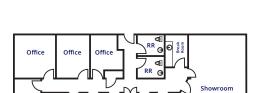

Warehouse Floor Plan

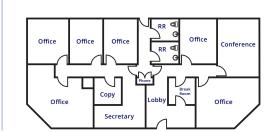


Office Floor Plans

First Floor



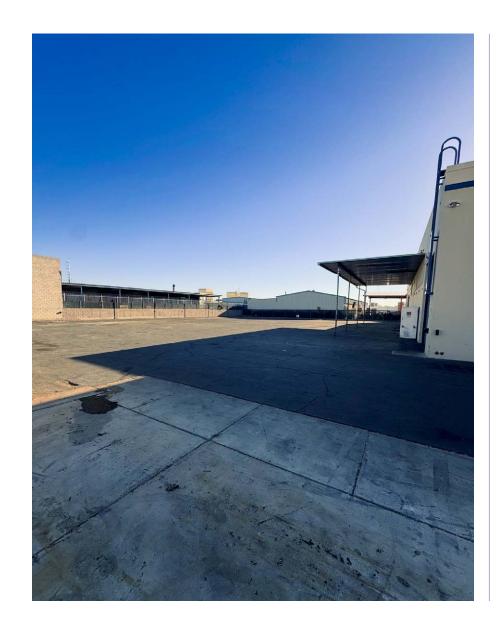

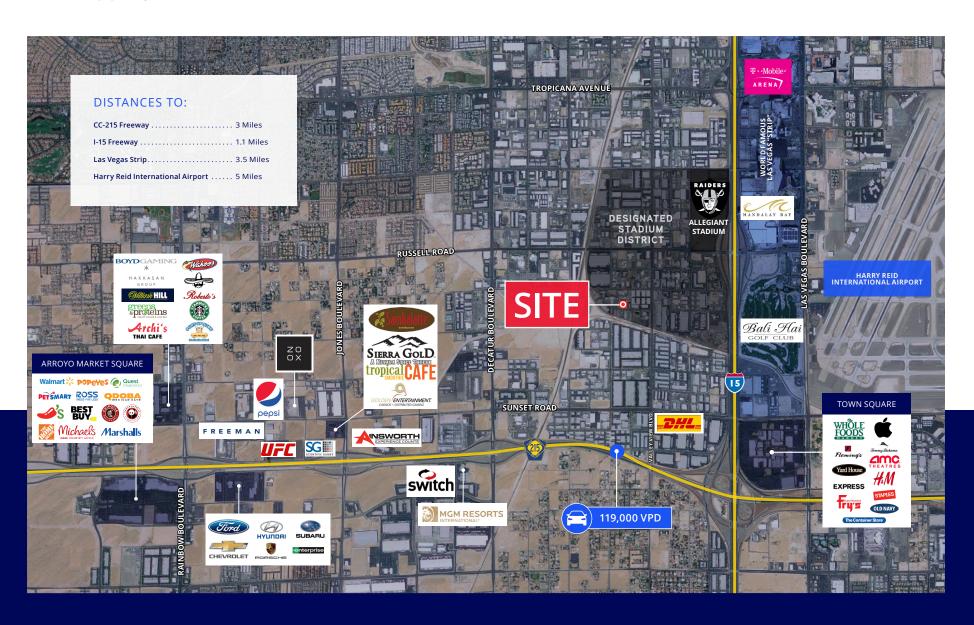
