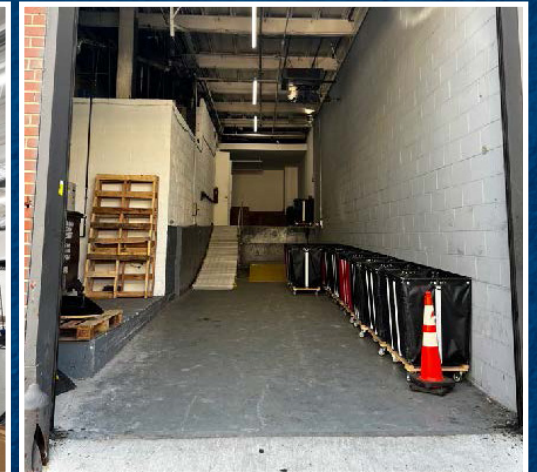
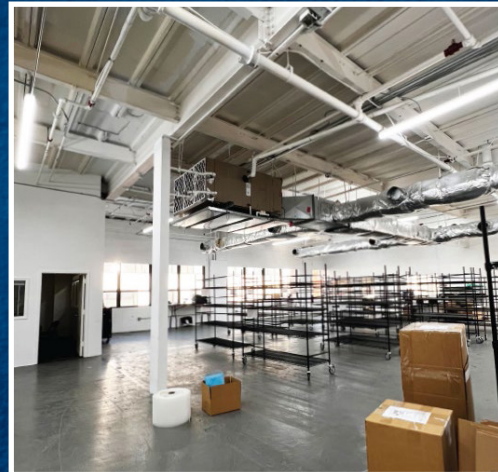

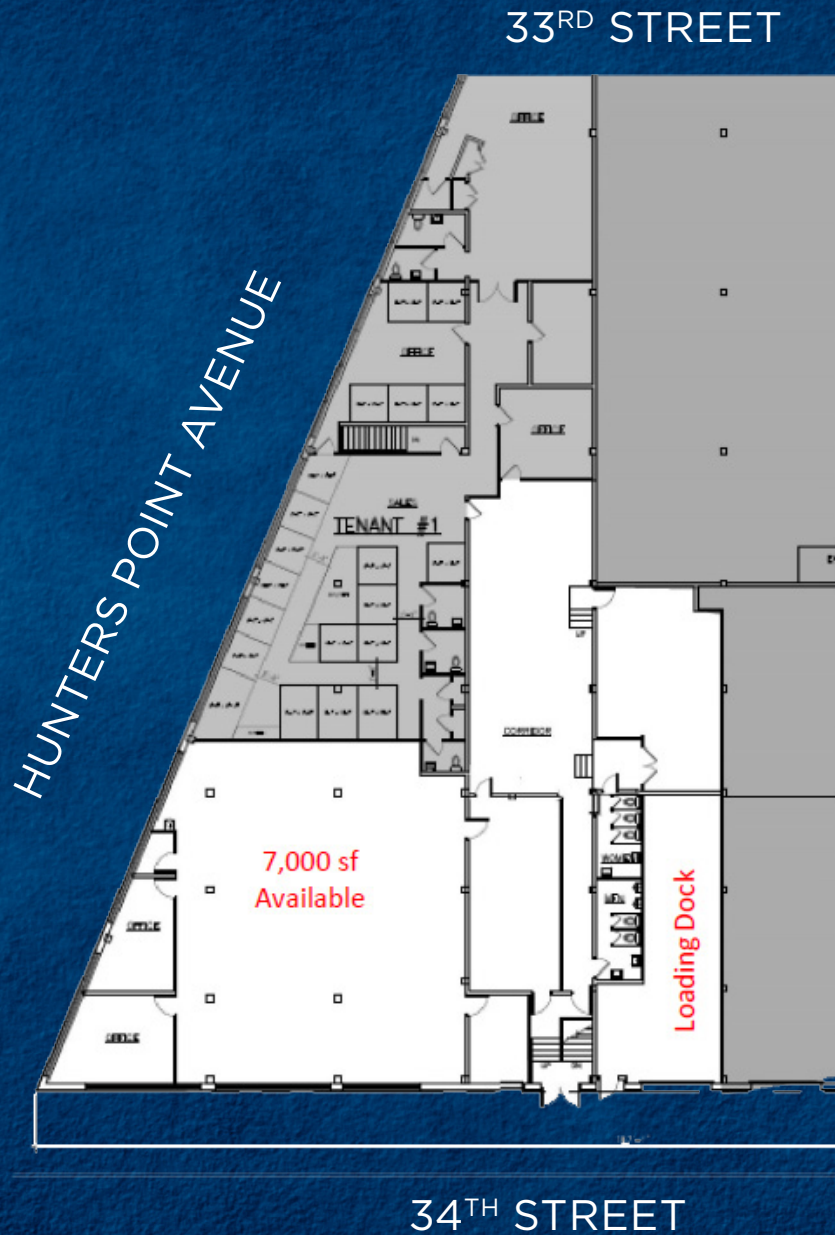

# SPACE FLOOR PLAN - 7,000 SF

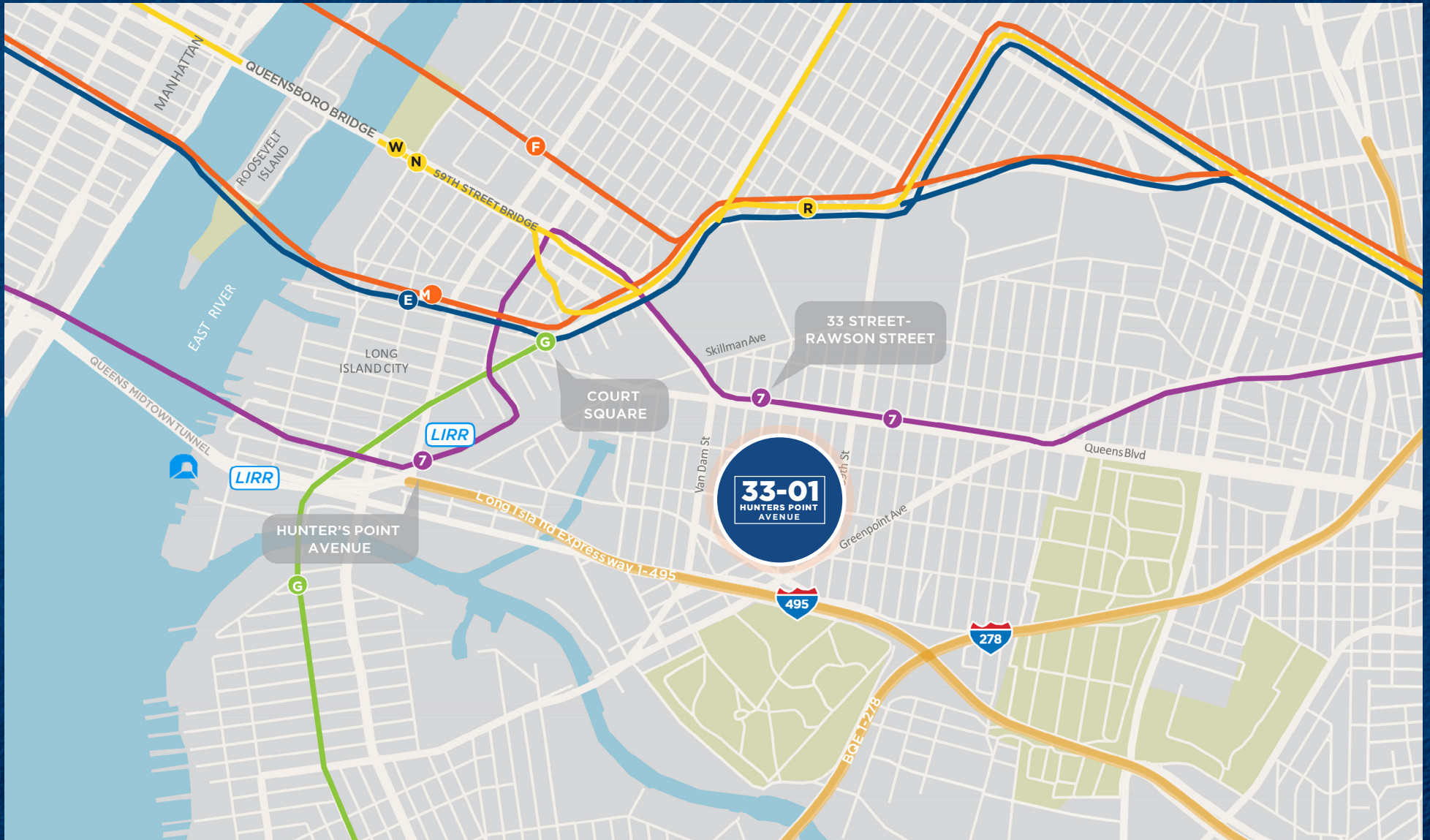
