The building offers good quality storage/manufacturing space supported by 3 docks, an overhead door, and an office area. There is also a fenced-in, gravel yard for outdoor storage that could accommodate 30+ trailers. A boat slip is located to the rear of the property which could potentially be reappraised for recreational use.

The site was contaminated, but has been remediated and owner has a DNR closure letter dated 2000. Neighboring businesses include Georgia Pacific Paper Mill, RGL Storage, and Drop Forge.

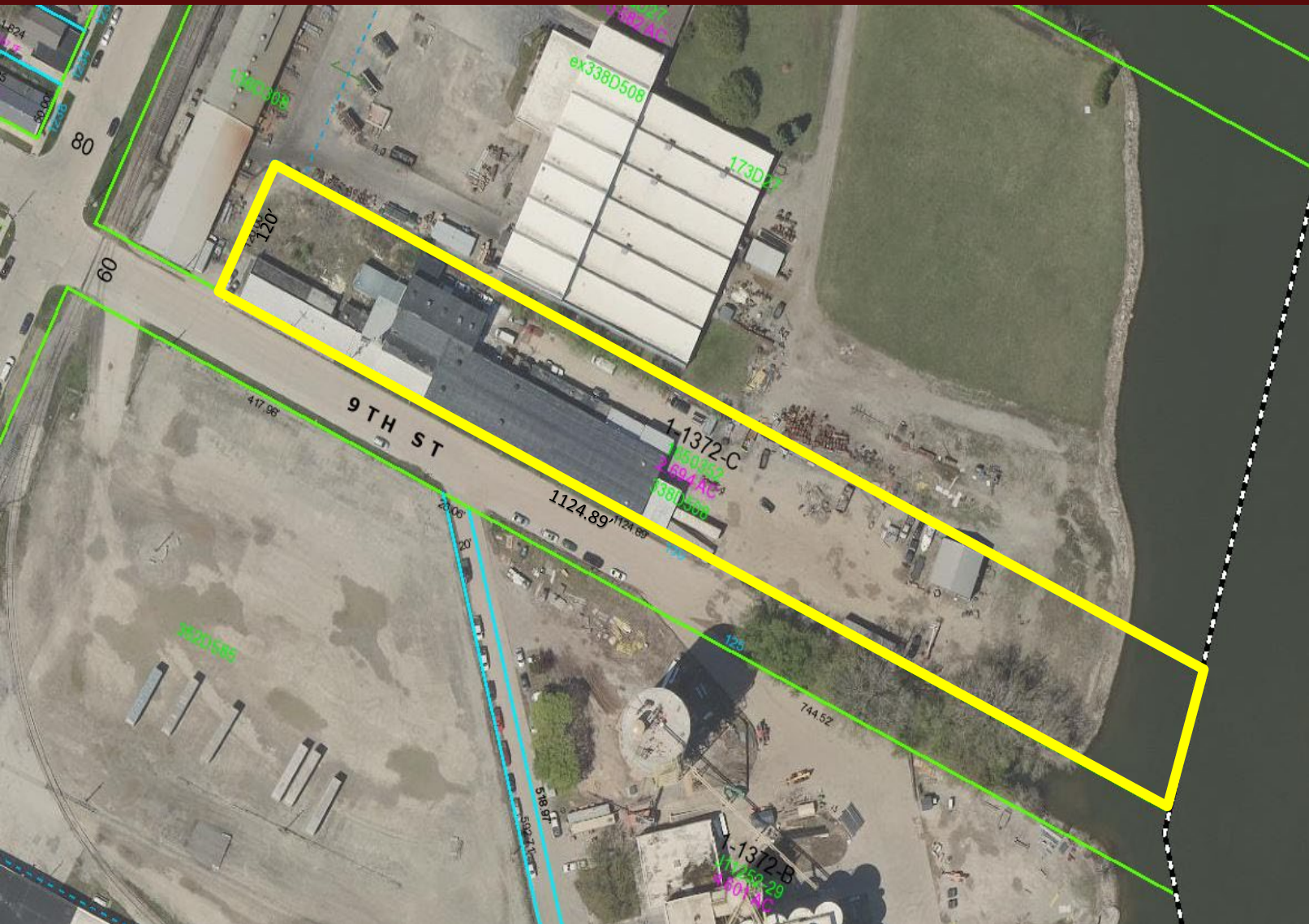

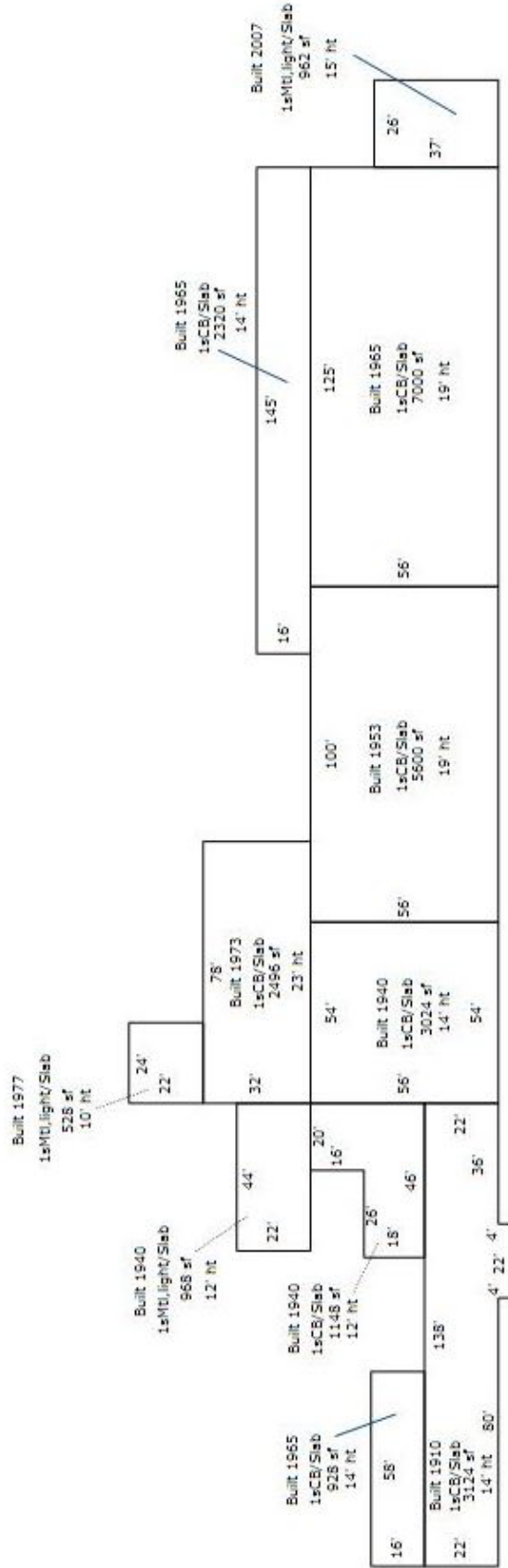

- 17 (g) The duty, when negotiating, to present contract proposals in an objective and unbiased manner and disclose the
18 advantages and disadvantages of the proposals.
