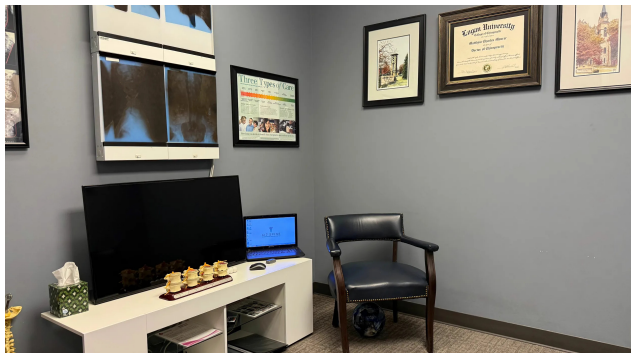

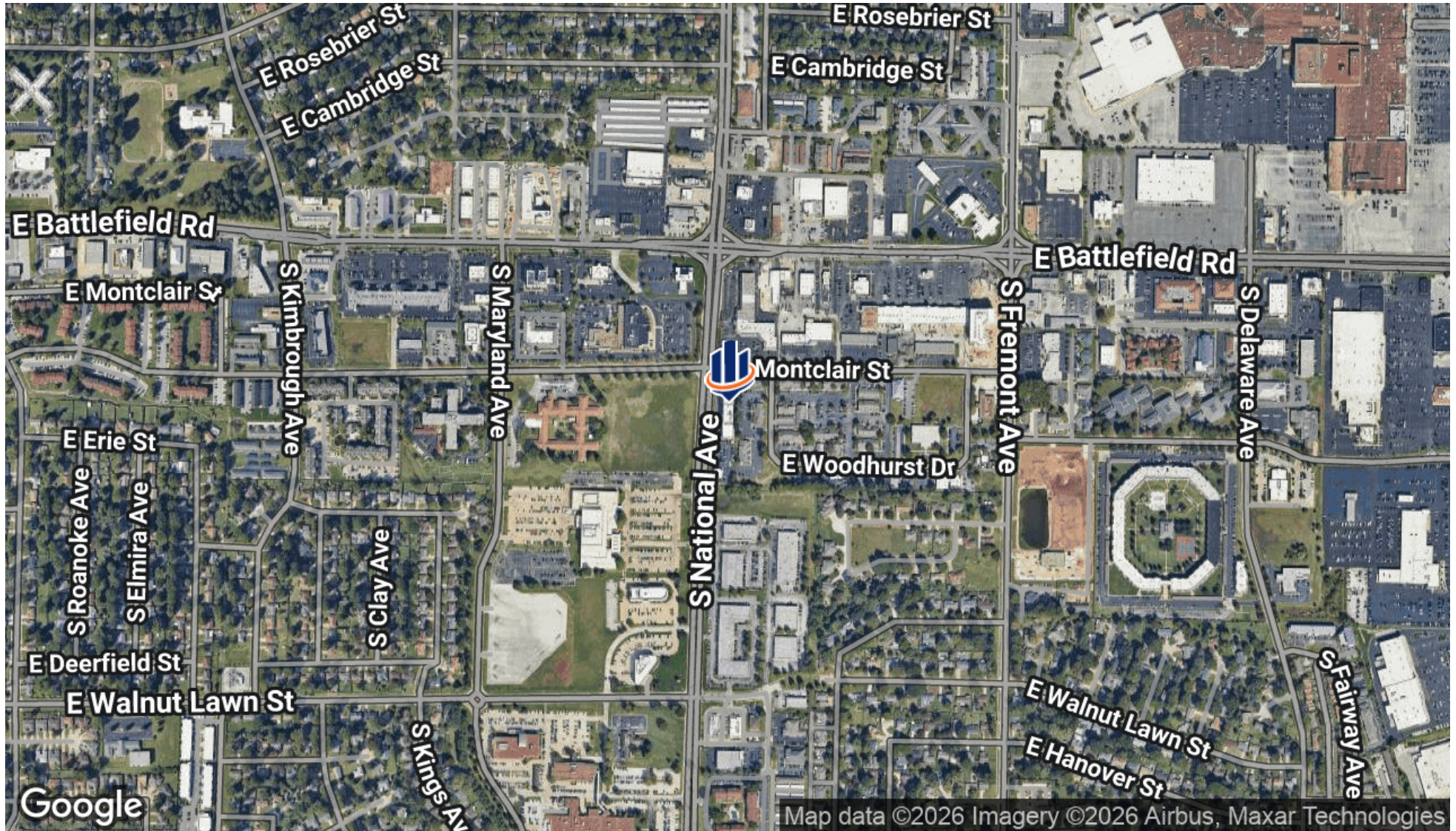
Floor Plan

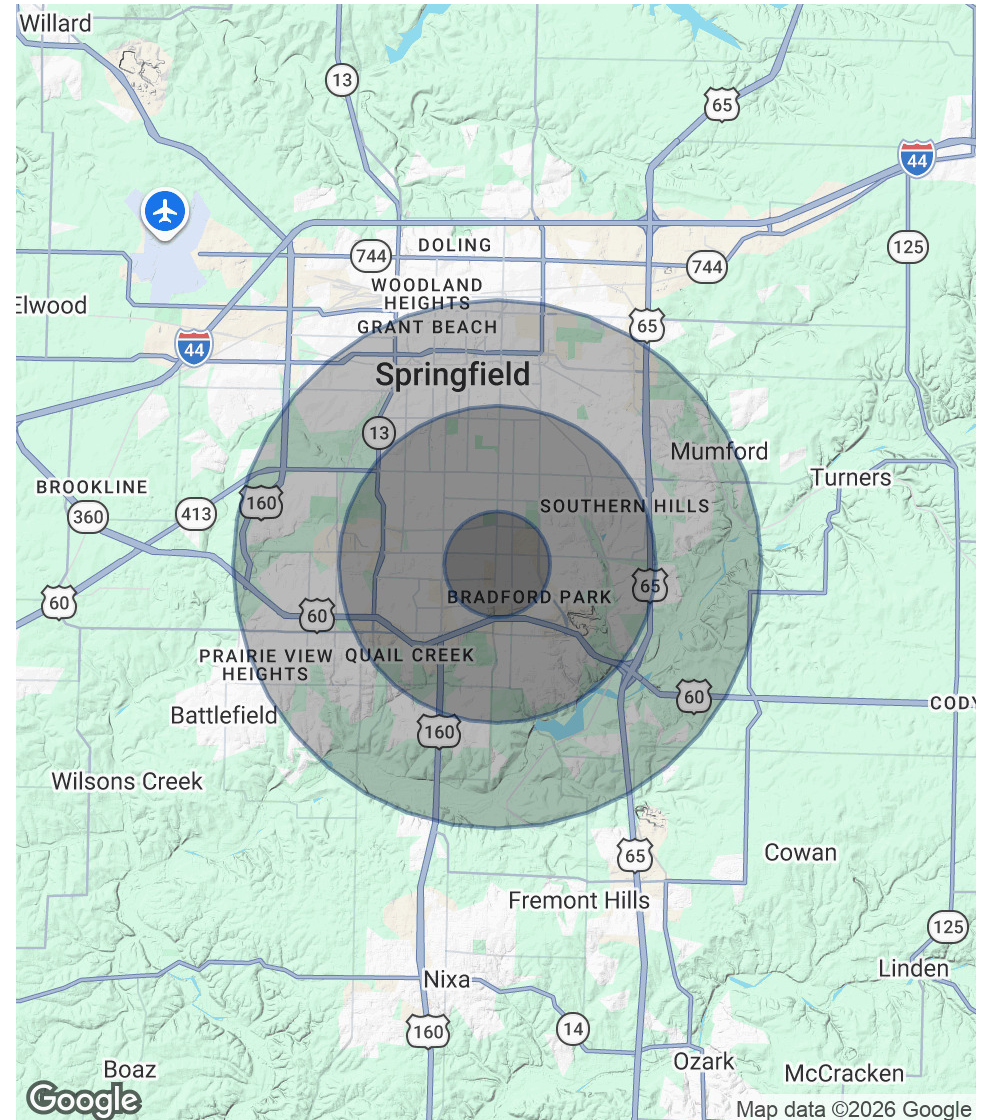
