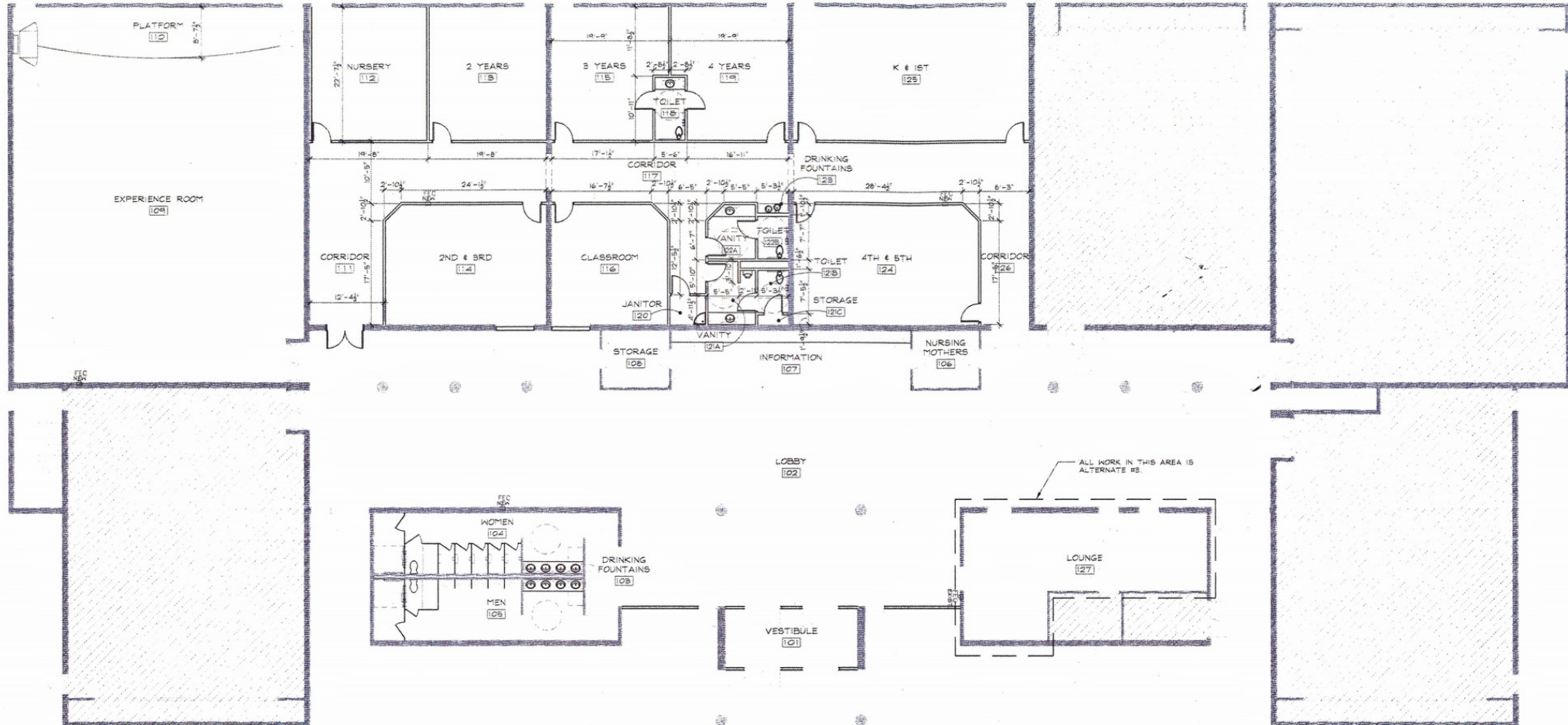

FLOOR PLAN | +/- 27,884 SF SPECIAL PURPOSE PROPERTY FOR SALE

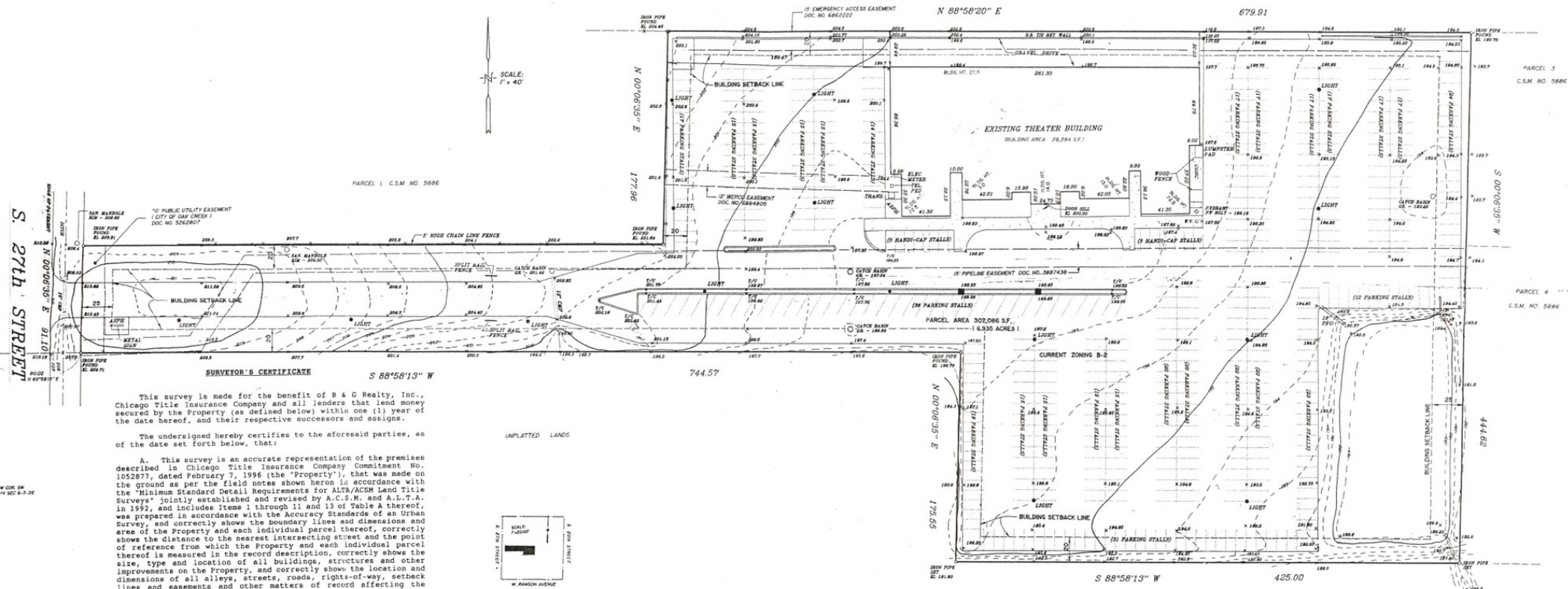

SITE PLAN | +/- 27,884 SF SPECIAL PURPOSE PROPERTY FOR SALE



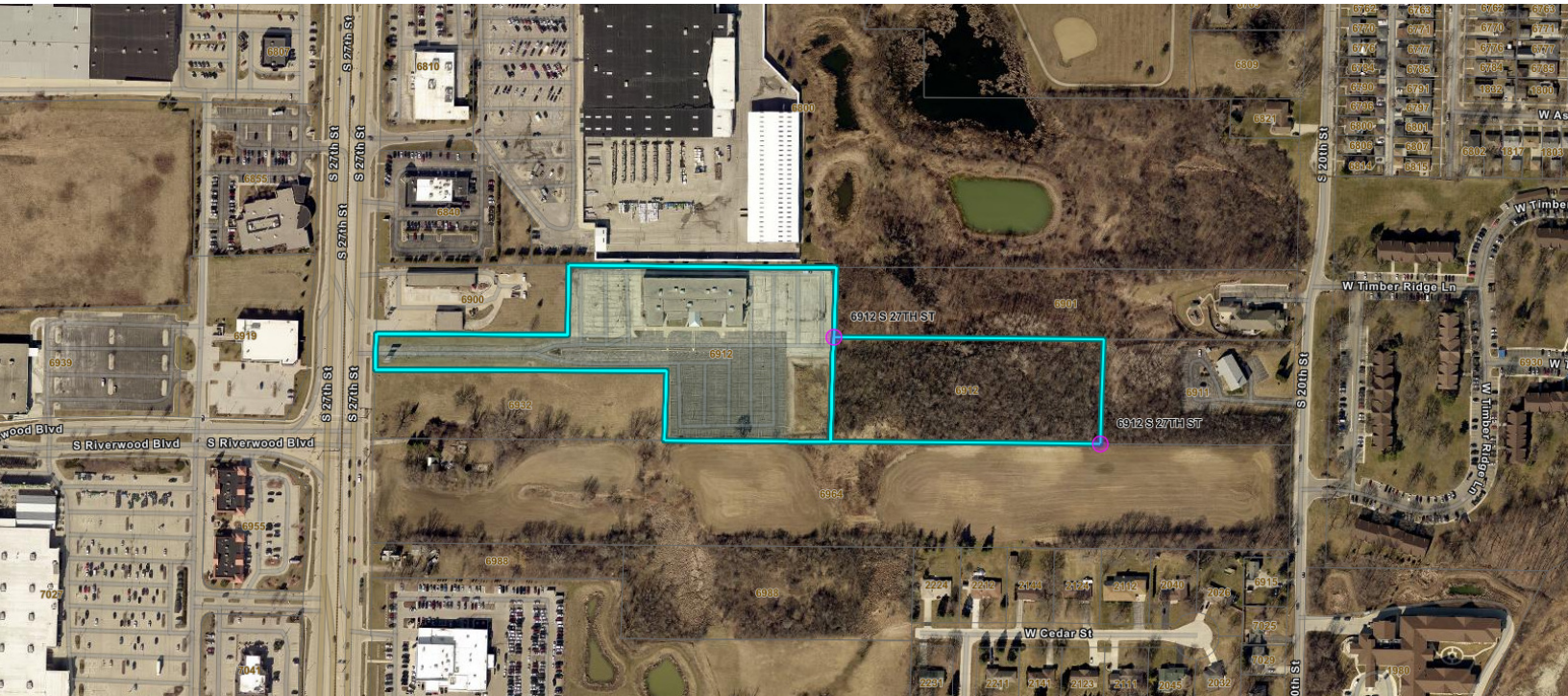

LOCATION MAP | +/- 27,884 SF SPECIAL PURPOSE PROPERTY FOR SALE

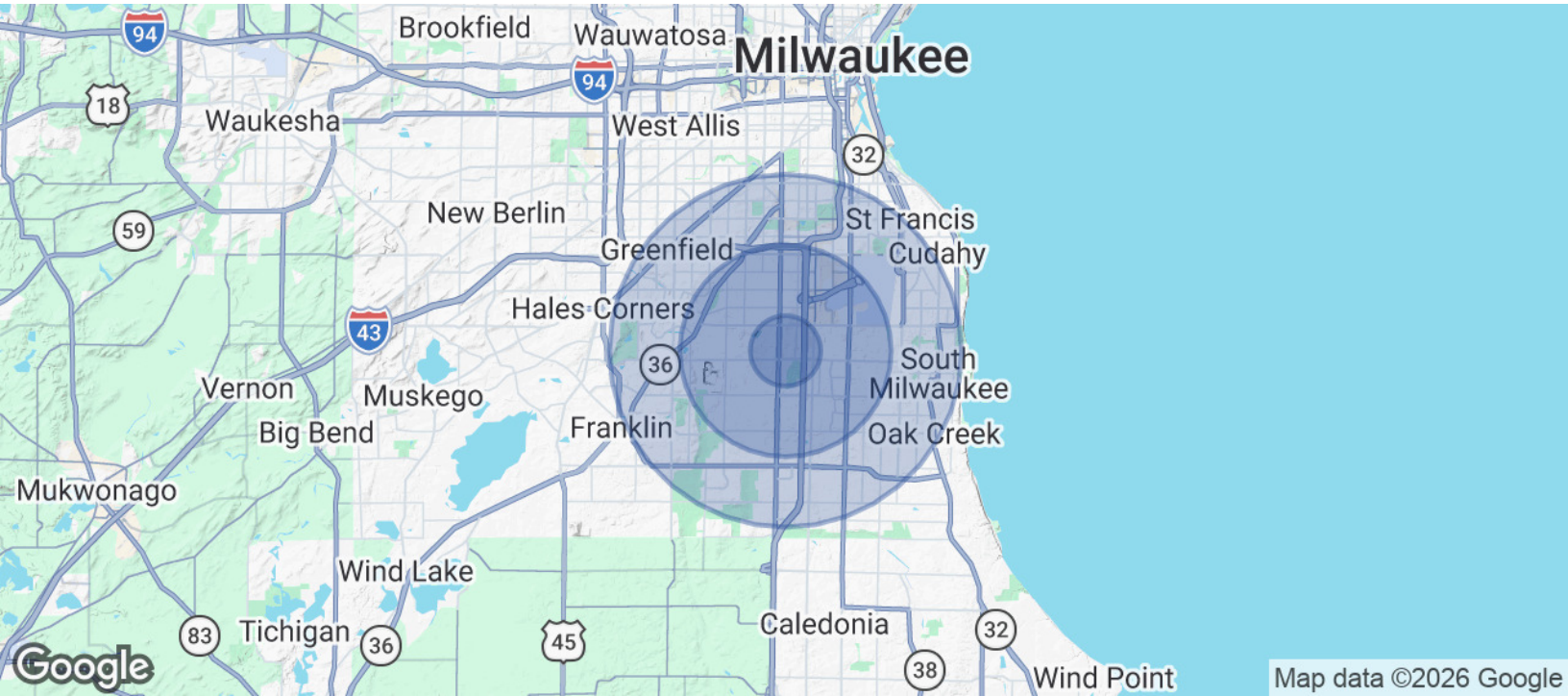
