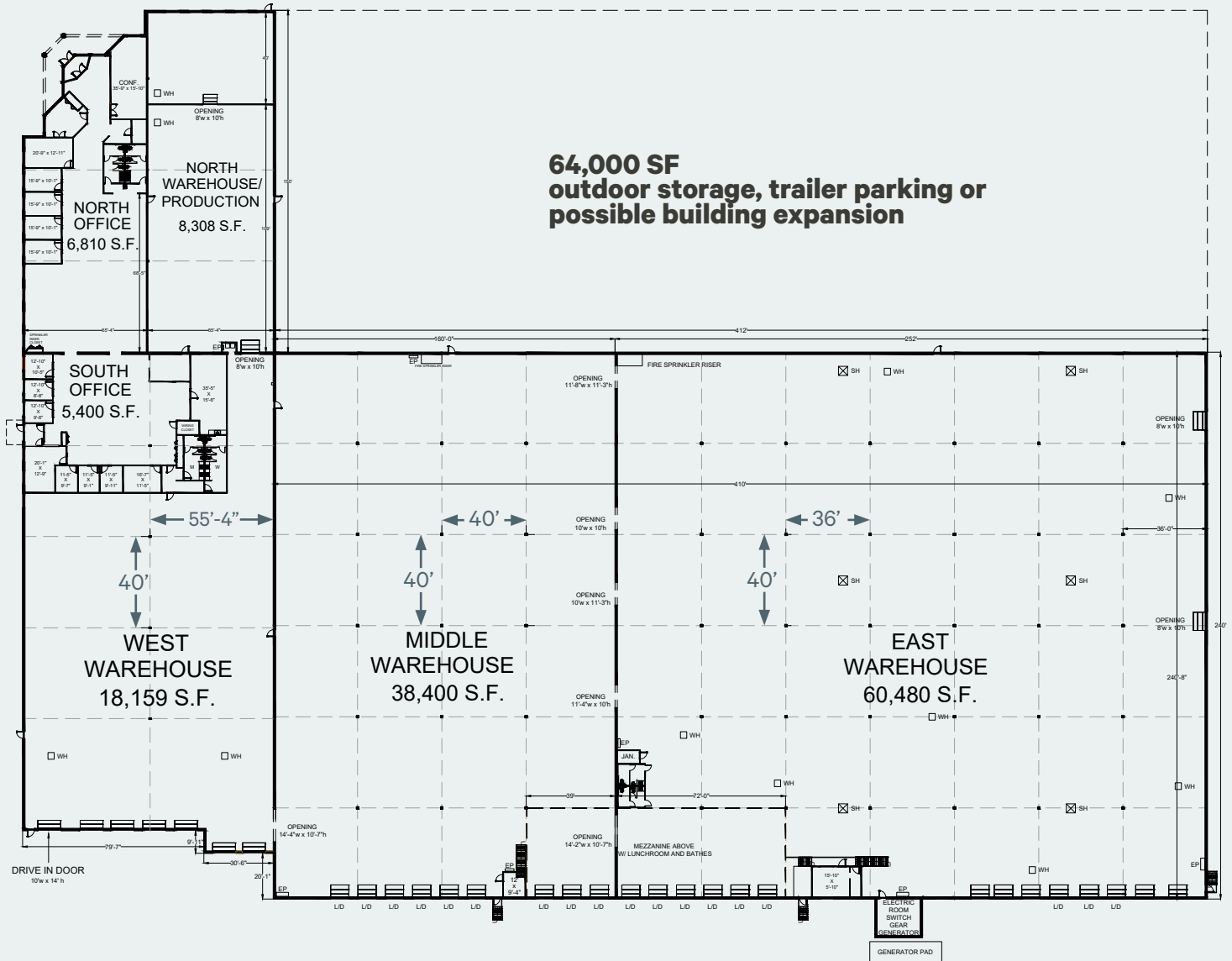

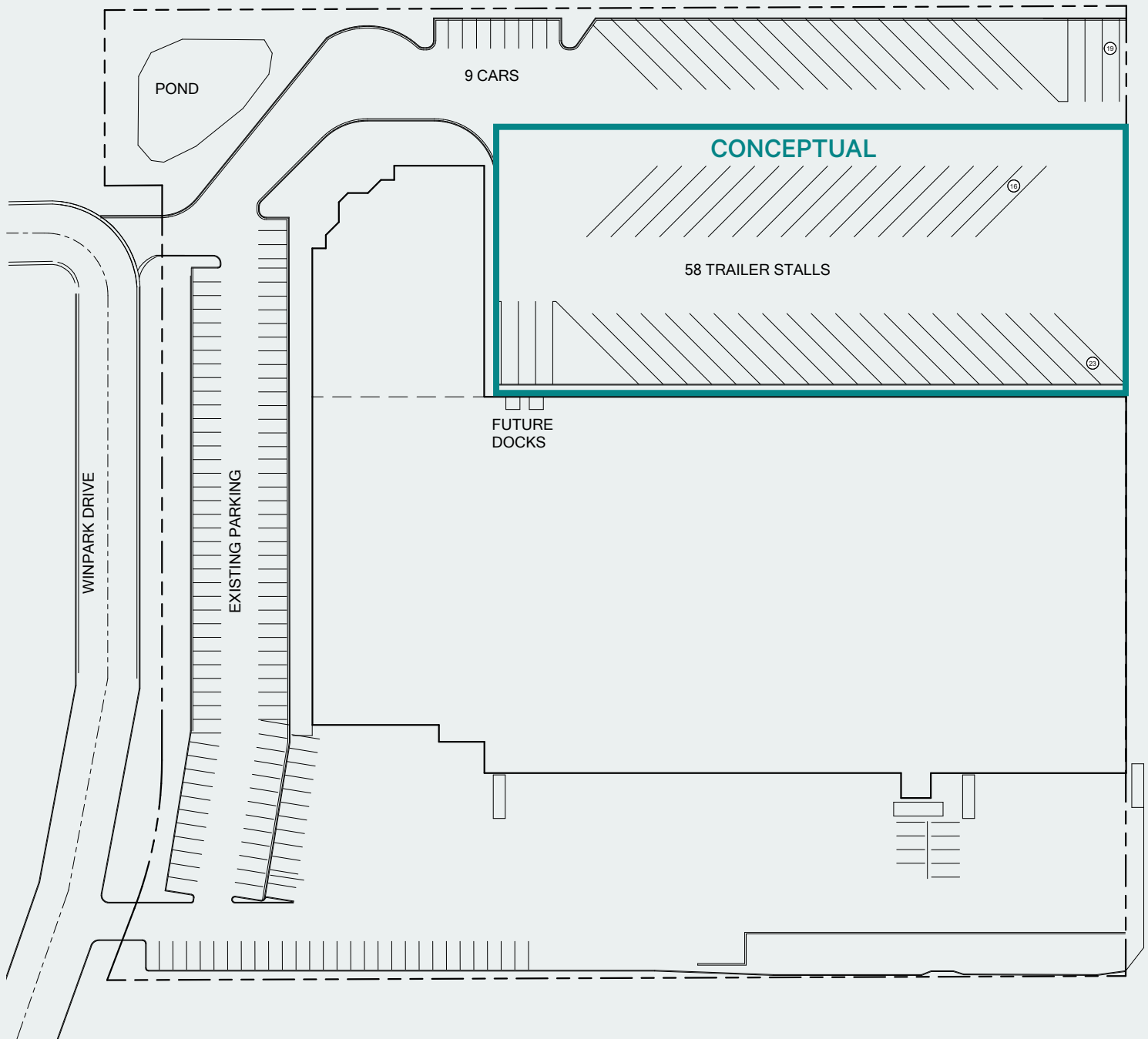
FLOOR PLAN
