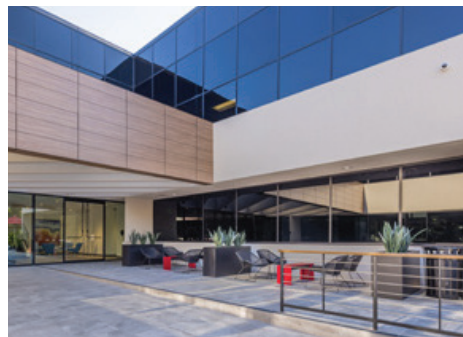

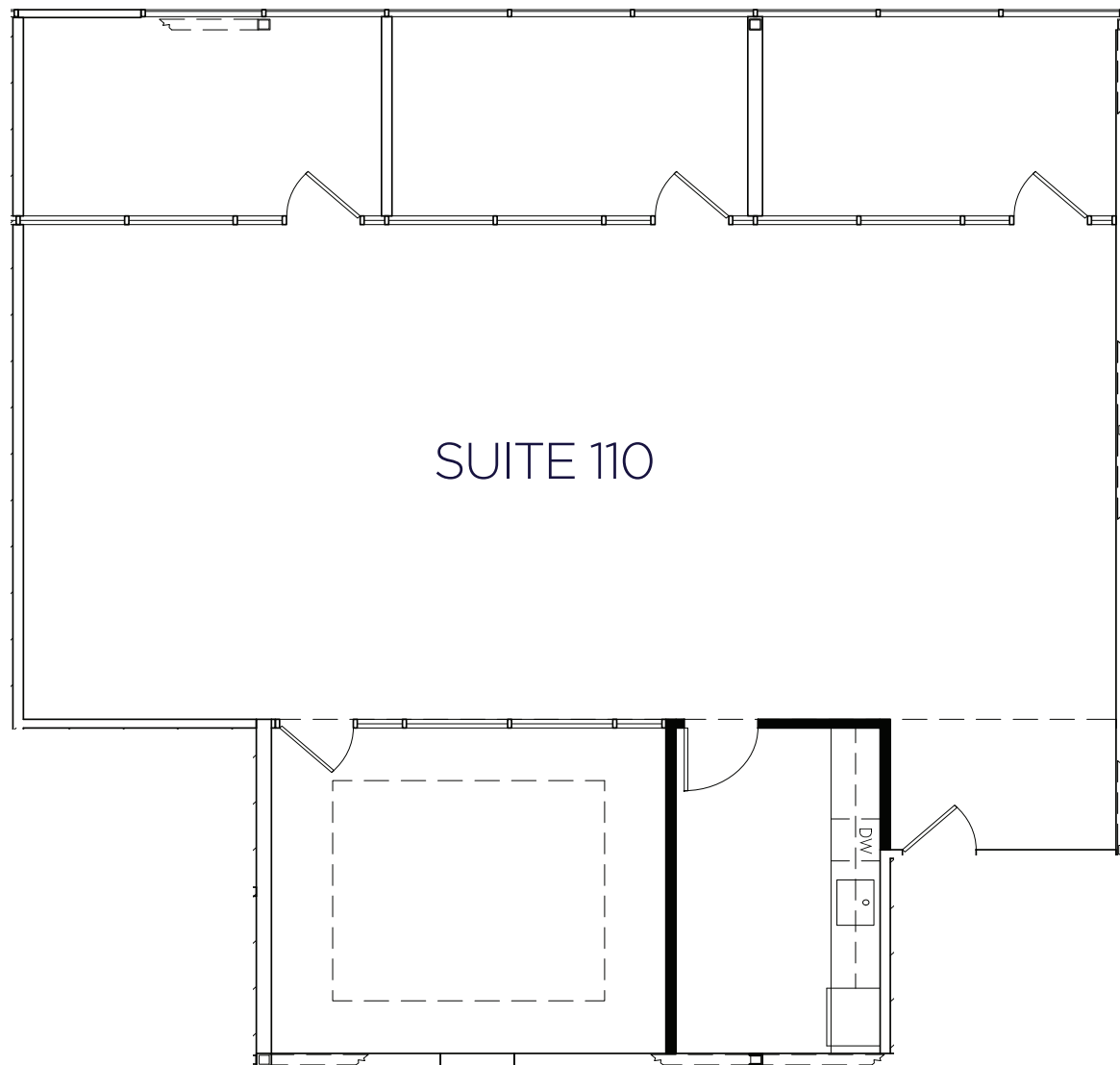
FLOOR PLAN

FIRST FLOOR

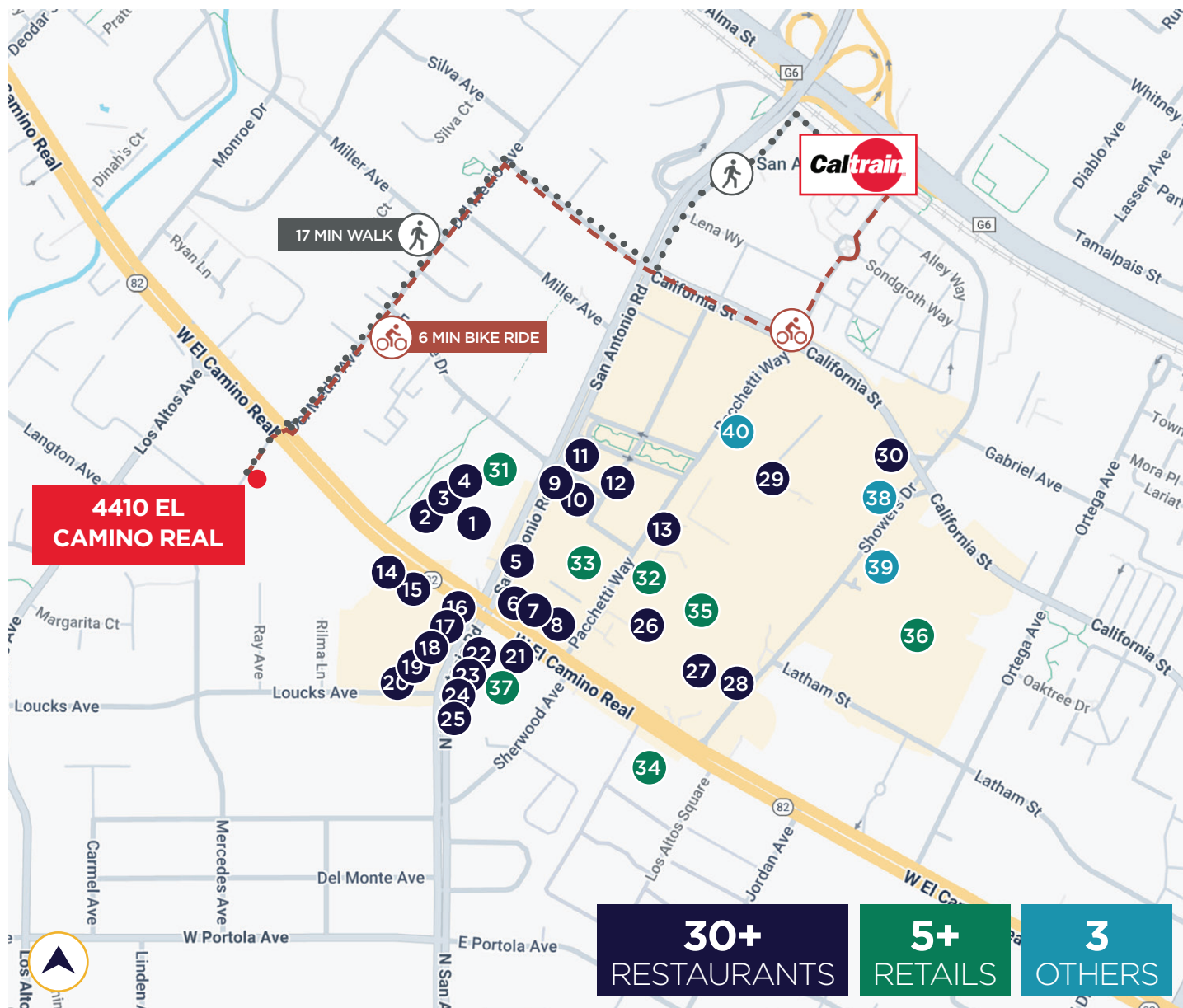

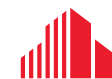
