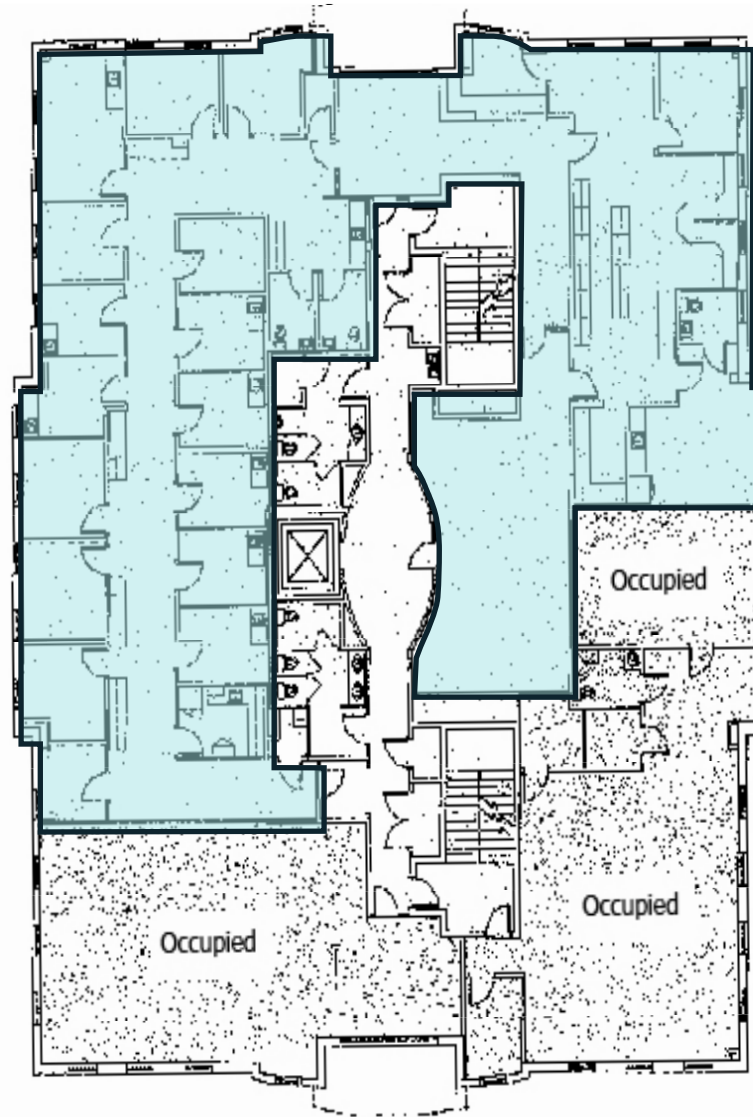

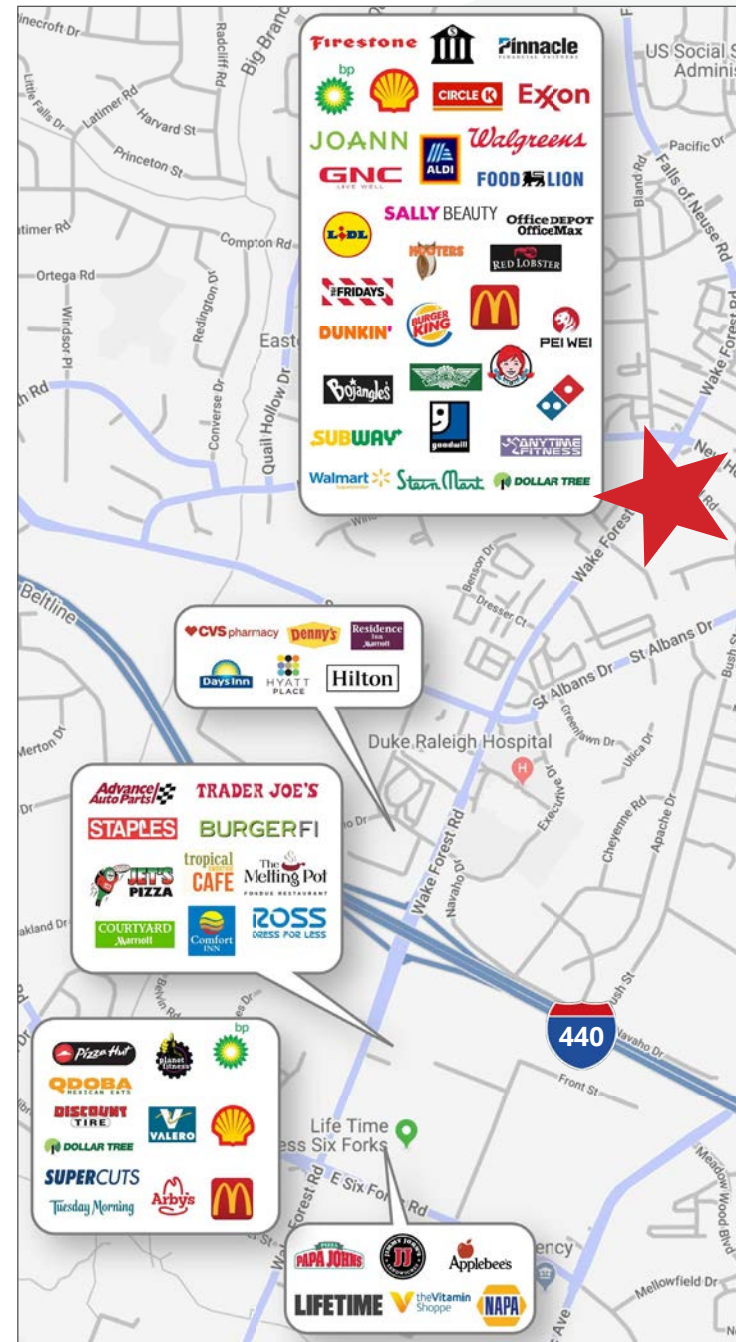
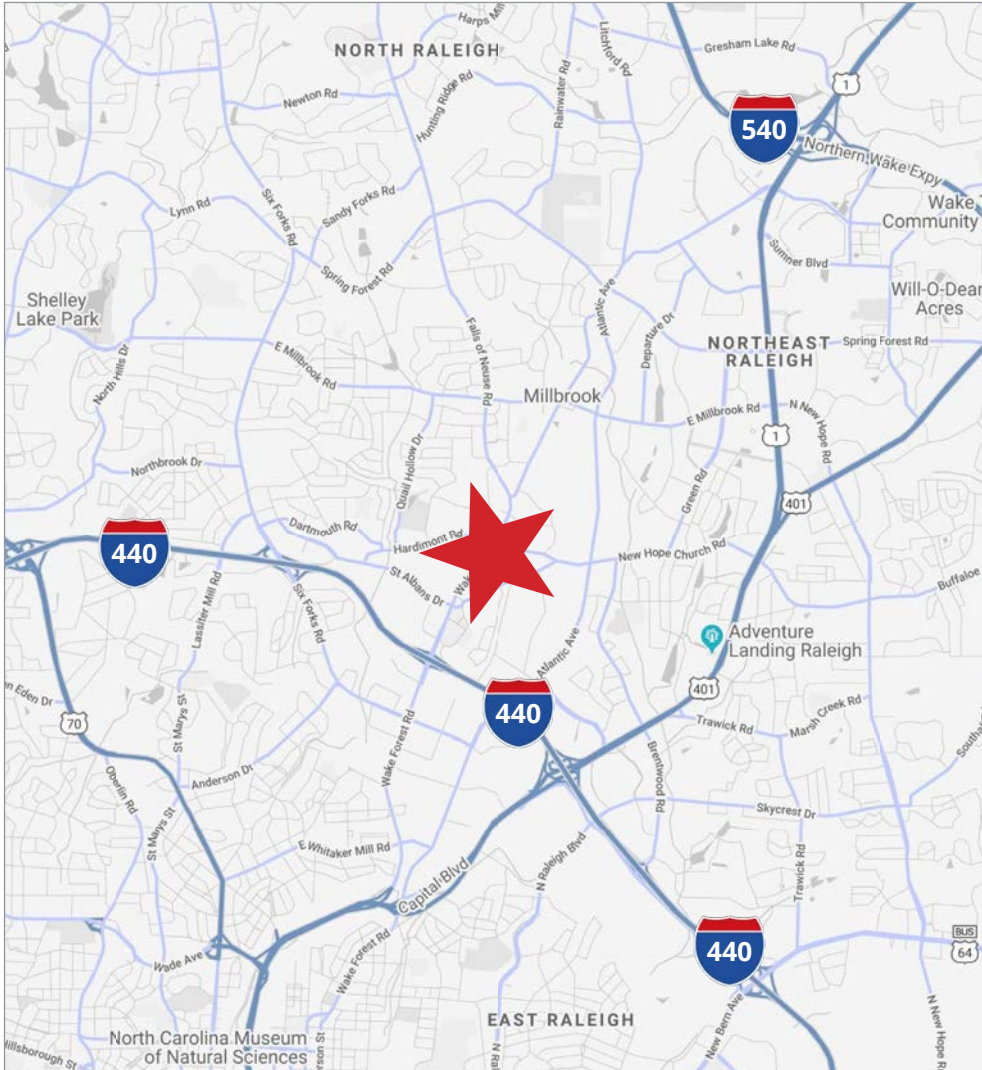

FLOOR PLAN



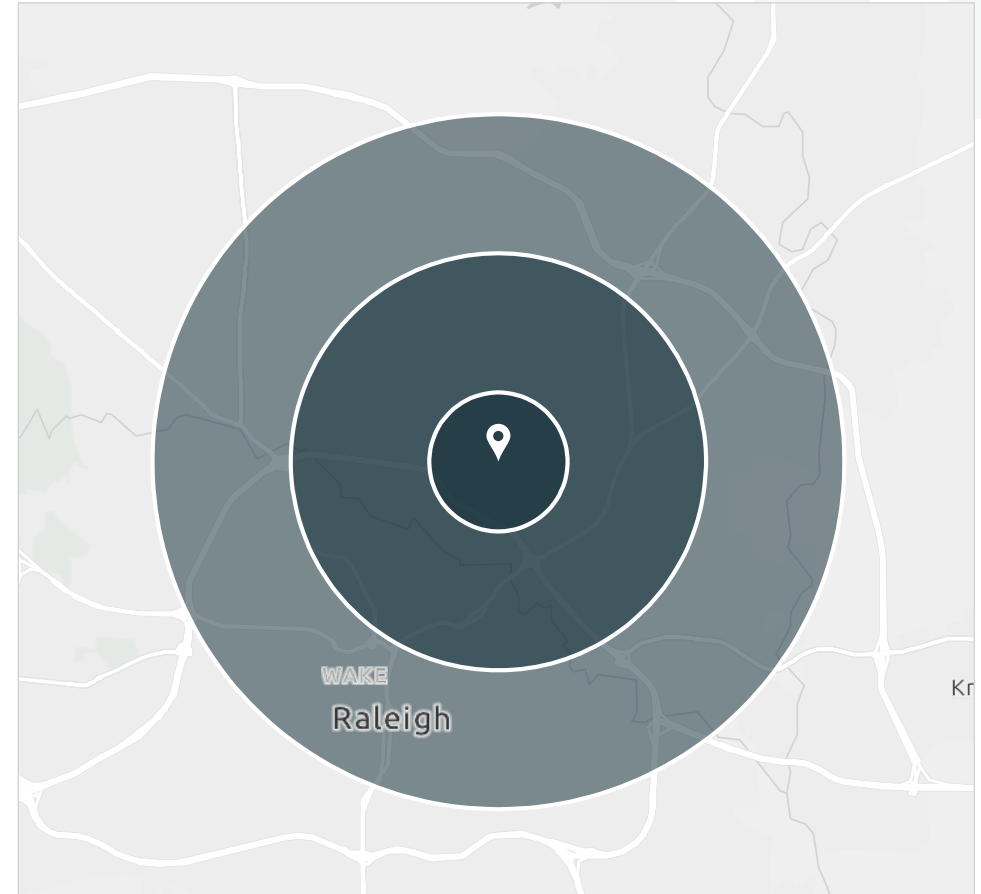
