INFORMATION ABOUT BROKERAGE SERVICES



Texas law requires all real estate license holders to give the following information about brokerage services to prospective buyers, tenants, sellers and landlords.

TYPES OF BLAL INTATE LICENSE HOLDERS

- A MOUNT is responsible for all brokerage actives, including acts performed by sales agents sponsored by the broker.
- A BALIN ARRIT must be oponeously a broker and works with clients on behalf of the broker.

- Put the interests of the client above all others, including the broken's own interests;
