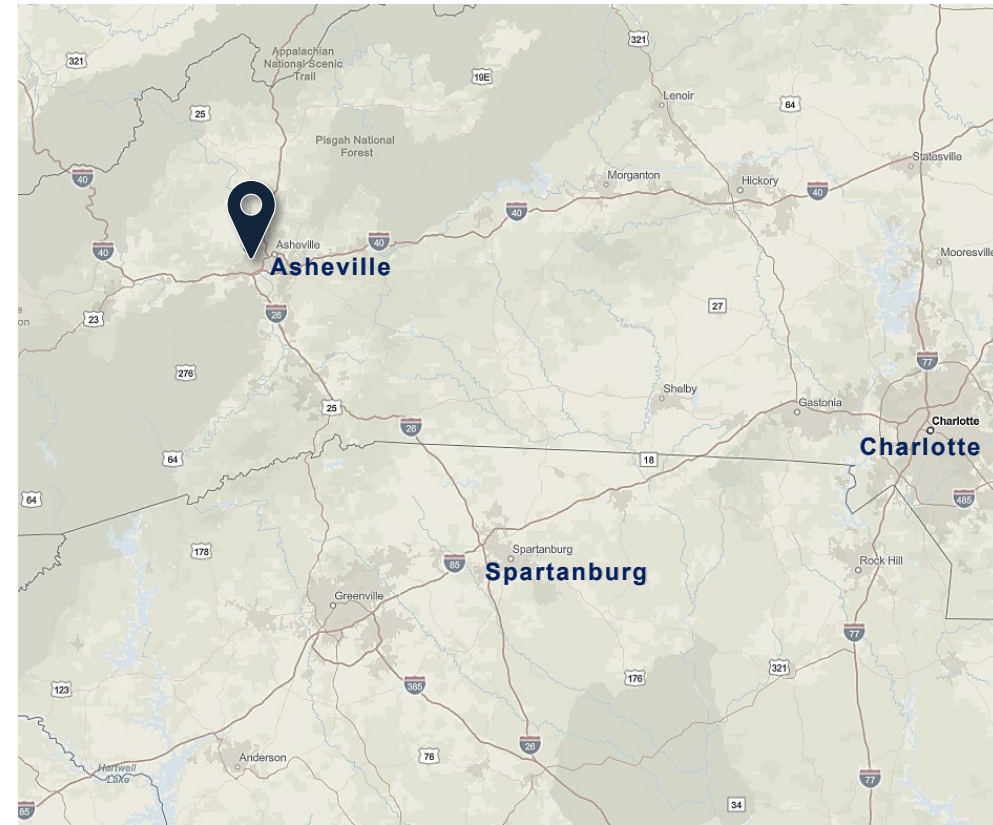

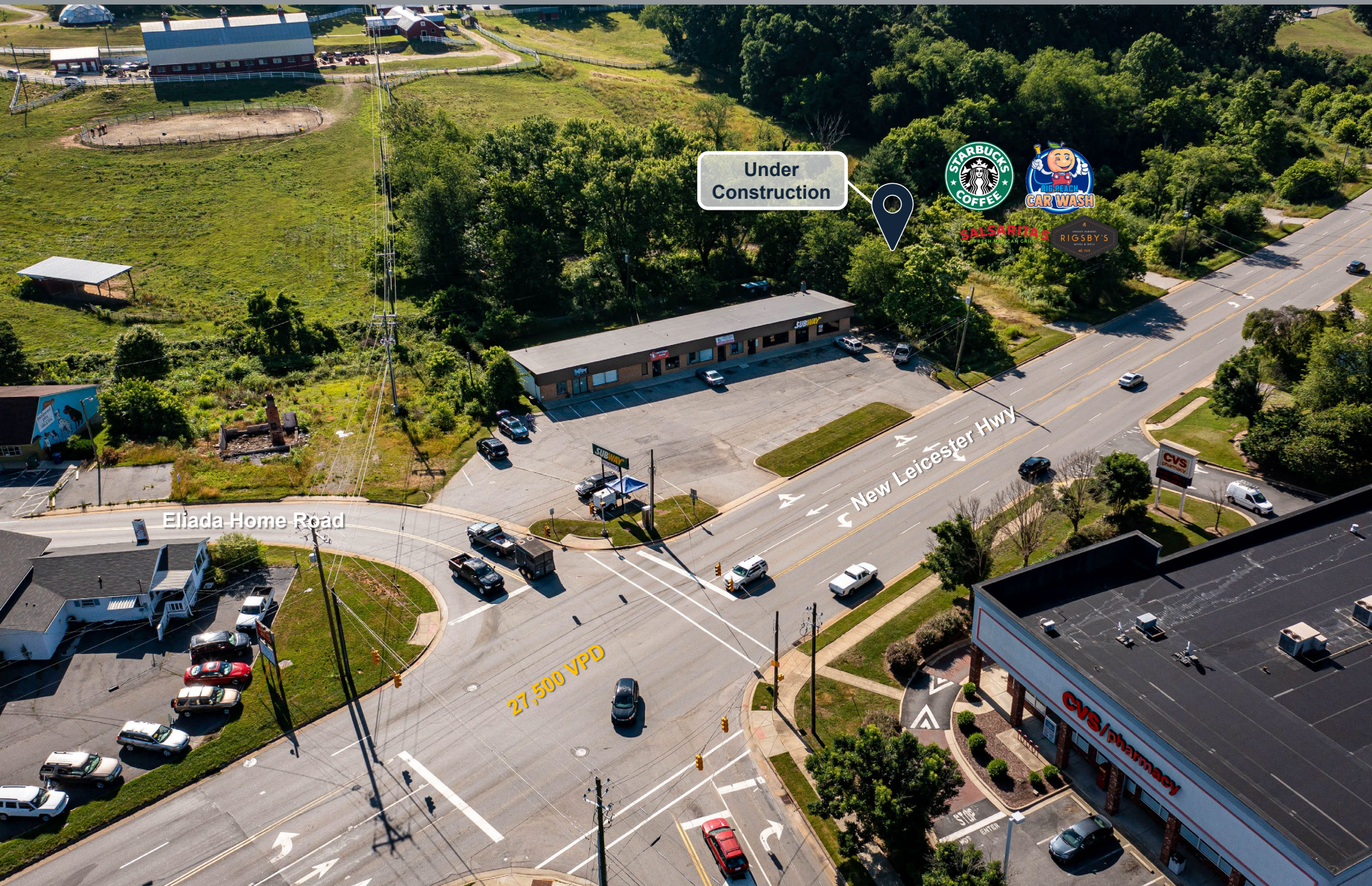

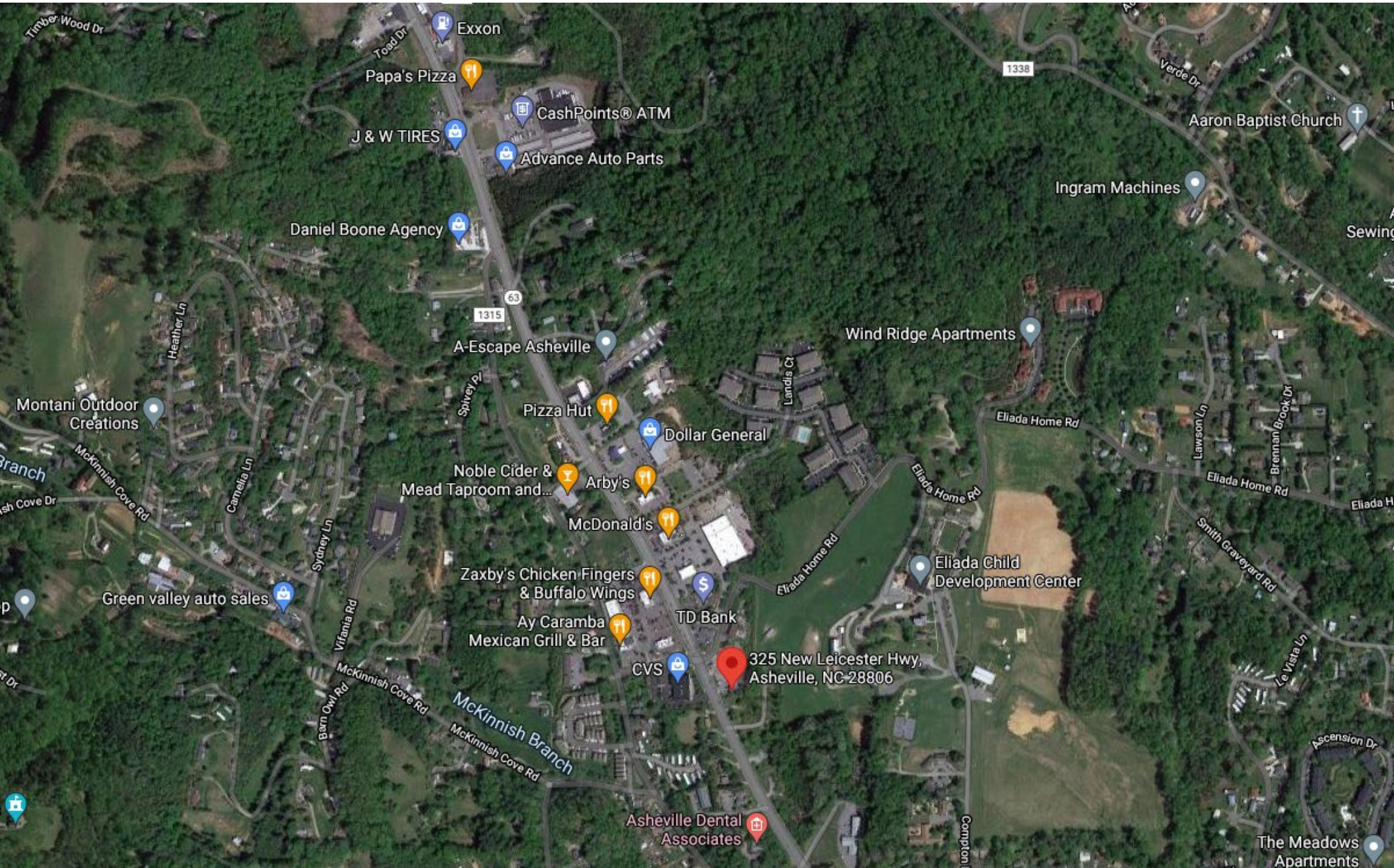

Currently, 49.8% of the 42,808 housing units in the area are owner occupied; 39.0%, renter occupied; and 11.1% are vacant. Currently, in the U.S., 57.3% of the housing units in the area are owner occupied; 31.2% are renter occupied; and 11.5% are vacant. In 2010, there were 37,265 housing units in the area - 51.4% owner occupied, 38.2% renter occupied, and 10.4% vacant. The annual rate of change in housing units since 2010 is 6.36%. Median home value in the area is \$273,758, compared to a median home value of \$264,021 for the U.S. In five years, median value is projected to change by 2.62% annually to \$311,485.
