


Seller is in the process of obtaining Zoning Board of Adjustment (ZBA) variance approvals supporting 16-unit townhome development, to be delivered prior to closing. Buyer to pursue all remaining Planning Board approvals, site plan review, and permits. The buyer shall provide their own building plans to the PBA (e.g., the builder is not tied into a product or construction style they don't like). The buyer may elect to phase the development as preferred for greater flexibility. The optionee is taking all offers and will consider owner financing, a joint venture, and/or selling its option prior to obtaining approvals at discount. 

PROPOSED SITE PLAN, FLOORPLAN & RENDERING










