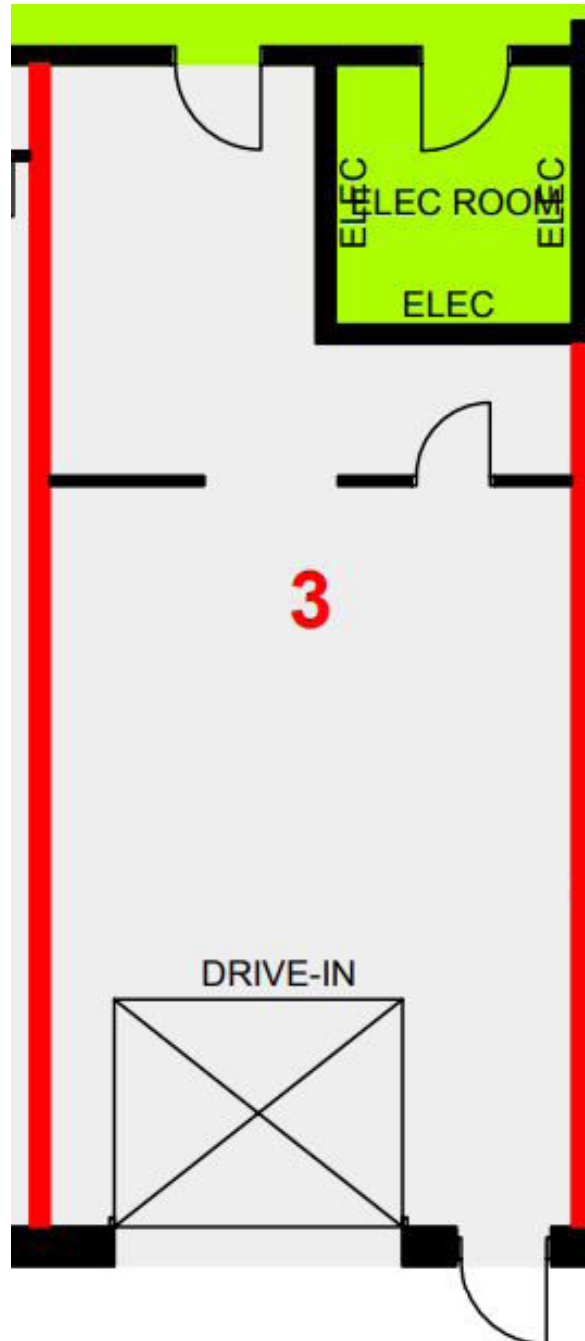

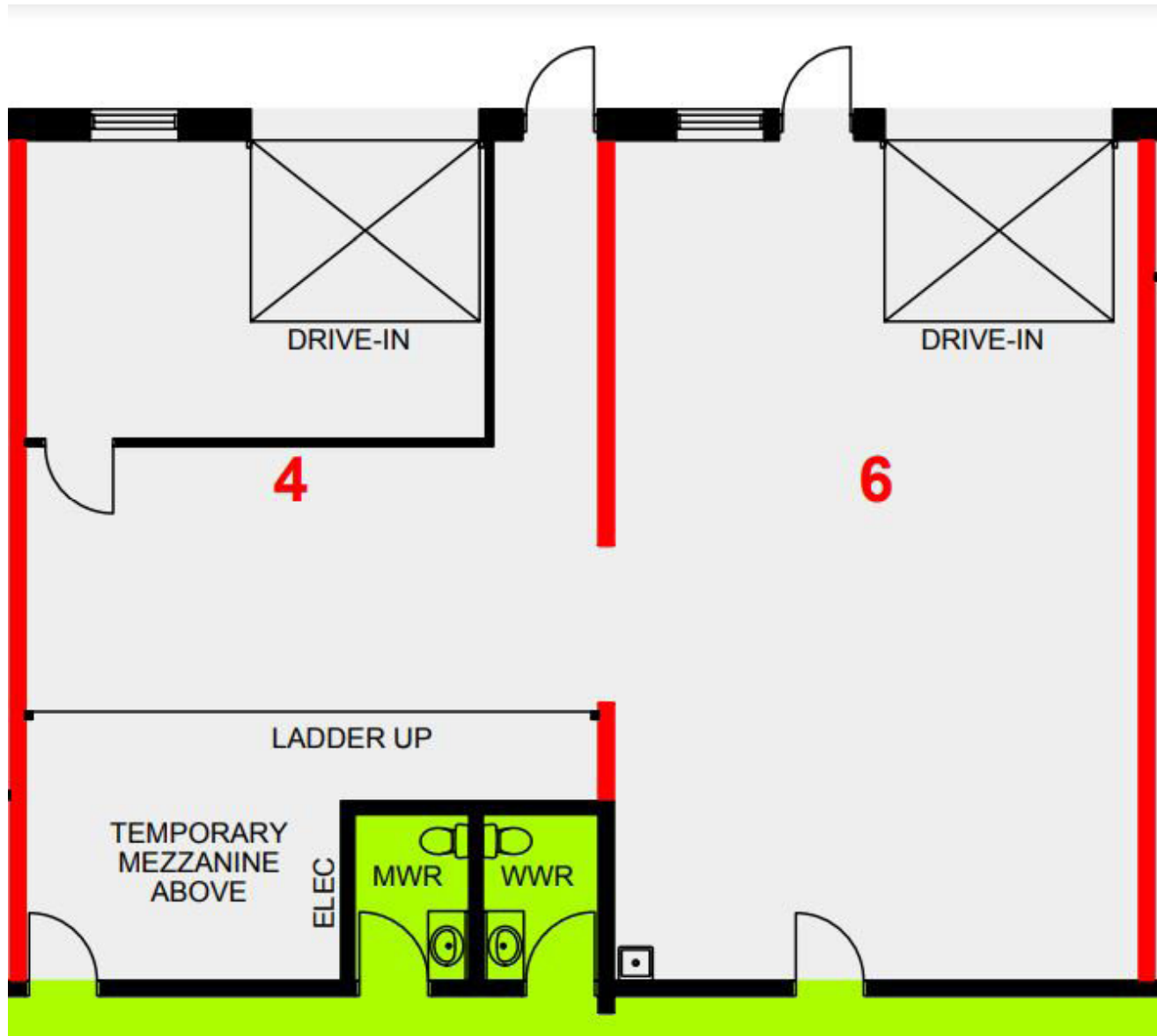

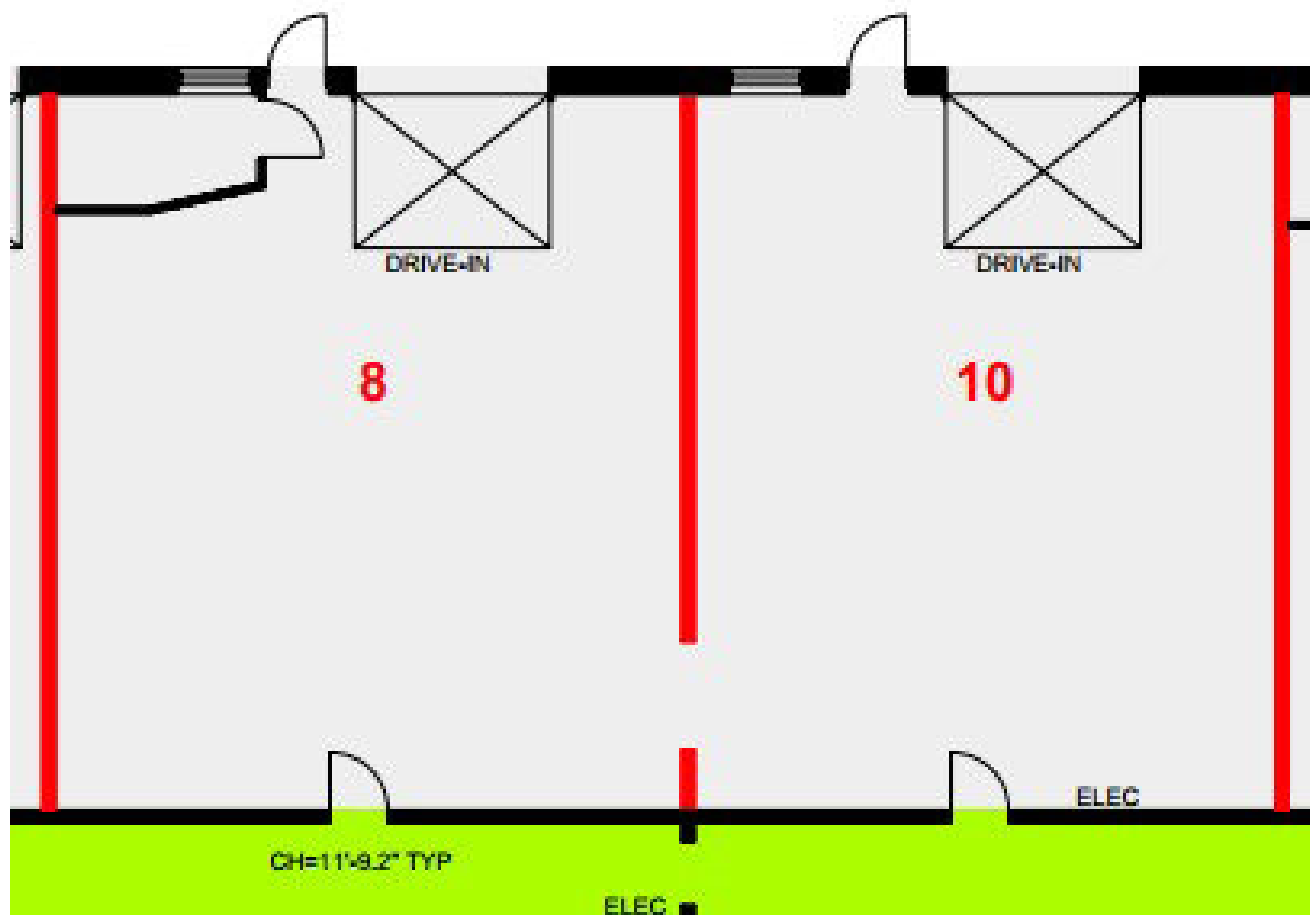
Unit 4 & 6

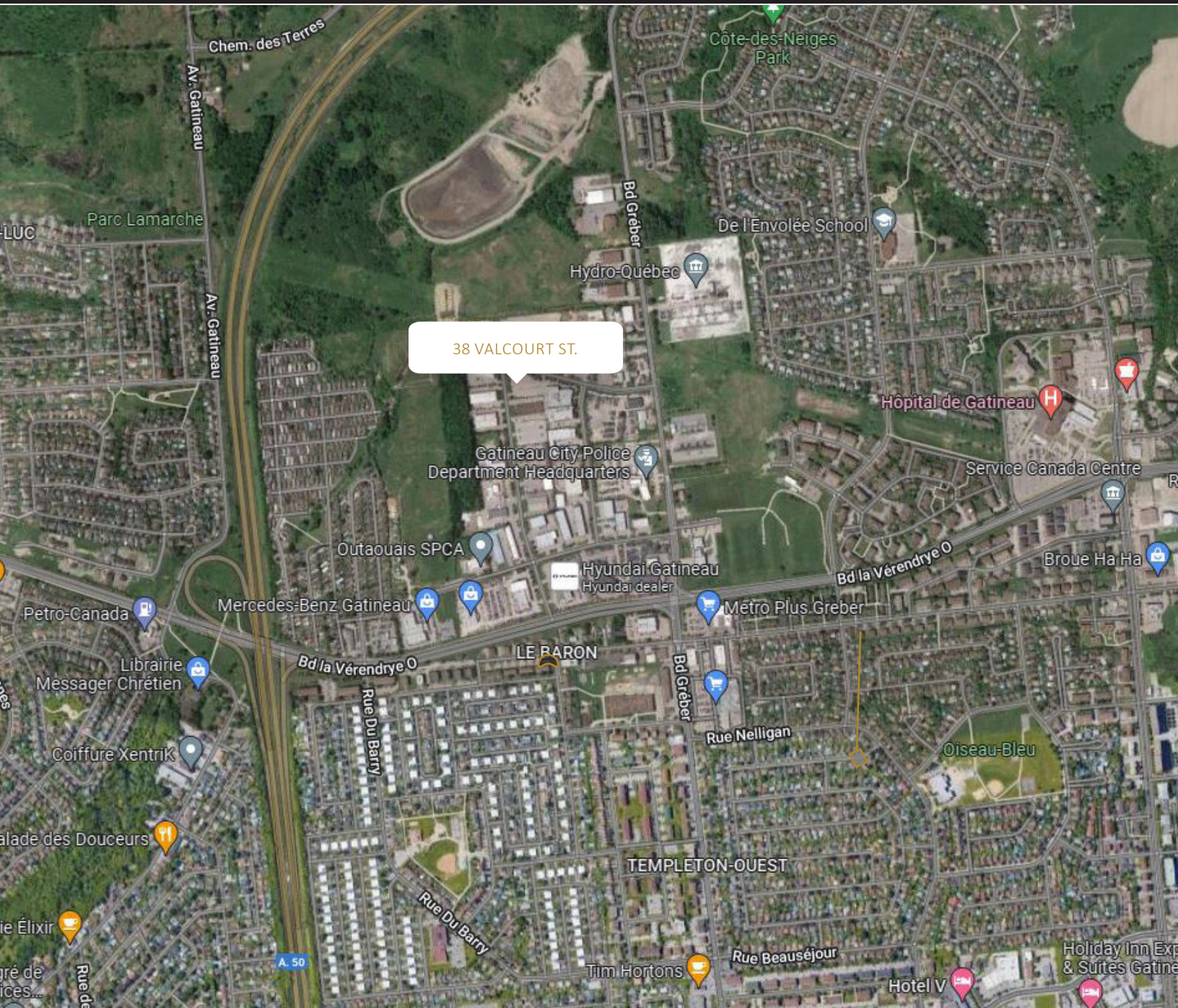
