

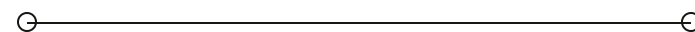

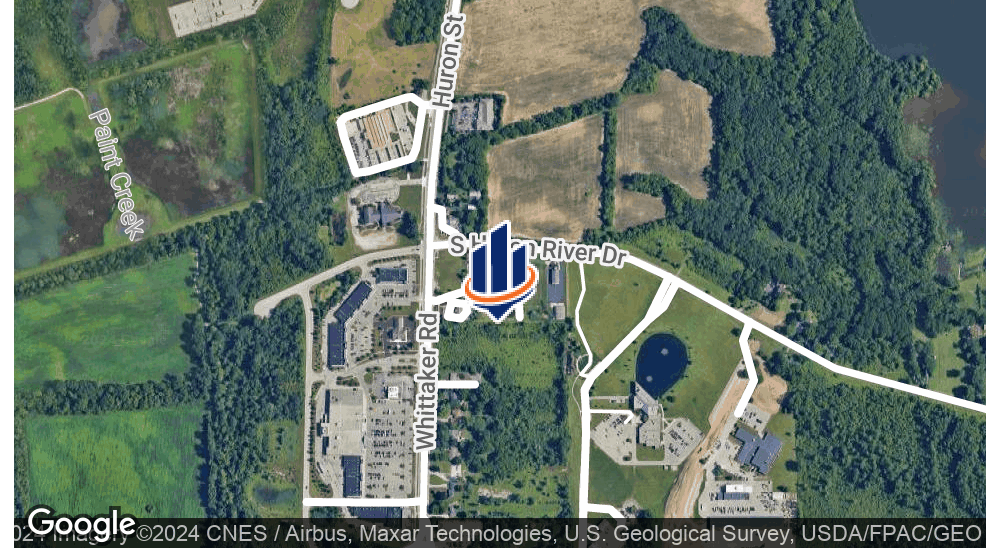
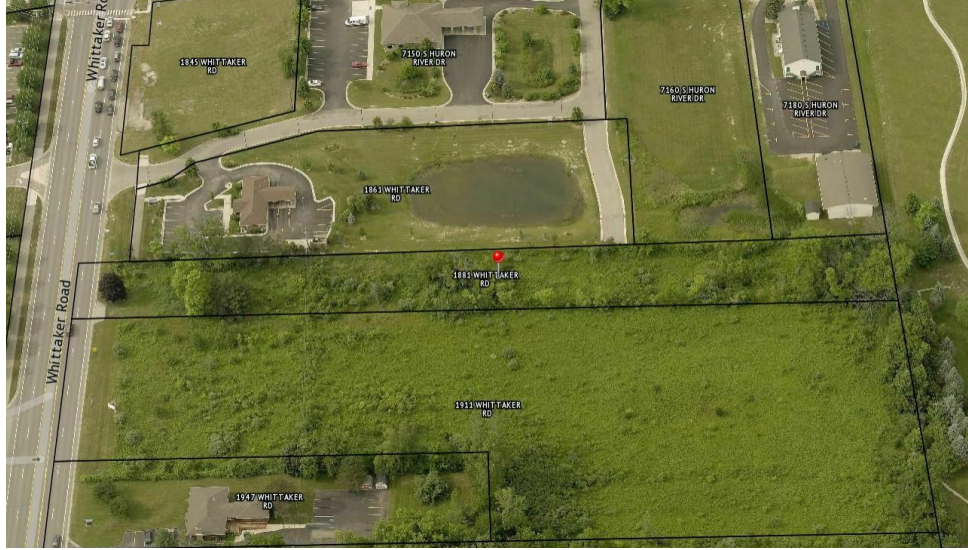

PROPERTY OVERVIEW

SVN Stewart Commercial Group is pleased to present this 1.33 acre development opportunity located at 1881 Whittaker Rd in the heart of Ypsilanti Township. The township master plan allows for a wide variety of uses. Township Core zoning allows for multi-family, mixed use, childcare, office, vet clinics, medical office/clinics, and a wide range of retail uses. This site is located directly across from Paint Creek Crossing, a thriving community hub consisting of major retailers such as Kroger and Starbucks along with other retailers, financial institutions, and popular restaurants. The Whittaker Rd. corridor sees approximately 18,550 vehicles per day. The adjacent 4.68 acre vacant lot located at 1911 Whittaker Rd. is available for separate purchase.

Ypsilanti Township is situated to the southeast of the city of Ann Arbor and is part of the larger Ann Arbor metropolitan area. It is known for its proximity to the University of Michigan and Eastern Michigan University. The township is accessible via major roadways like I-94, making it just 15 minutes to Ann Arbor and a 20-minute drive to DTW.

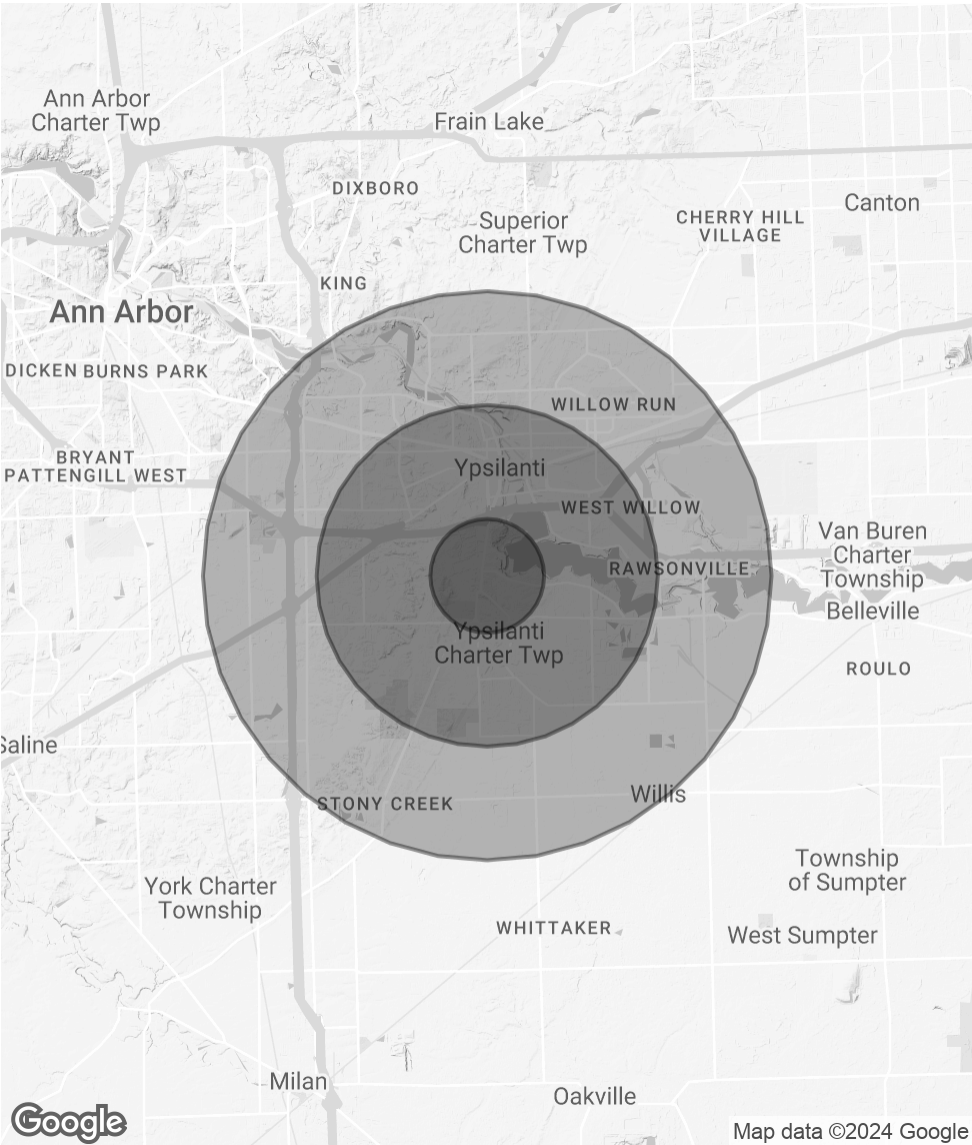
