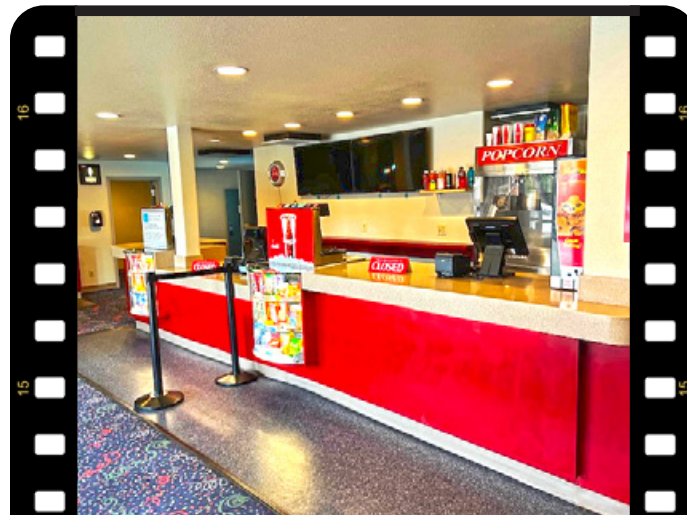

- **This historic building** was completely renovated in the late 1800's and early 1900's and has been a longtime staple in the area - [Read about the buildings history here](#)
- **Originally designed as a single screen theater**, the current owner of the Granada added a second screen in 1972, followed by a third screen in 1994 bringing the total capacity to 323 seats - *Auditorium 1 = 103 seats - Auditorium 2 = 45 seats - Auditorium 3 = 175 seats*
- **More recent renovations include** the installation of new rocker seats, state-of-the-art digital Christie projectors, Dolby 3D and 750 surround sound systems, an updated concession bar and lobby area, new carpet, new auditorium drapes, and other improvements
- **The location offers** over 6,798 households and a median age of 38 within a 15 minute drive time of the property, with consumer spending reports showing over \$19,910,248 spent on entertainment which includes movies tickets
- **Surrounding local, regional and national retailers and restaurants include** Bi-Mart, Safeway, KFC, Papa Murphy's, Walmart, Grocery Outlet, Dollar Tree, & Panda Express - [Google Map View](#)
- **Local traffic generators include** Eastern Oregon University (3,000 students), La Grande High School (628 students), Middle School (456 students) and Elementary School, Woodgrain (over 200 employees), and Grande Ronde Hospital (50 beds)
- **La Grande is known as** a gateway to Eastern Oregon's outdoor recreation, which includes the Blue Mountains & the Hells Canyon area, it is a historic stop on the Oregon Trail, a center for arts and culture with venues like the Elgin Opera House, and a college town thanks to Eastern Oregon University, with its economy supported by lumber and agriculture the City is a blend of rugged outdoor adventure, deep history, and small-town charm set in the scenic landscape of Eastern Oregon

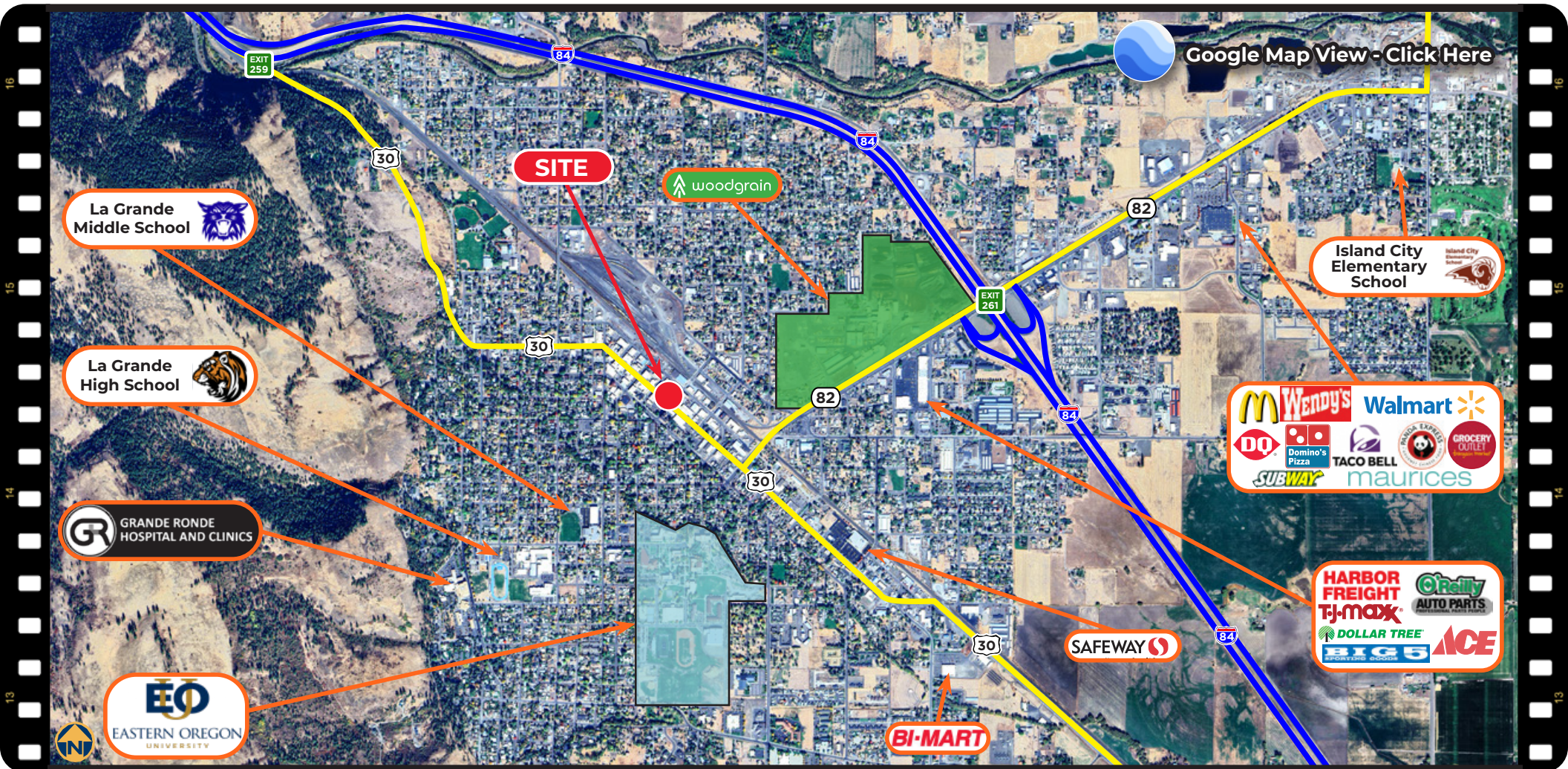

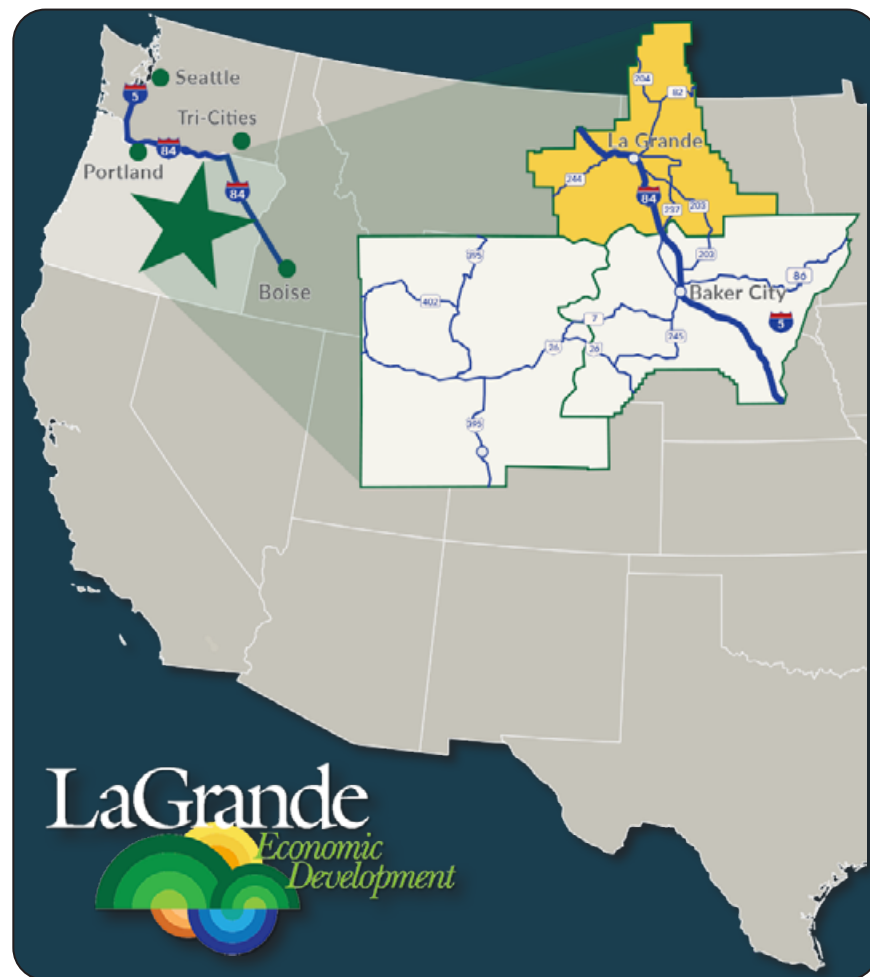
