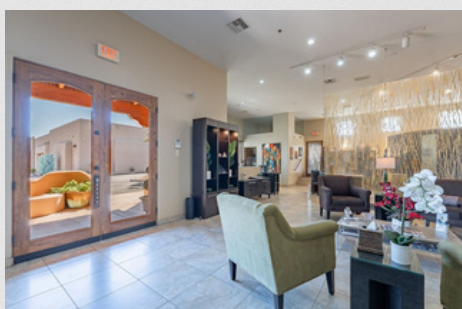

**Parking:** All tenants participate in the *Parking Overlay Association*, an organized agreement that ensures the maintenance and upkeep of the shared public parking areas. Each tenant contributes an annual fee to the association, which covers landscaping, cleaning, lighting, and overall accessibility for the benefit of all businesses within the development.
