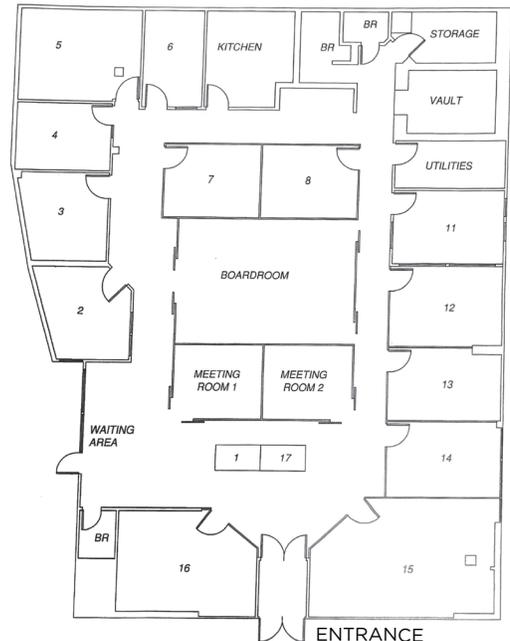

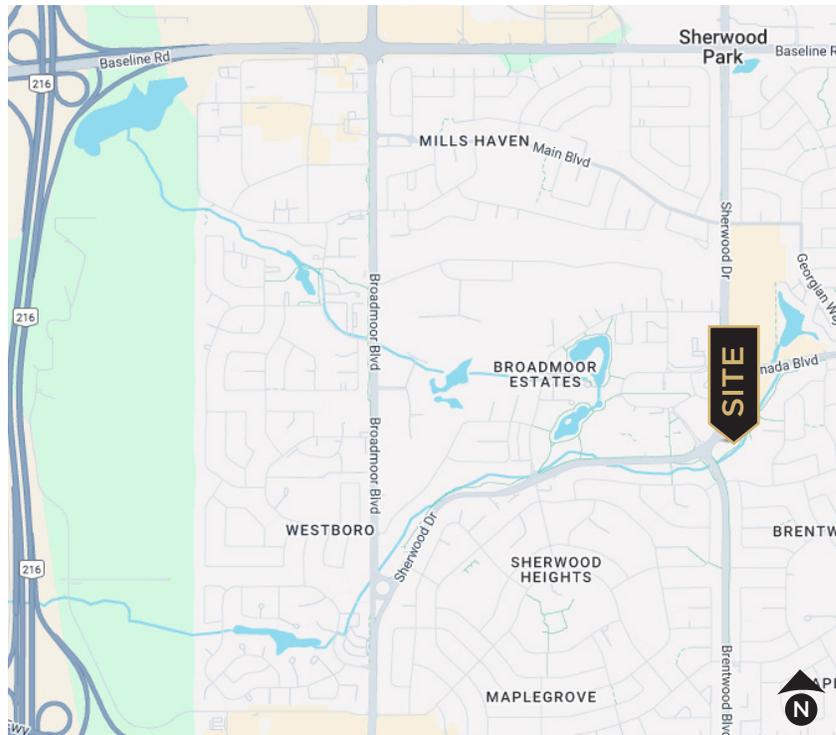
FLOOR PLAN
