

Comprising four parcels with dual access from New Kings Road and Pitts Road, this property is undergoing rezoning of its Residential Rural (RR) portions to Business Park (BP) classifications. The development plan includes the construction of five buildings totaling 55,000 square feet, designed for flex industrial use, complete with extensive parking facilities. Currently zoned CCG-2, the site supports a wide range of activities including self-storage, wholesaling, warehousing, storage, distribution, light manufacturing and more. This makes it an ideal location for contractors, IOS storage, container storage and general lay-down yards. Its advantageous location just one mile north of the I-295 corridor, with convenient access from two nearby exits, provides exceptional connectivity for both north and southbound traffic, highlighted by 207 feet of frontage on New Kings Road.


