Currently, 68.7% of the 33,610 housing units in the area are owner occupied; 22.3%, renter occupied; and 9.0% are vacant. Currently, in the U.S., 58.5% of the housing units in the area are owner occupied; 31.7% are renter occupied; and 9.8% are vacant. In 2020, there were 32,831 housing units in the area and 8.7% vacant housing units. The annual rate of change in housing units since 2020 is 0.72%.
