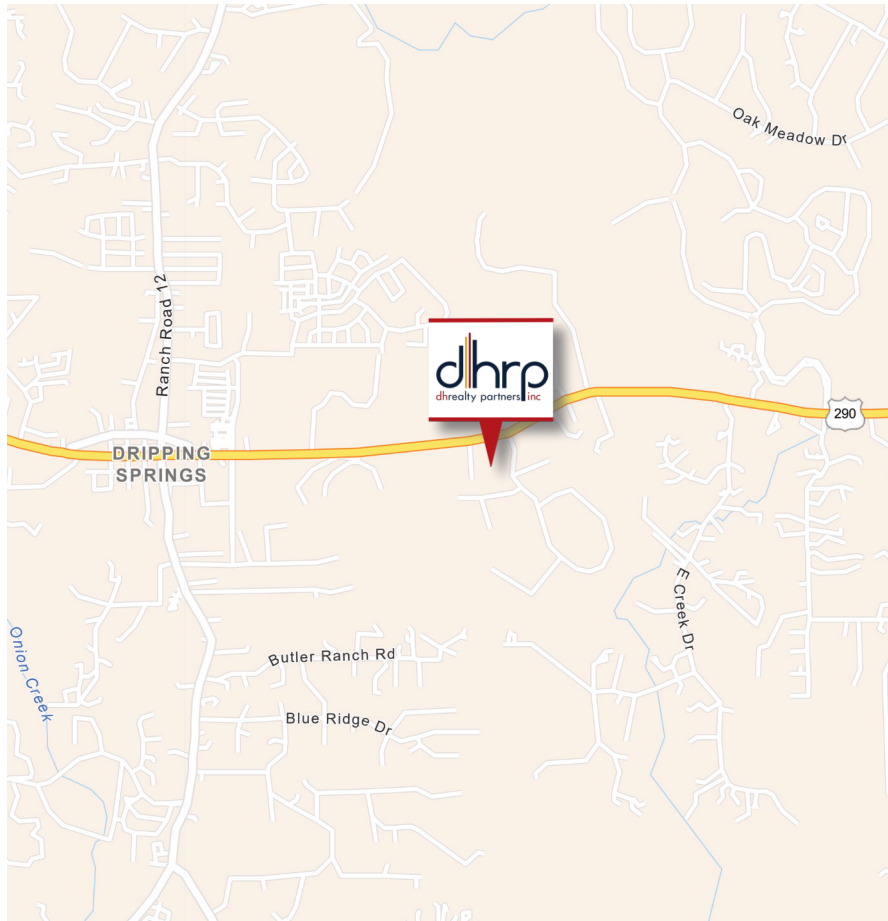

Information About Brokerage Services
