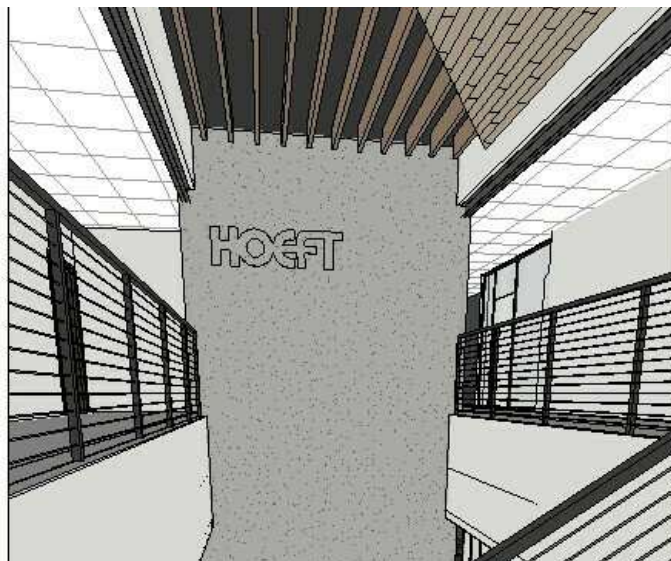
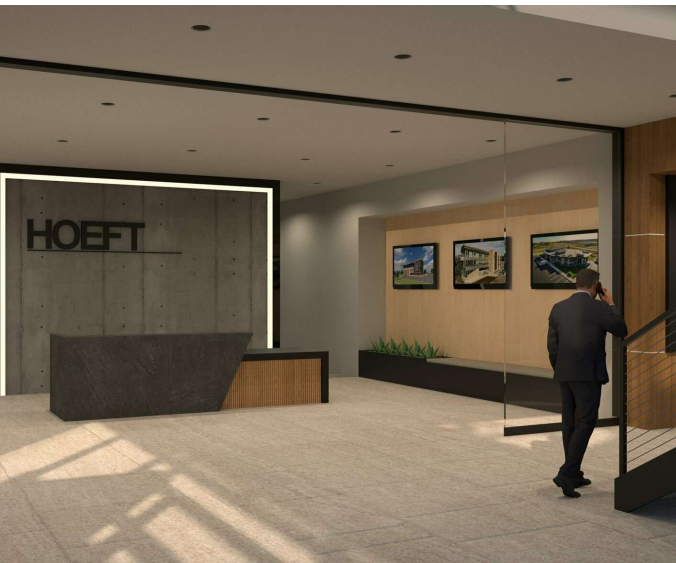

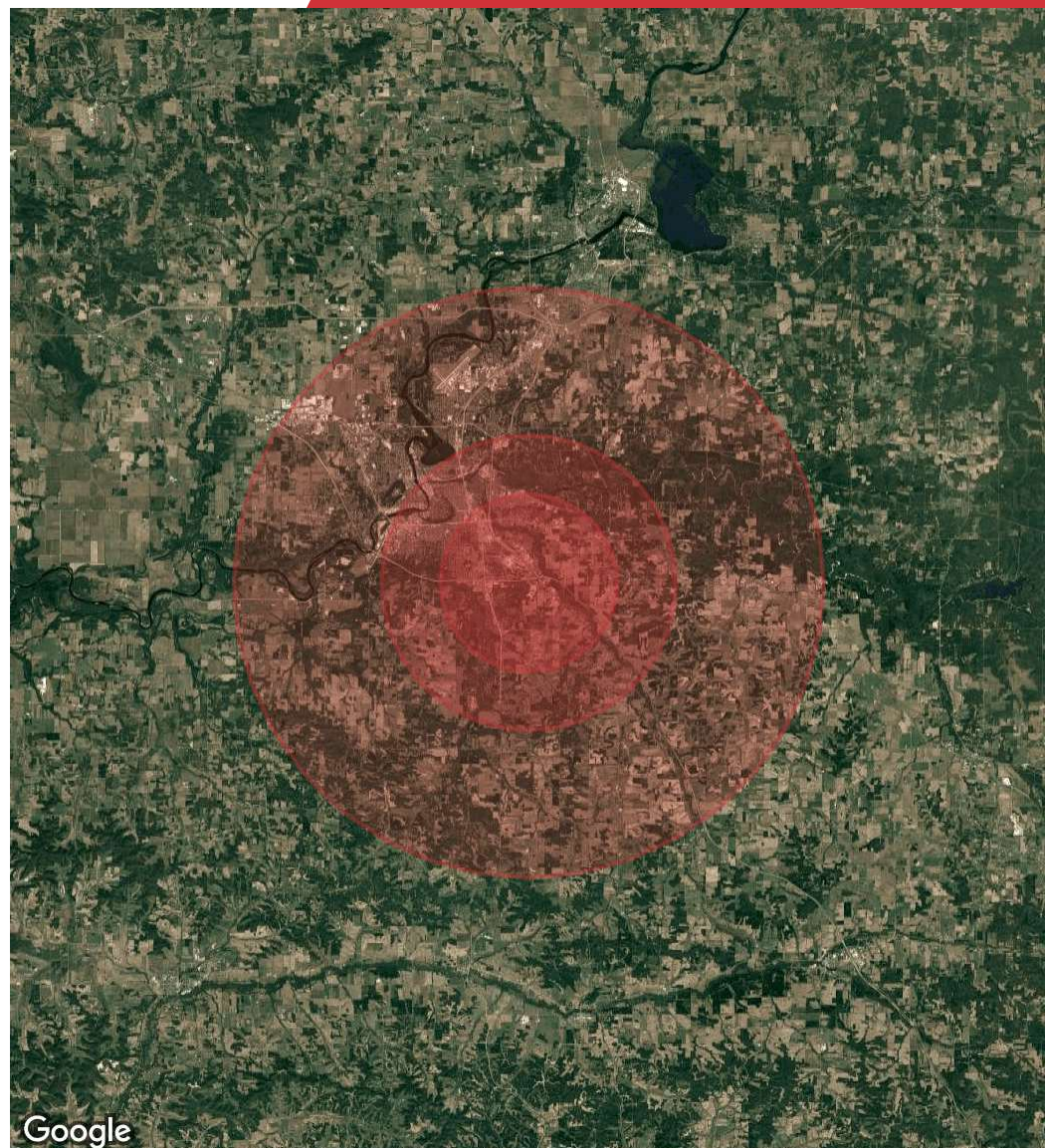

## BROKER DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS
