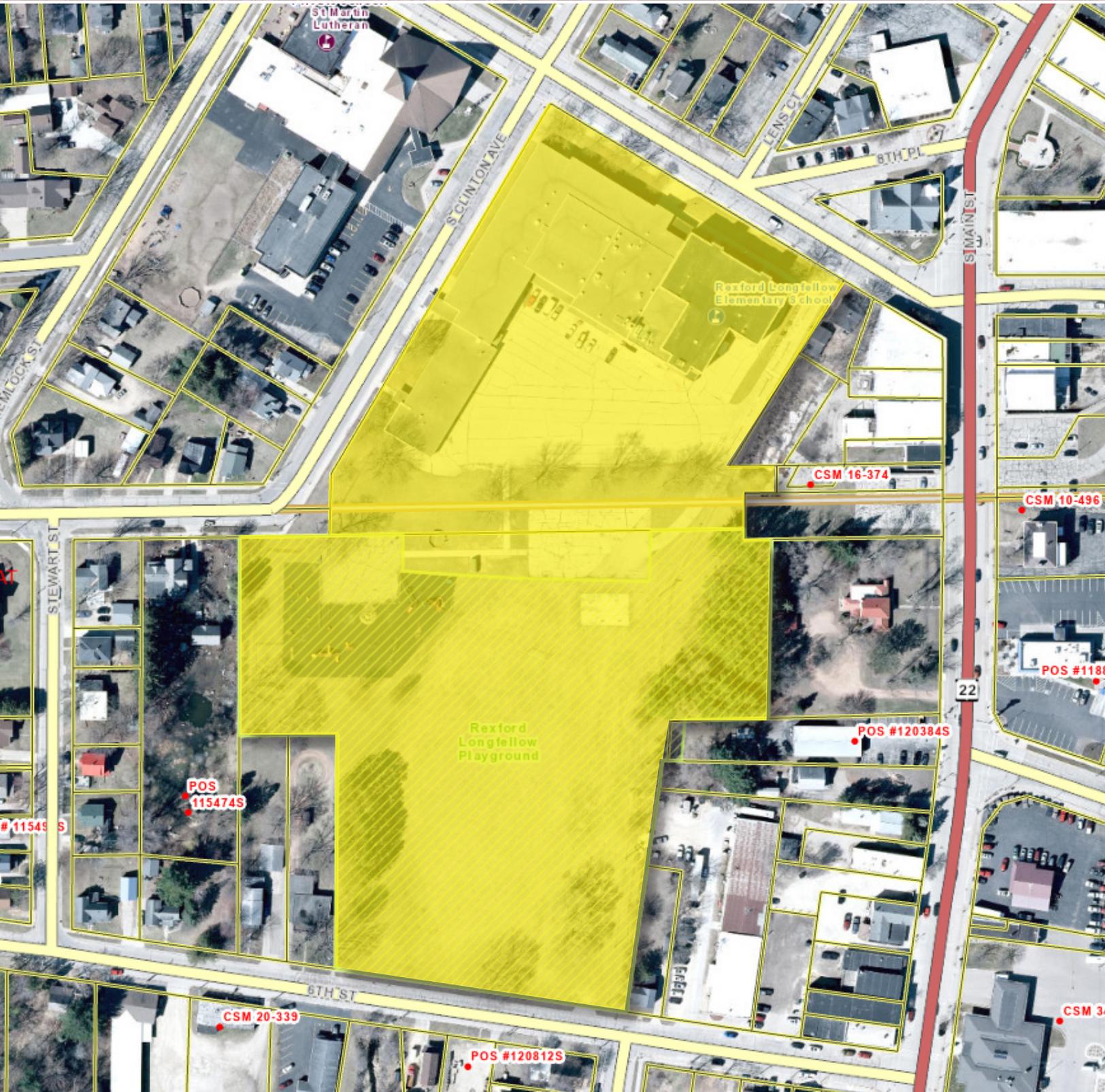

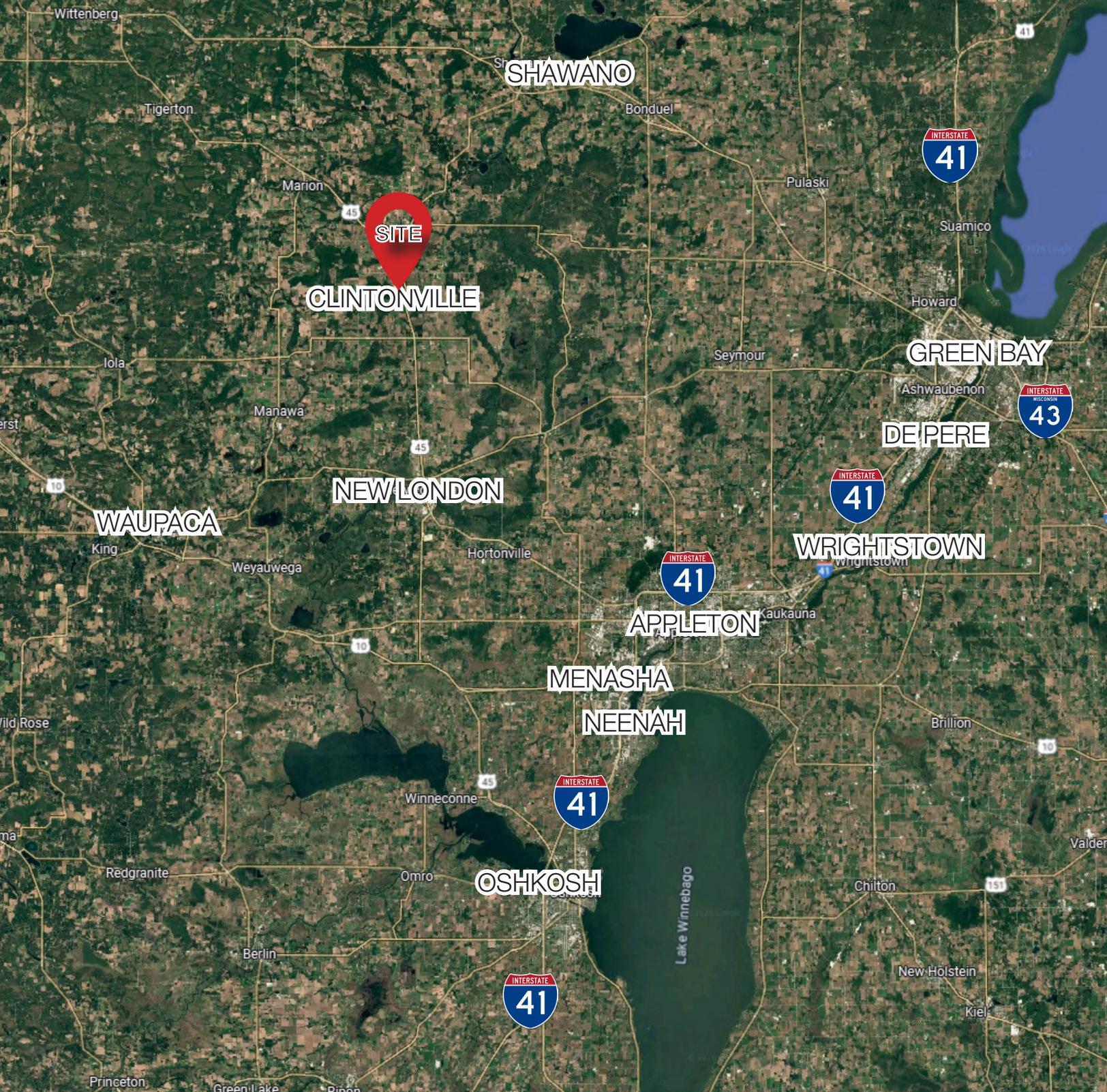
Additional Property Features

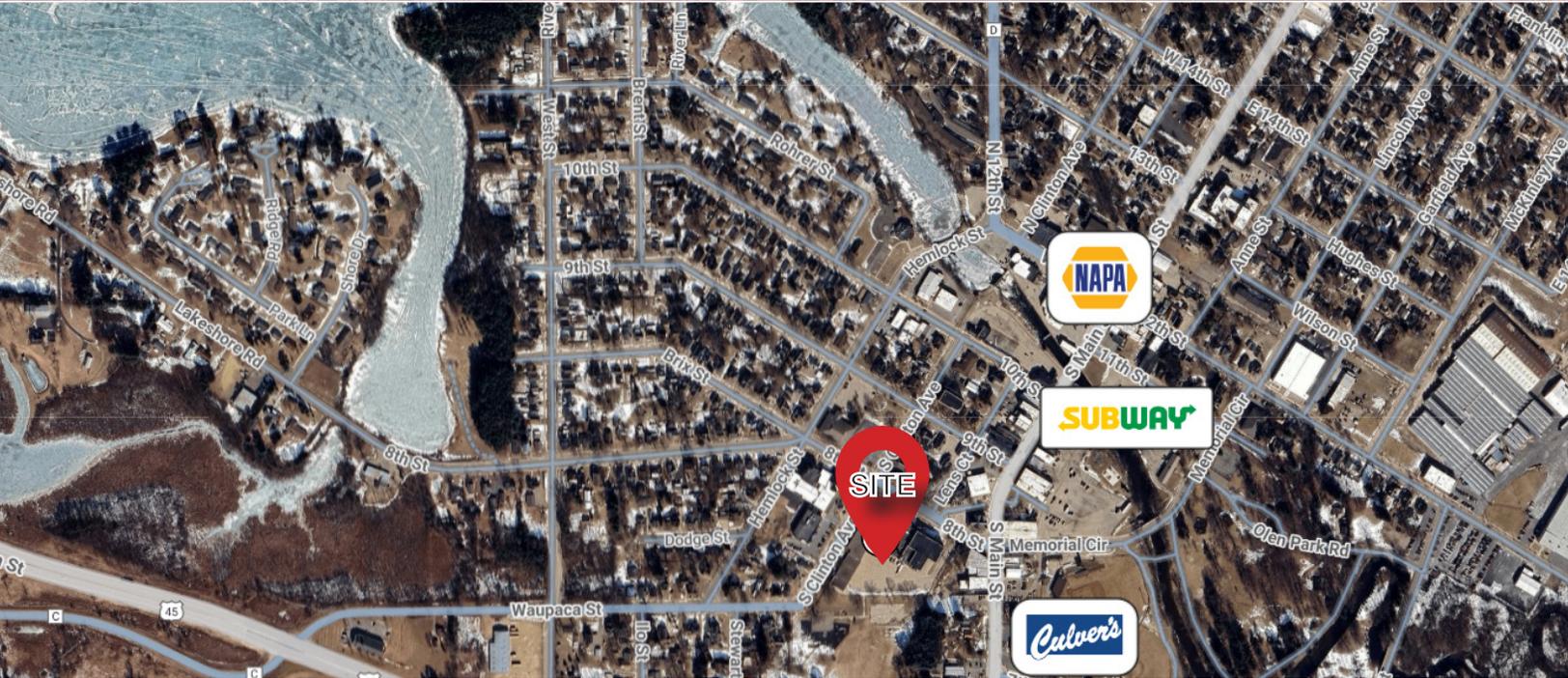
The approximately 180,000-square-foot property sits on over 10 acres and offers a wide range of functional spaces, including a gym constructed in 1981 with separate boys' and girls' locker rooms and a balcony overlooking the space, as well as a newer large gym with a partition wall, additional boys' and girls' locker rooms, and three storage areas.

The building also features an auditorium originally built in 1918 with a stage and lighting booth, an art room, band room, library, main office, four to six rooms with partition walls, and a south wing designed for younger children with five rooms. Additional amenities include an industrial kitchen with a walk-in cooler and freezer, two boilers that are alternated every other year, outdoor playground areas with basketball hoops, and individual rooms averaging approximately 1,000 square feet.

STATE OF WISCONSIN BROKER DISCLOSURE



Wisconsin law requires all real estate licensees to give the following information about brokerage services to prospective customers.

Prior to negotiating on your behalf the Brokerage firm, or an agent associated with the firm, must provide you the following disclosure statement.

Disclosure to Customers

This disclosure is required by section 452.135 of the Wisconsin statutes and is for information only. Confidentiality Notice to Customers

The Firm and its Agents will keep confidential any information given to the Firm or its Agents in confidence, or any information obtained by the Firm or its Agents that a reasonable person would want to be kept confidential, unless the information must be disclosed by law or you authorize the Firm to disclose particular information. The Firm and its Agents shall continue to keep the information confidential after the Firm is no longer providing brokerage services to you.

To ensure that the Firm and its Agents are aware of what specific information you consider confidential, you may list that information below or provide that information to the Firm or its Agents by other means. At a later time, you may also provide the Firm or its Agents with other information you consider to be confidential.

An “Adverse Fact” is defined in Wis. Stat. 452.01(1e) as a condition or occurrence that a competent licensee generally recognizes will significantly and adversely affect the value of the property, significantly reduce the structural integrity of improvements to real estate, or present a significant health risk to occupants of the property; or information that indicates that a party to a transaction is not able to or does not intend to meet his or her obligations under a contract or agreement made concerning the transaction.
