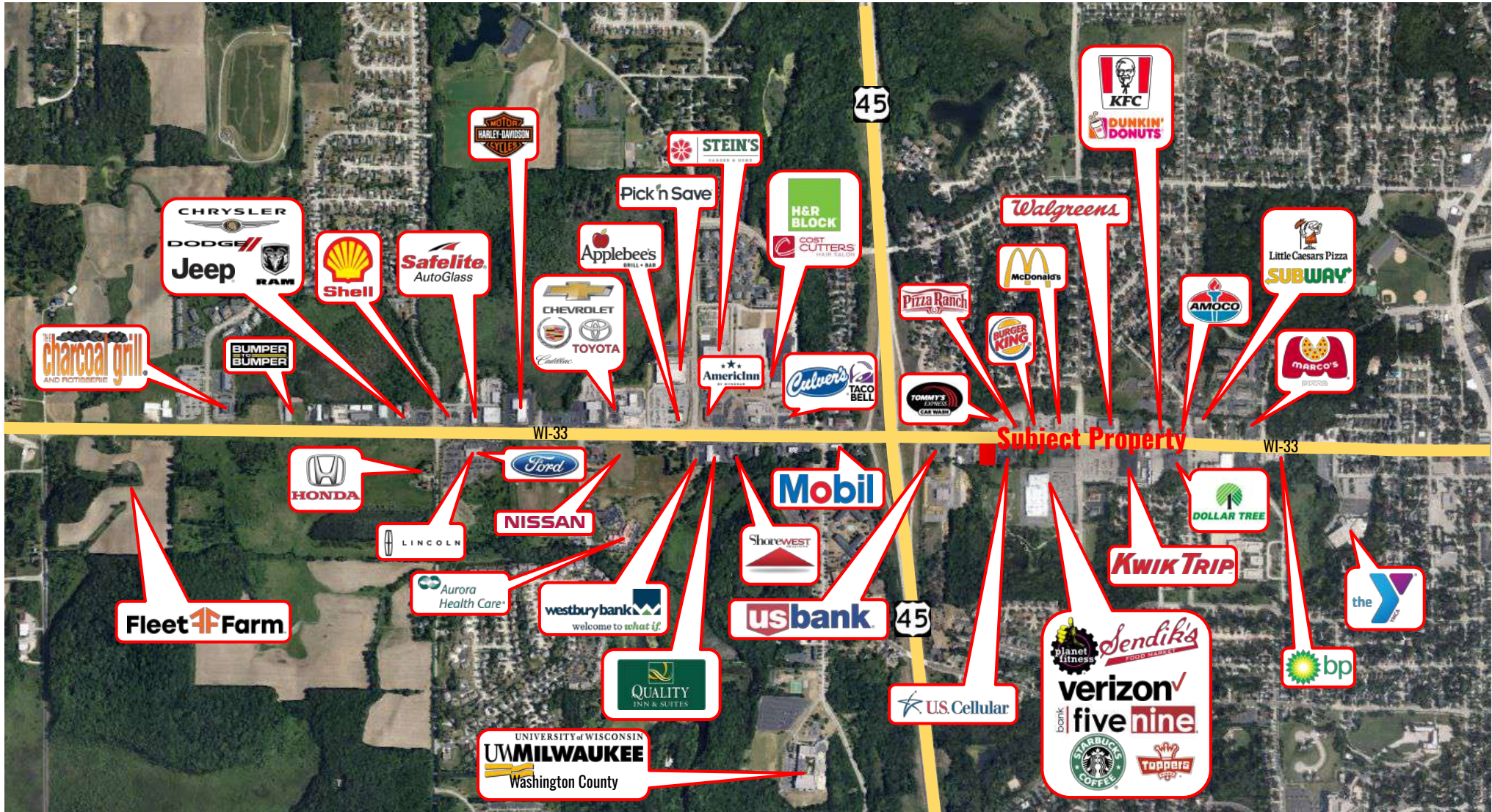

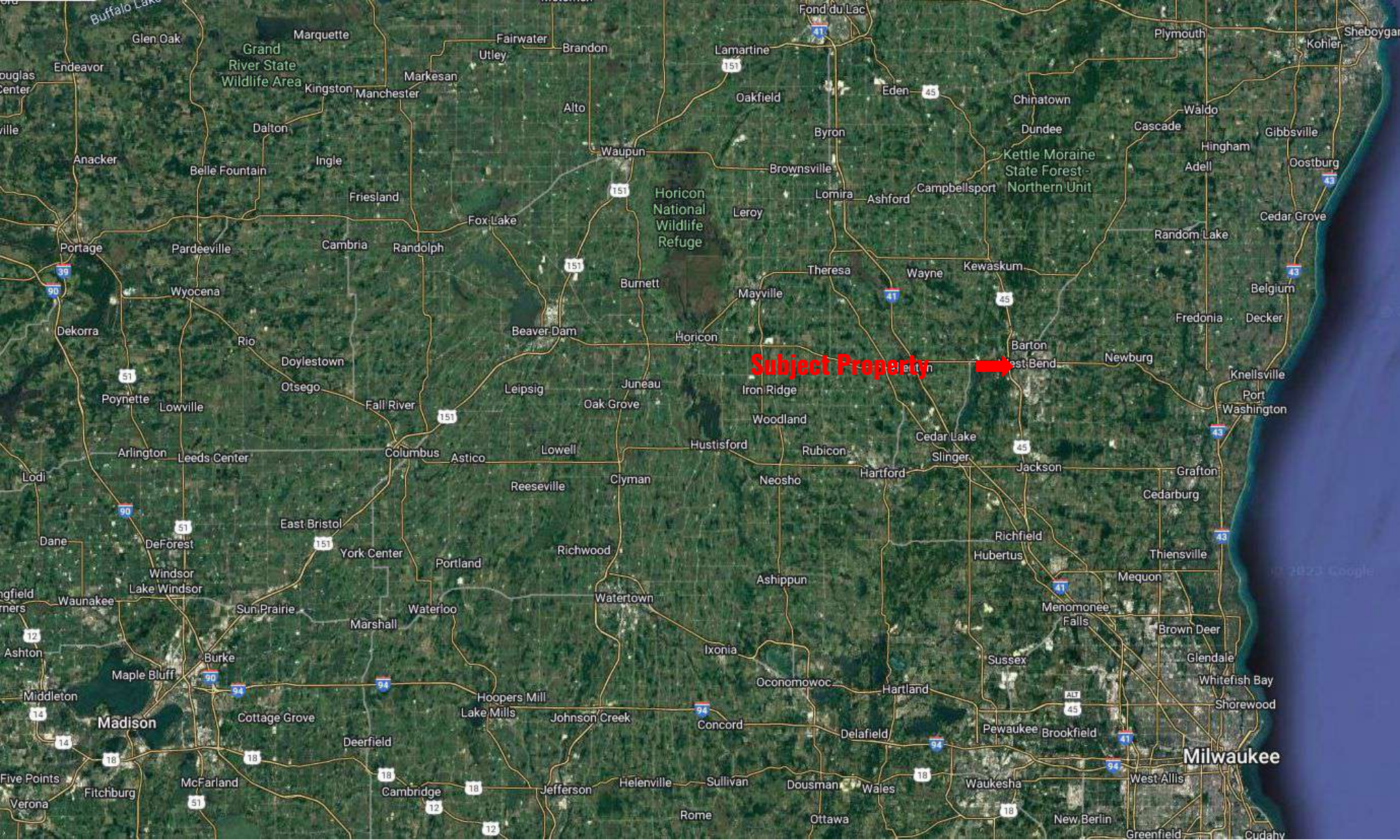

# Area Map



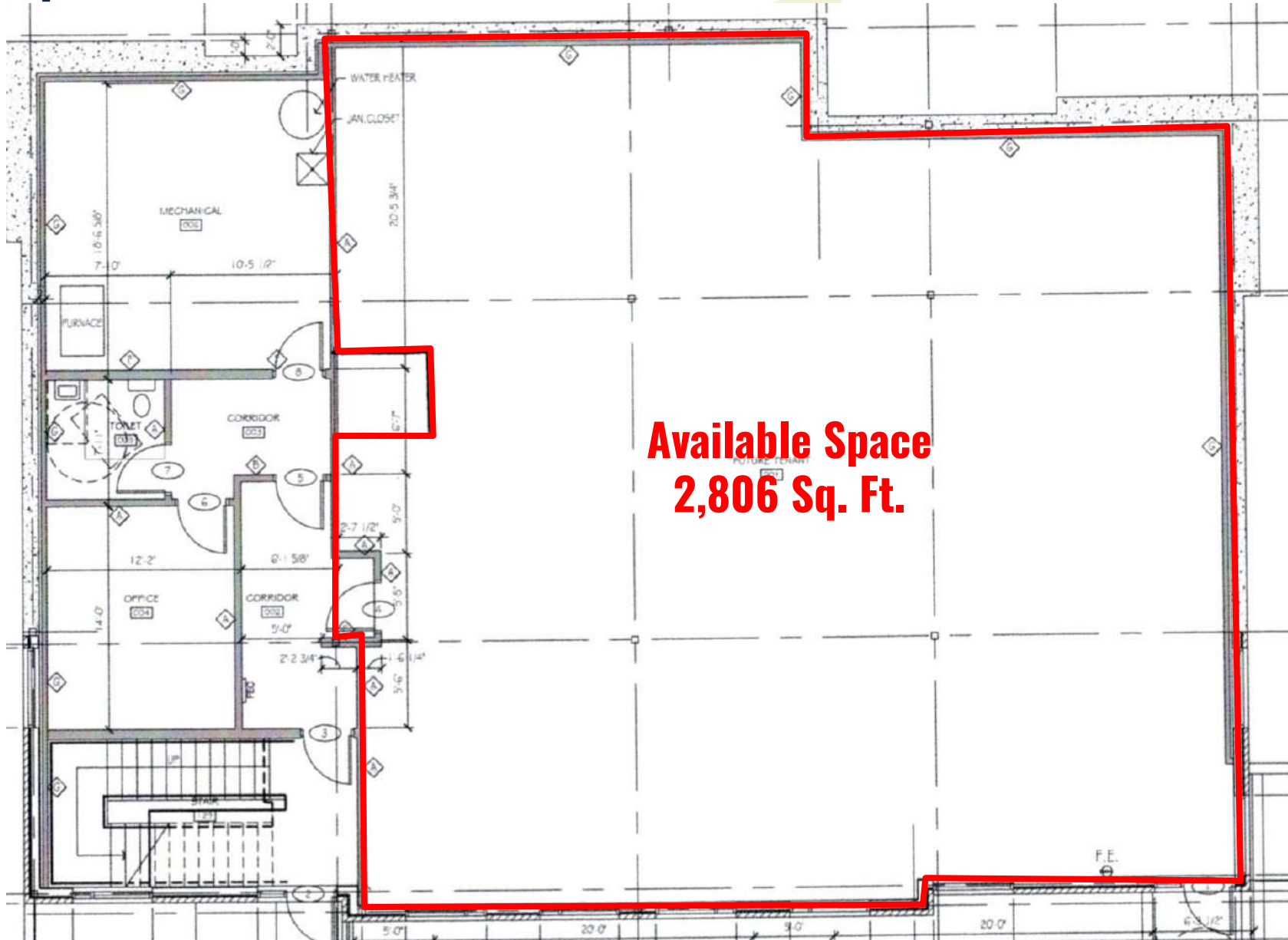
