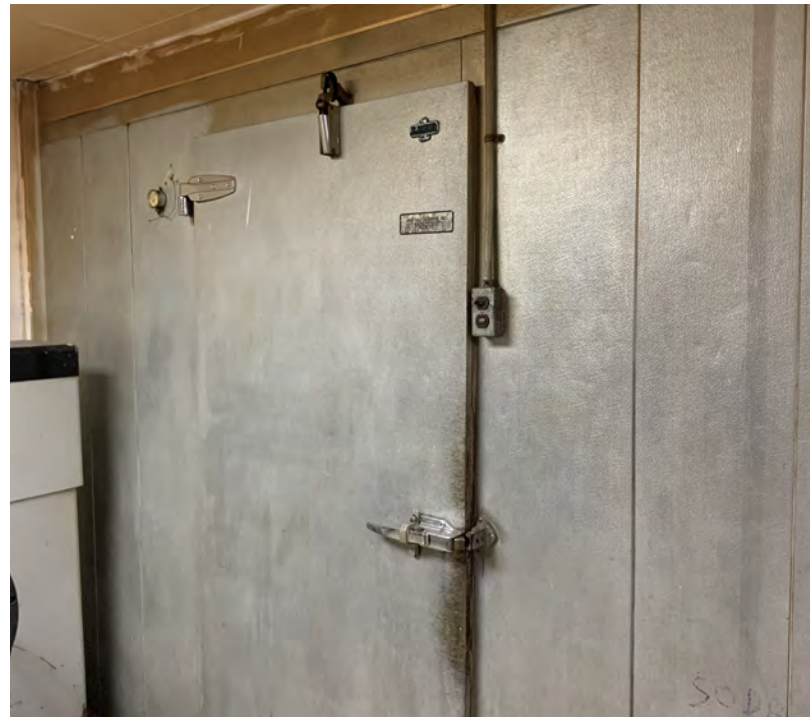

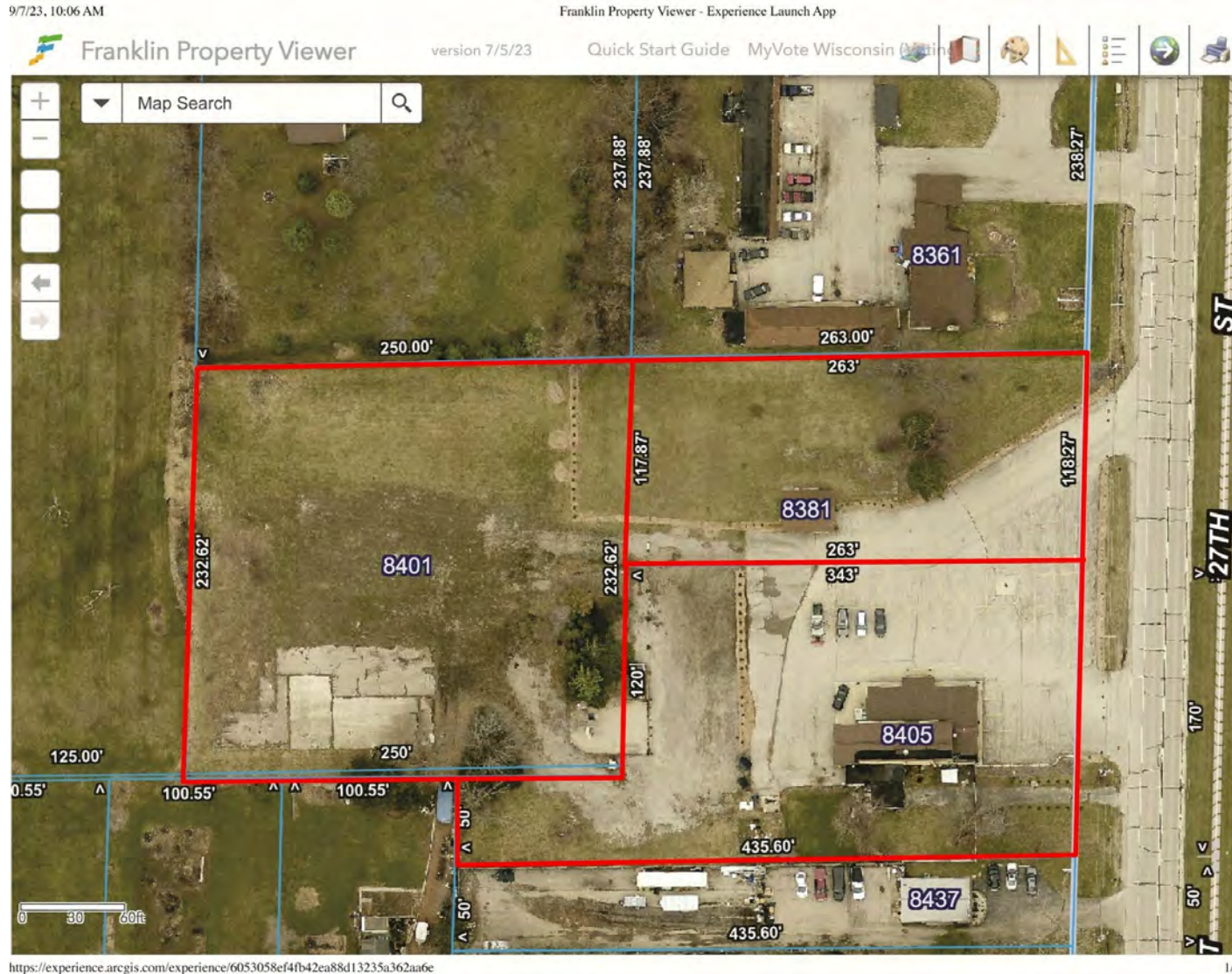

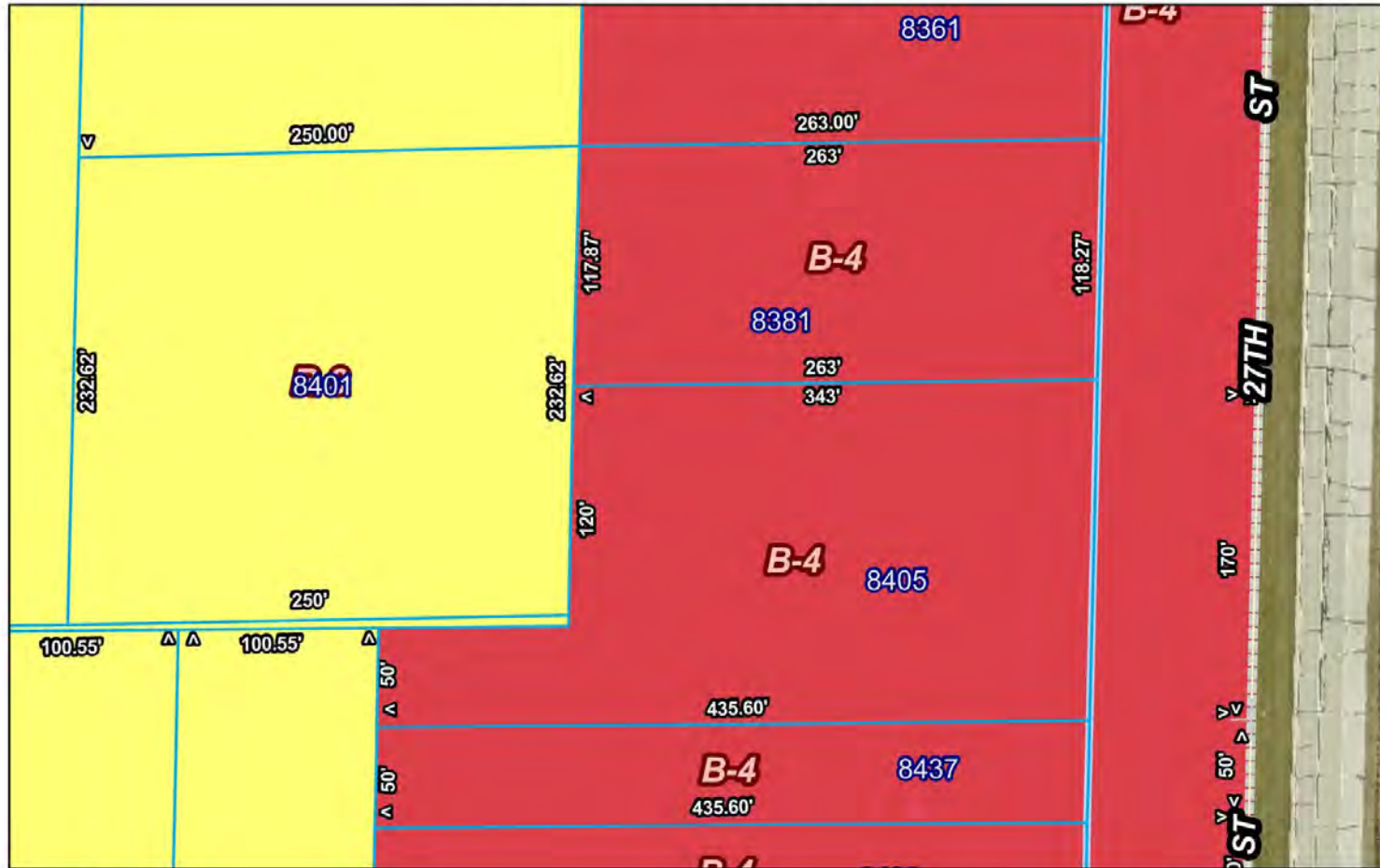

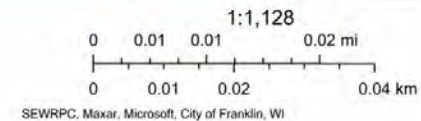
ZONING MAP | TURN KEY RESTURANT AND BAR OR REDEVELOPMENT OPPORTUNITY FOR SALE

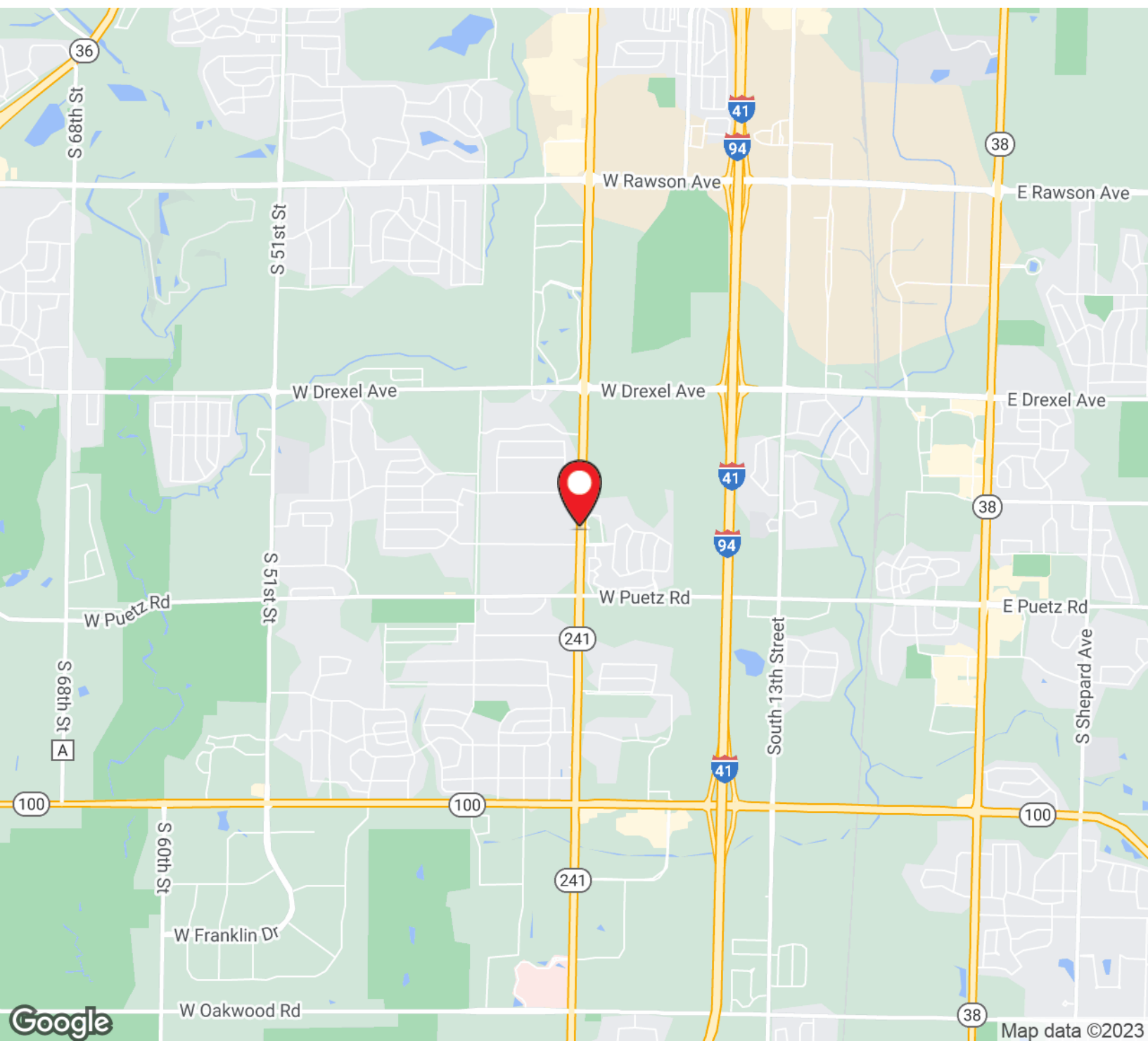

DISCLOSURE TO NON-RESIDENTIAL CUSTOMERS
