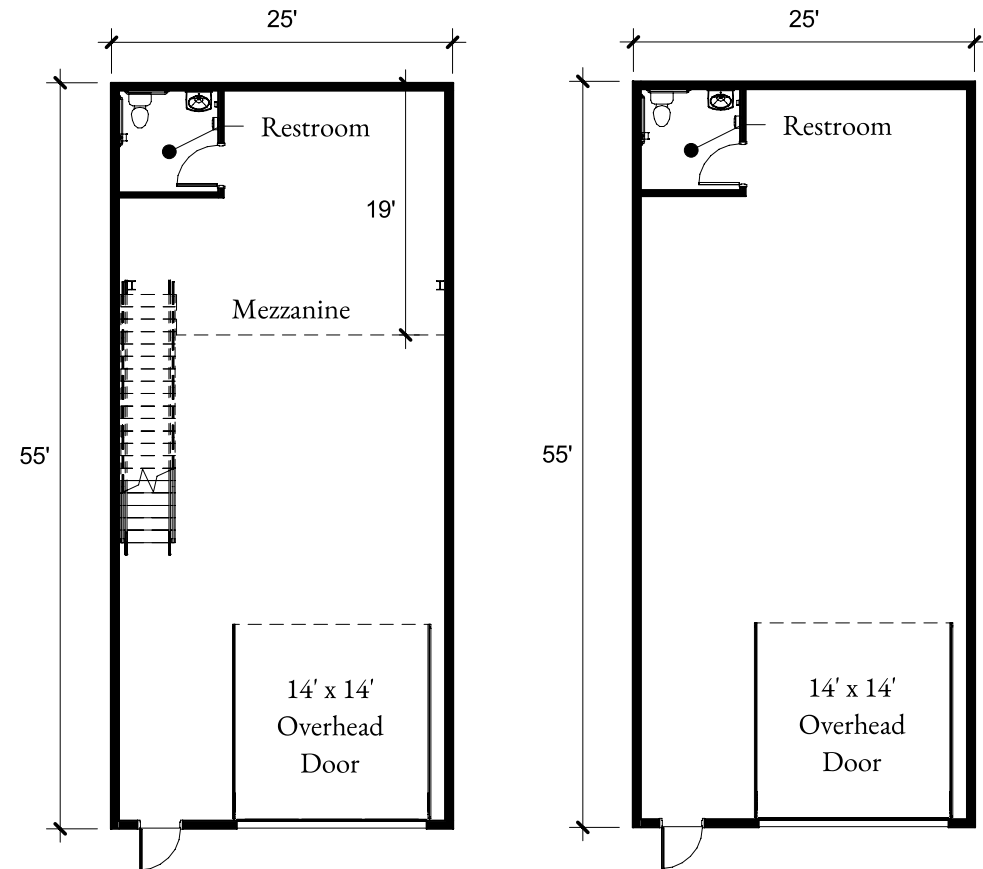


FLOOR PLANS

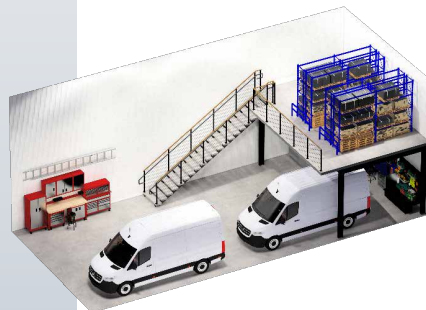
