Built in 2004, the property offers excellent functionality with 26' clear height, ten 12' x 12' grade-level doors, wet sprinklers, skylights, and efficient reinforced-concrete construction. Situated on a generous 2.3-acre parcel with parking ratio (2.09/1,000 SF), the site provides exceptional access via Gene Autry Trail and E. Tachevah Drive, placing it within minutes of major transportation routes.

The property's location within the Coachella Valley industrial corridor and proximity to the airport make it ideal for logistics, manufacturing, distribution, or service-industrial users seeking a prime Palm Springs address.
