All of a certain tract or parcel of land situated in Caldwell County, Texas and being a part of the Pablo Martinez Survey A-181 and being also a part of a tract of land called 81.2 acres and conveyed to Matilde Castillo by deed recorded in Volume 200 Page 323 of the Deed Records of Caldwell County, Texas and being more particularly described as follows:

BEGINNING at a capped $\frac{1}{2}$ " iron pin set in the intersection of the SW line of F.M. #1854 and the NW line of County Road #178 and in the East corner of the above mentioned 81.2 acre tract for the East corner this tract.

THENCE S 44 degrees 25 minutes 01 seconds W with the SE line of the said 81.2 acre tract and the NW line of County Road #178 **990.77 feet** to a capped iron pin found used for basis of bearing in the South corner of the said 81.2 acre tract and an apparent exterior corner of a tract of land called 10.002 acres and conveyed to Albert Martinez et ux by deed recorded in Volume 335 Page 484 of the said Official Records for the South corner this tract.

THENCE N 45 degrees 00 minutes 00 seconds W with the SW line of the said 81.2 acre tract and the partially along the NE line of the above mentioned Martinez tract **2432.87 feet** to a capped $\frac{1}{2}$ " iron pin set in the NE line of a tract of land called 15.004 acres and conveyed to Raymond Kossa et ux by deed recorded in Volume 329 Page 424 of the said Official Records for the West corner this tract and from which point a $\frac{5}{8}$ " iron pin found used for basis of bearing bears N 45 degrees 00 minutes 00 seconds W 969.88 feet.

THENCE N 45 degrees 00 minutes 00 seconds E over and across the said 81.2 acre tract **982.88 feet** to a capped $\frac{1}{2}$ " iron pin set in the NE line of the said 81.2 acre tract and the SW line of F.M. #1854 for the North corner this tract.

THENCE S 45 degrees 11 minutes 07 seconds E with the NE line of the said 81.2 acre tract and the SW line of F.M. #1854 **2422.80 feet** to the place of beginning containing **55.000 acres** of land more or less.
