The subject orchards are irrigated via drip irrigation systems that consist of a filtration system with water distributed to the orchards via underground PVC main lines and laterals to risers, with two above ground emitters.

The subject cropland is irrigated via buried drip systems that consist of aboveground and underground pipeline with drip tape running down the rows.

Property has primarily Grade 1 - Excellent soils.

Westhaven clay loam, 0 to 2 percent slopes.

Cerini clay loam, 0 to 2 percent slopes.
