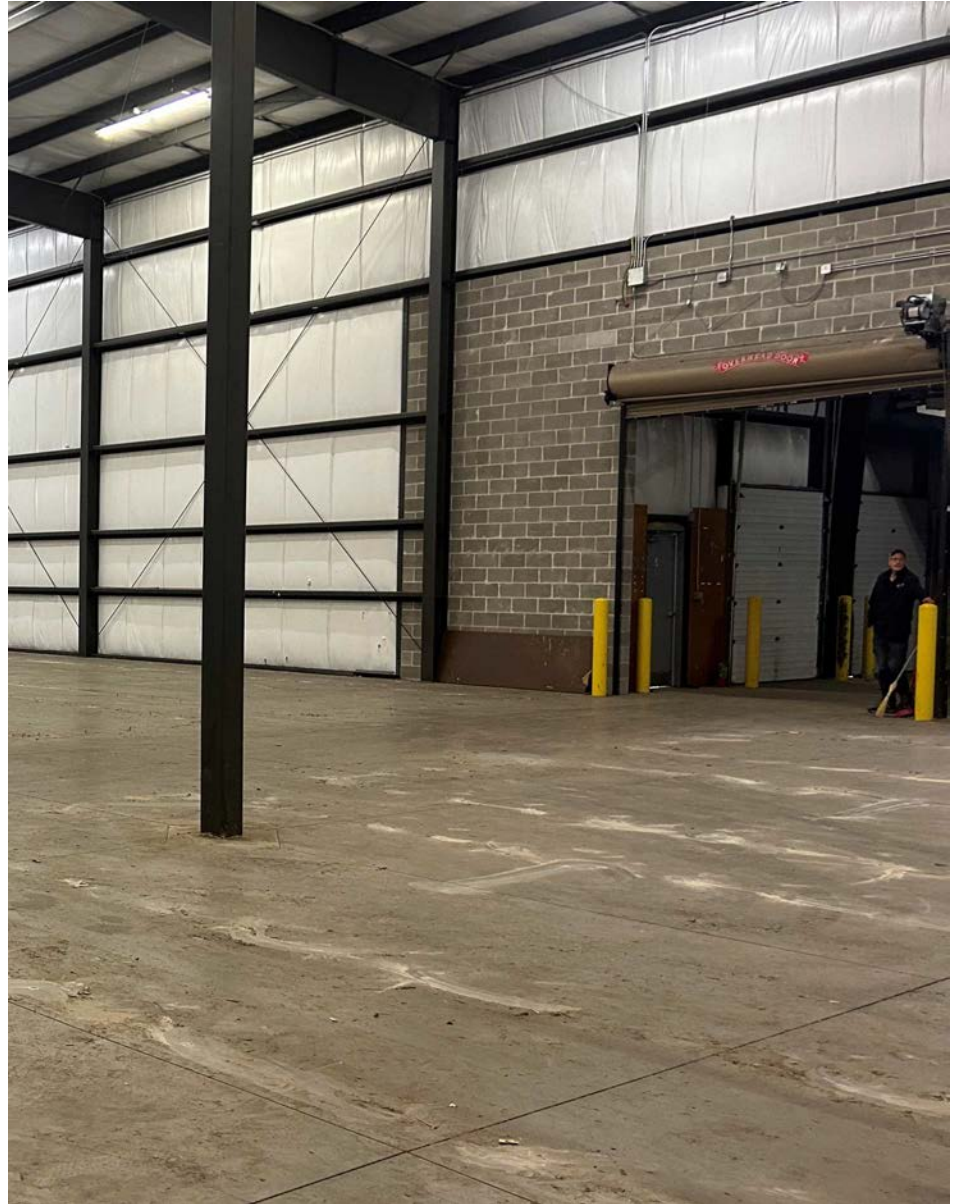

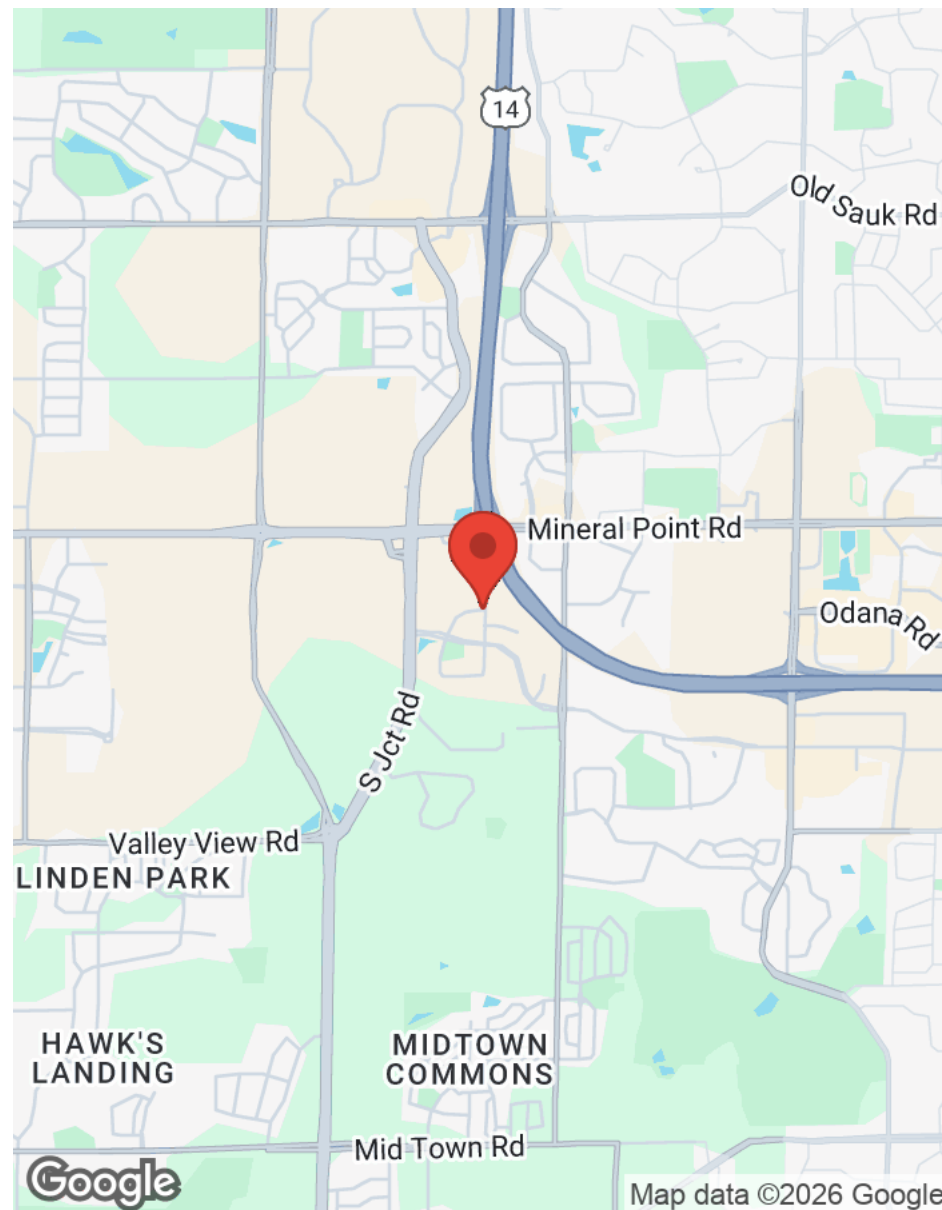
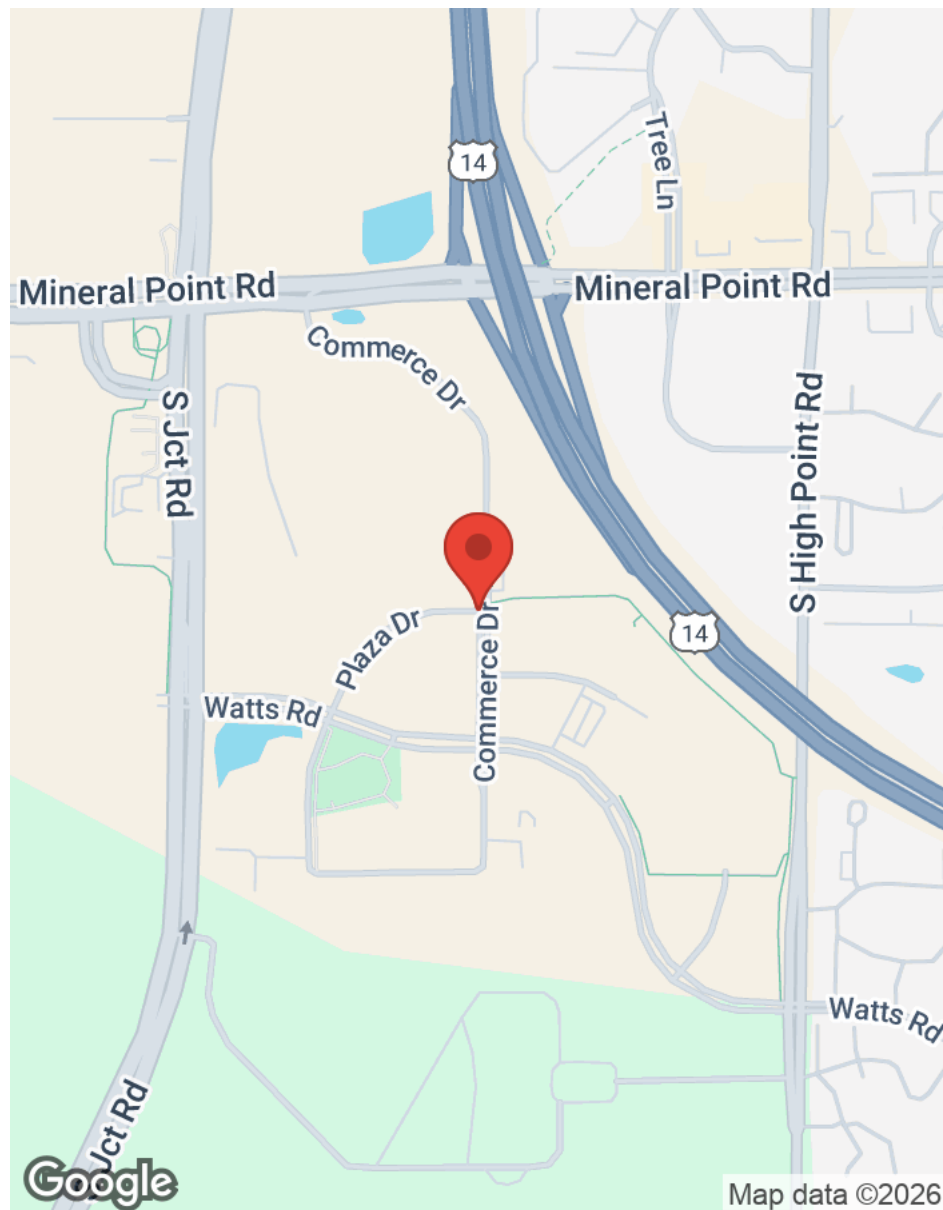






LOCATION MAPS

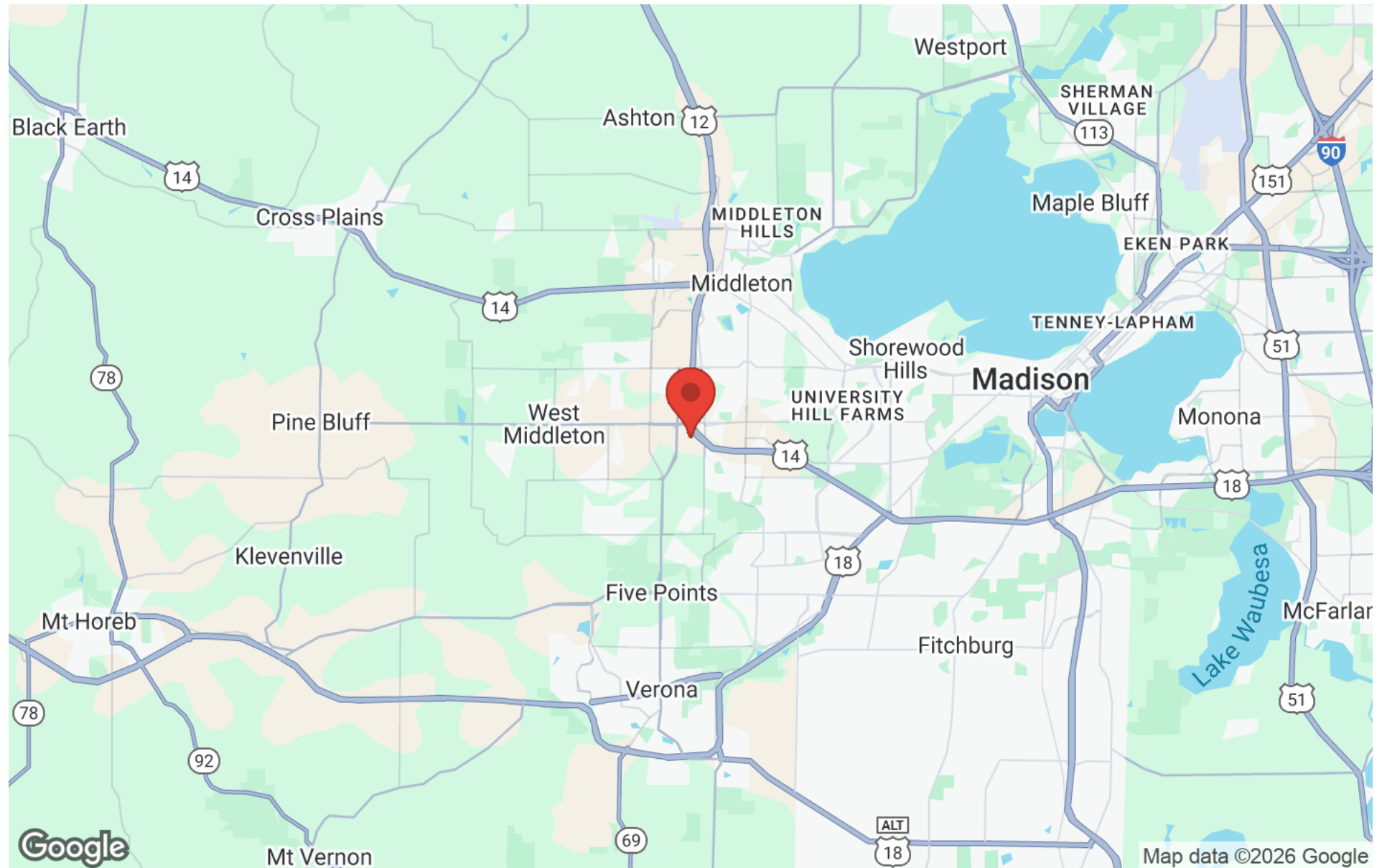

3690 COMMERCE DRIVE | MADISON, WI

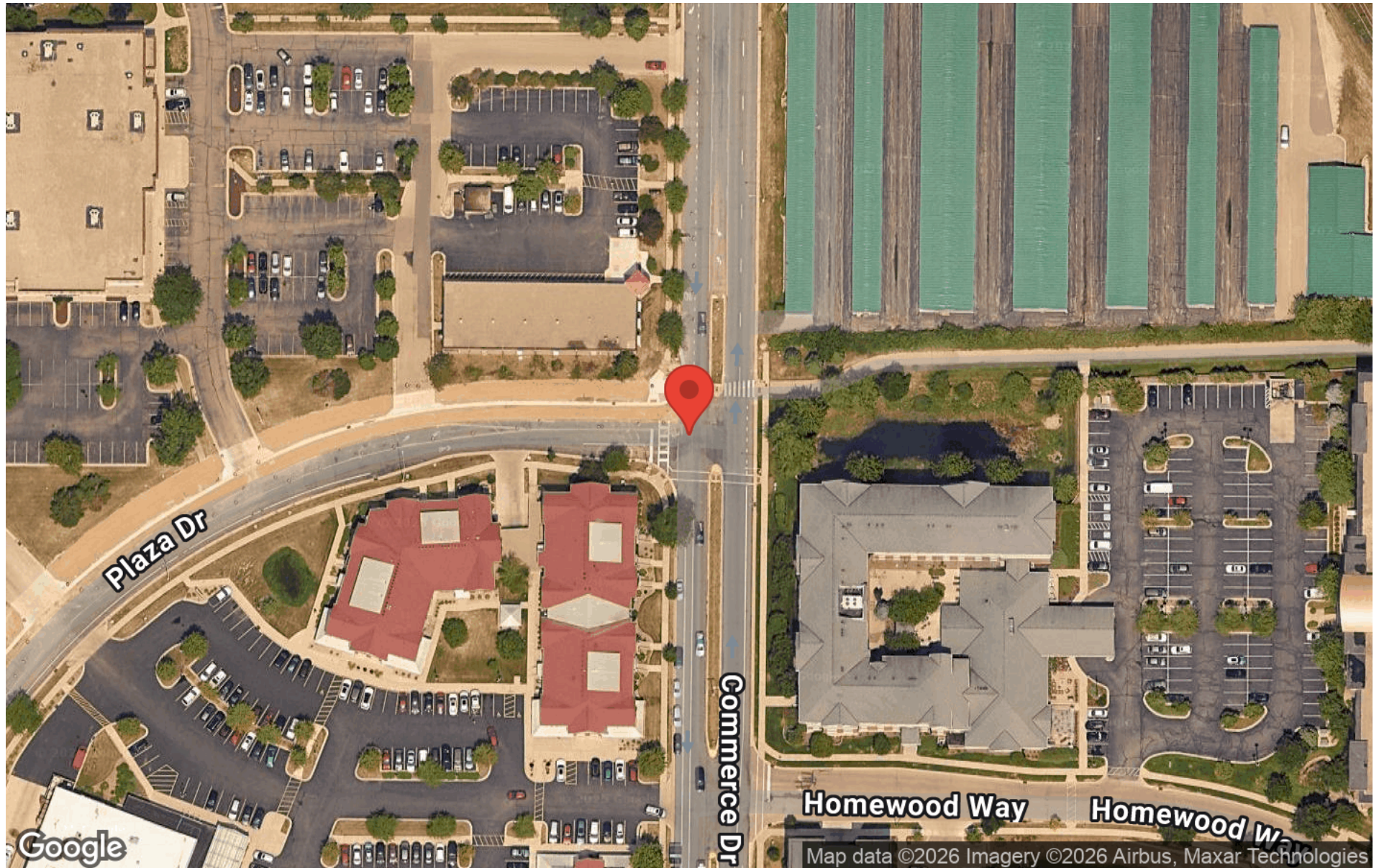

3690 COMMERCE DRIVE | MADISON, WI

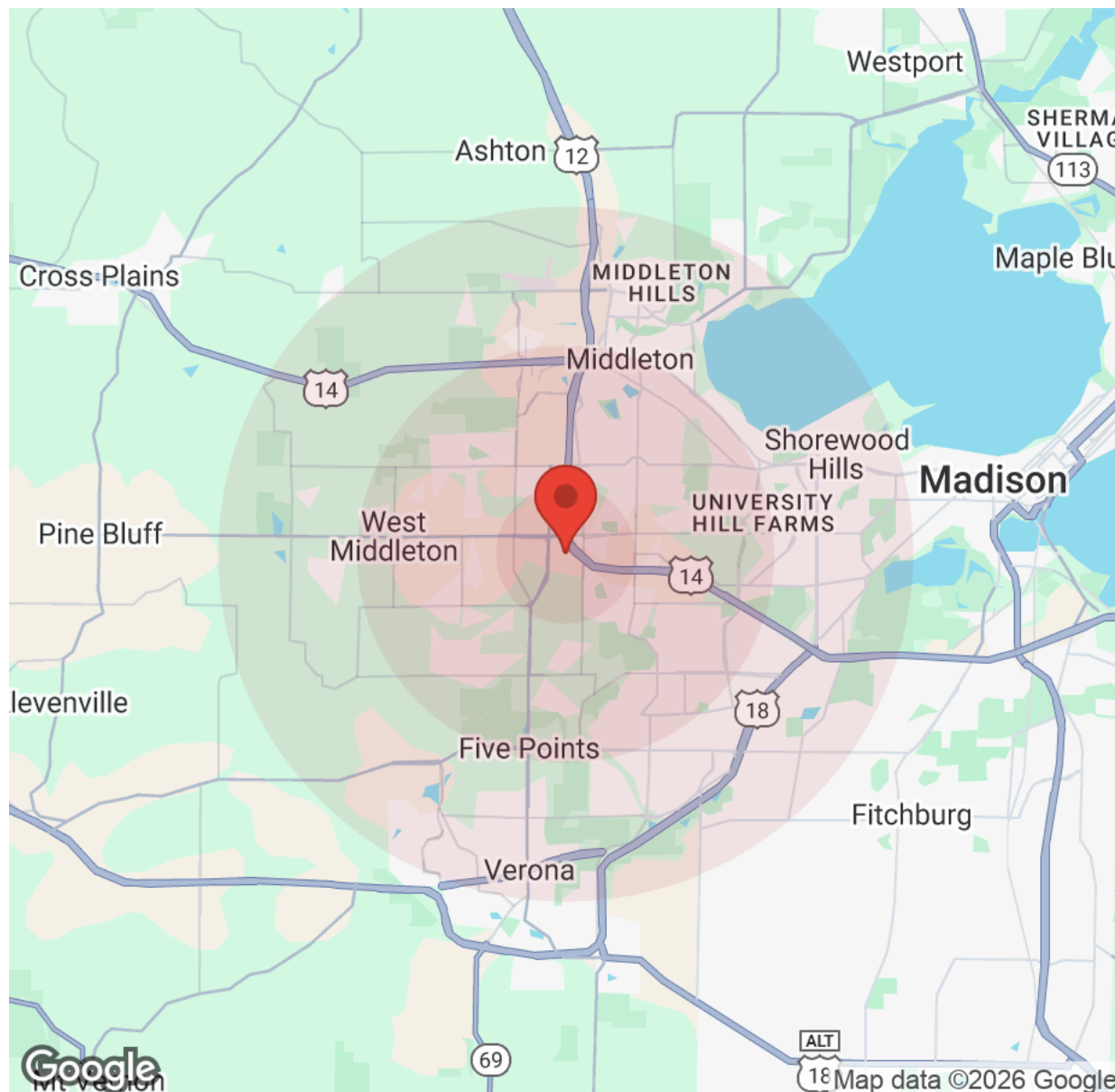
