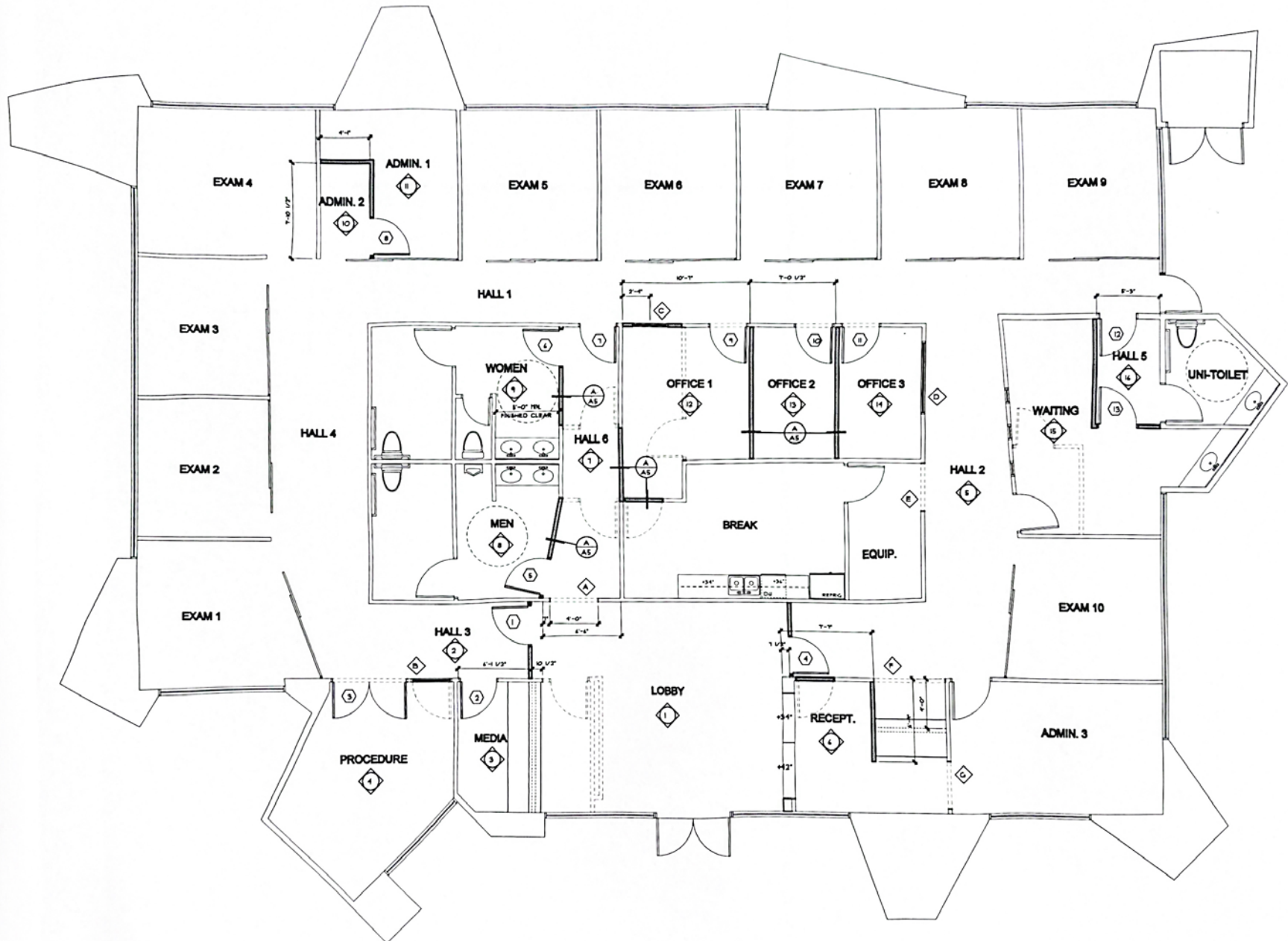

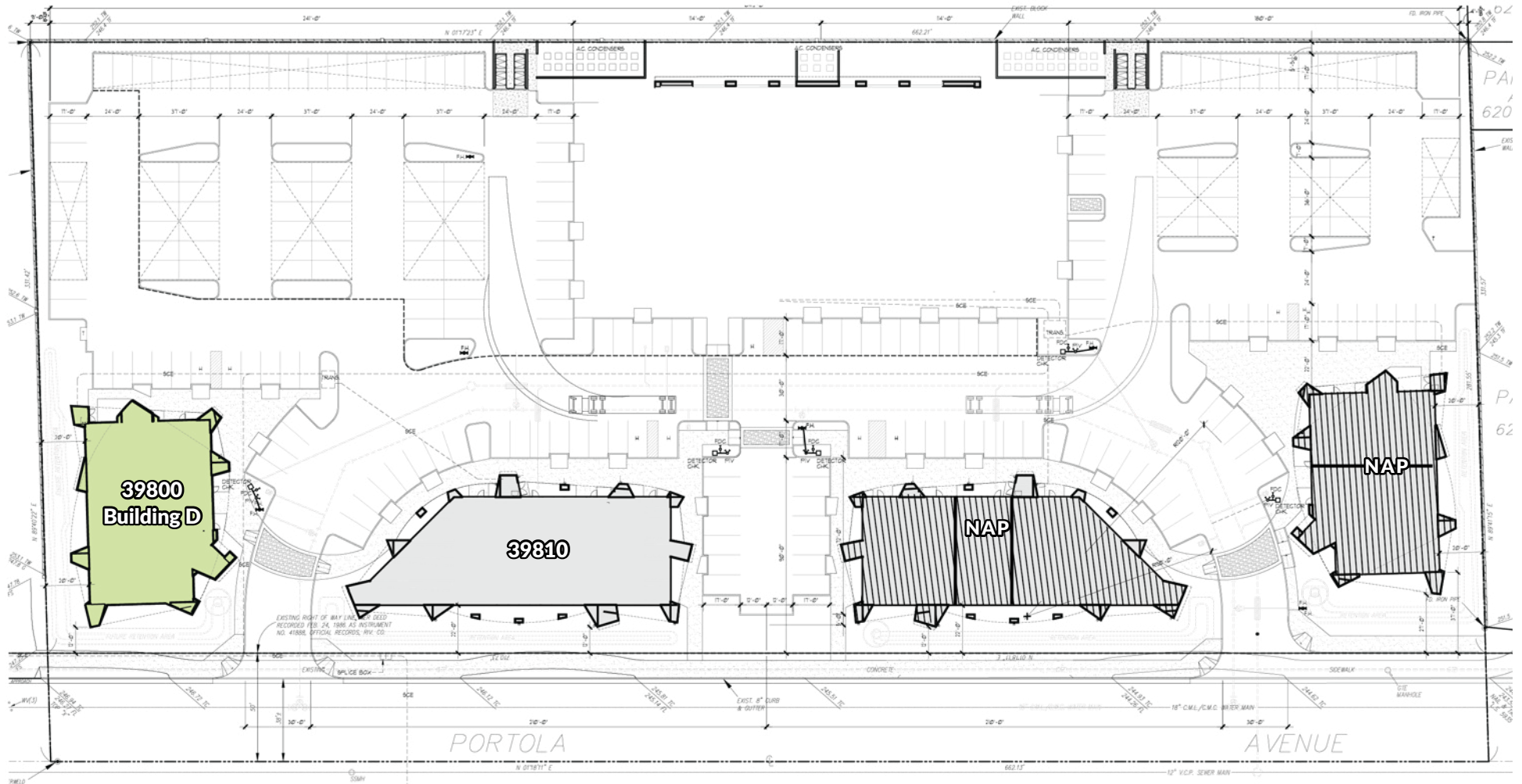
FLOOR PLAN
