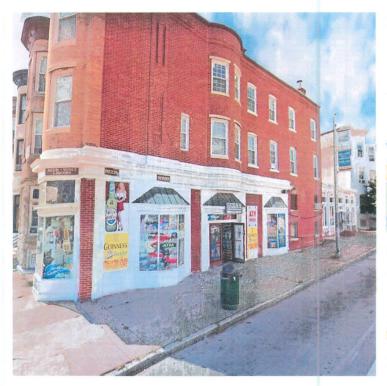

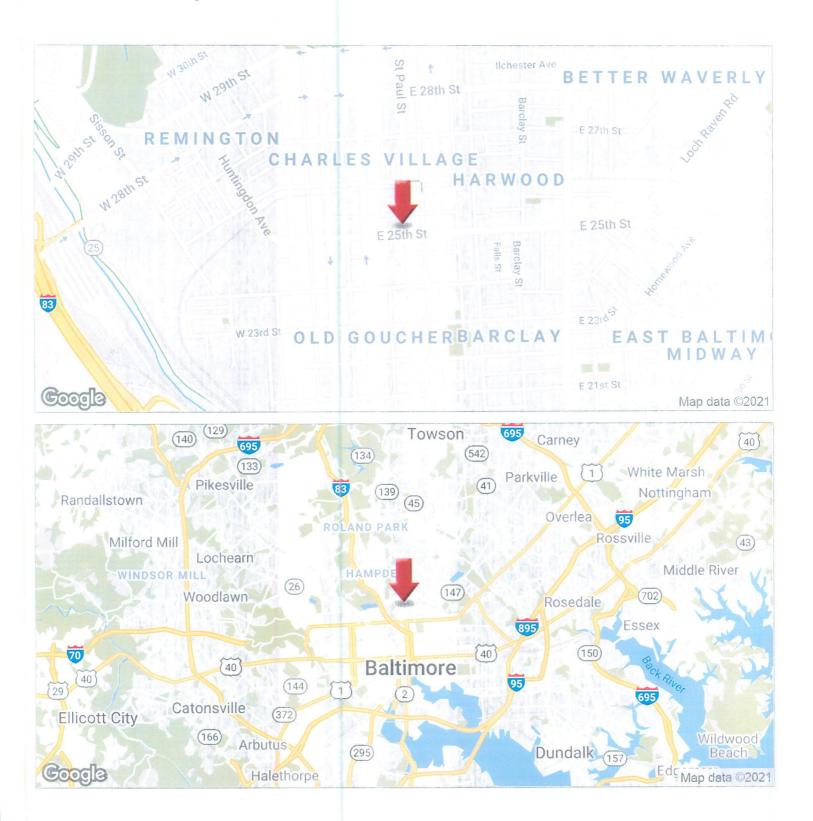








Location Maps
