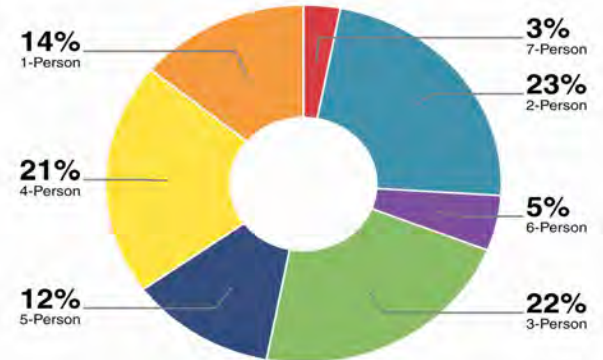

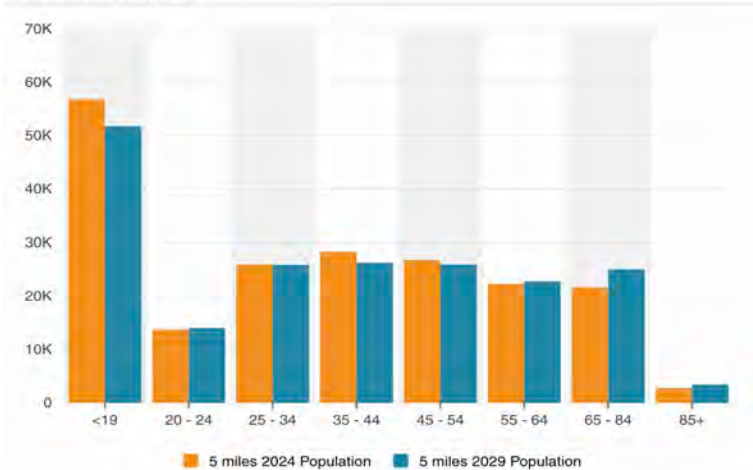

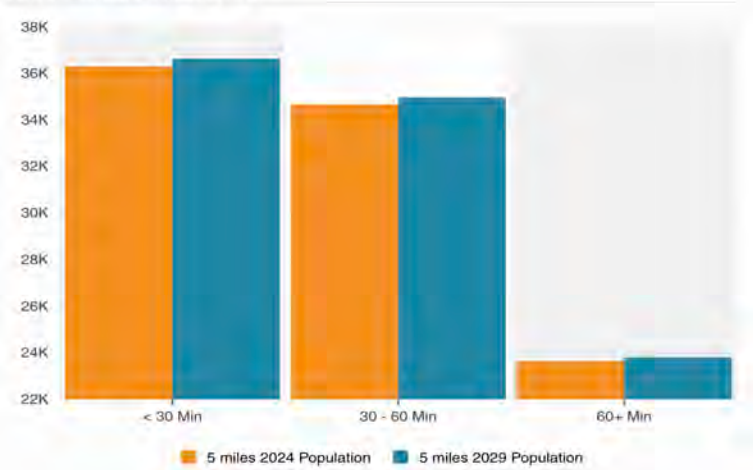


5 miles 2024 % of Households
