

The remaining 70,400 SF will be available for lease starting April 1, 2025 and the whole building is available for sale today offering a great opportunity for a low basis, high quality facility, with cash flow and significant upside.

The Itron manufacturing facility sits on over 19 acres providing land for future expansion needs, has ample parking, a TPO white roof, as well as 6 dock doors and 2 drive-ins. In addition to that the facility boasts multiple investments including a pressurized warehouse with nitrogen access, state of the art security and simplex fire alarm systems, as well as an RF wall for radio frequency.














Area Map
