Description for Peter Grubb Job No. OCG0521

Parcel 2

This parcel is a portion of Government Lot 1 of Section 32 and of Government Lot 1 of Section 33, all in Township 33 North, Range 6 East of the Boise Meridian, Idaho County, Idaho, and is more particularly described as follows:

COMMENCING at the northeast corner of said Government Lot 1, a found brass cap monument;

Thence South 0° 11' 11" West along the east boundary of said Government Lot 1 a distance of 628.36 feet to a found 5/8 inch diameter rebar on the north boundary of Tax 40;

Thence traversing the boundary of said Tax 40 as follows:

South 69° 17' 46" East a distance of 257.00 feet to a found 5/8 inch diameter rebar;

South 00° 12' 26" West a distance of 50.00 feet to a found 5/8 inch diameter rebar;

South 25° 29' 16" West a distance of 100.88 feet to a found 5/8 inch diameter rebar;

South 33° 42' 00" East a distance of 170.82 feet to a point on the northerly right-of-way for U.S. Highway 12 as described in the Warranty Deed filed as Inst. No. 412825, a mag nail set with an aluminum washer stamped L. S. 3627;

Thence northwesterly 320.98 feet along said right-of-way per W.D. No. 412825 following the arc of a curve to the left having a central angle of 17° 19' 17", a radius of 1061.74 feet and a long chord which bears North 66° 11' 35" West a distance of 319.76 feet to a $5/8 \times 30$ inch rebar set with a plastic cap stamped L. S. 3627;

Thence North 76° 20' 20" West continuing along said right-of-way a distance of 185.14 feet to a 5/8 x 30 inch rebar set with a plastic cap stamped L. S. 3627;

Thence leaving said right-of-way bearing North 14° 00' 06" East a distance of 167.12 feet to a 5/8 x 30 inch rebar set with a plastic cap stamped L. S. 3627;

Thence South 79° 53' 22" East a distance of 97.94 feet to a 5/8 x 30 inch rebar set with a plastic cap stamped L. S. 3627;

Thence North 19° 27' 27" East a distance of 68.20 feet to a point on the north boundary of said Tax 40, a 5/8 x 30 inch rebar set with a plastic cap stamped L. S. 3627;

Thence South 69° 20' 44" East a distance of 22.76 feet to the **TRUE POINT OF BEGINNING**, said parcel containing 1.989 Acres more or less.
