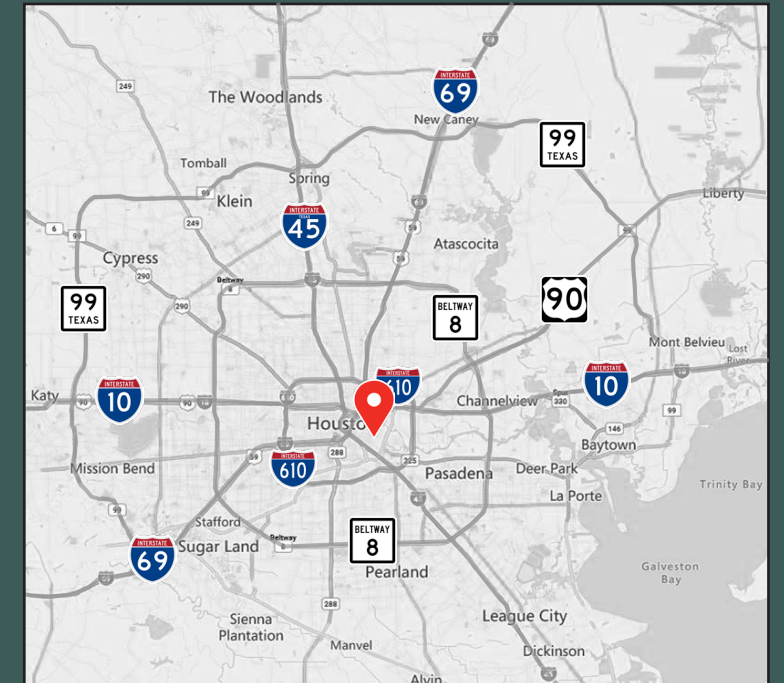

Area Profile

Situated in East Downton Houston ("EaDo") making it convenient for residents/visitors to access the heart of the city.

Adjacent to Buffalo Bayou East Master Plan that will create walking/biking trails, parks, ball fields, and entertainment venues.

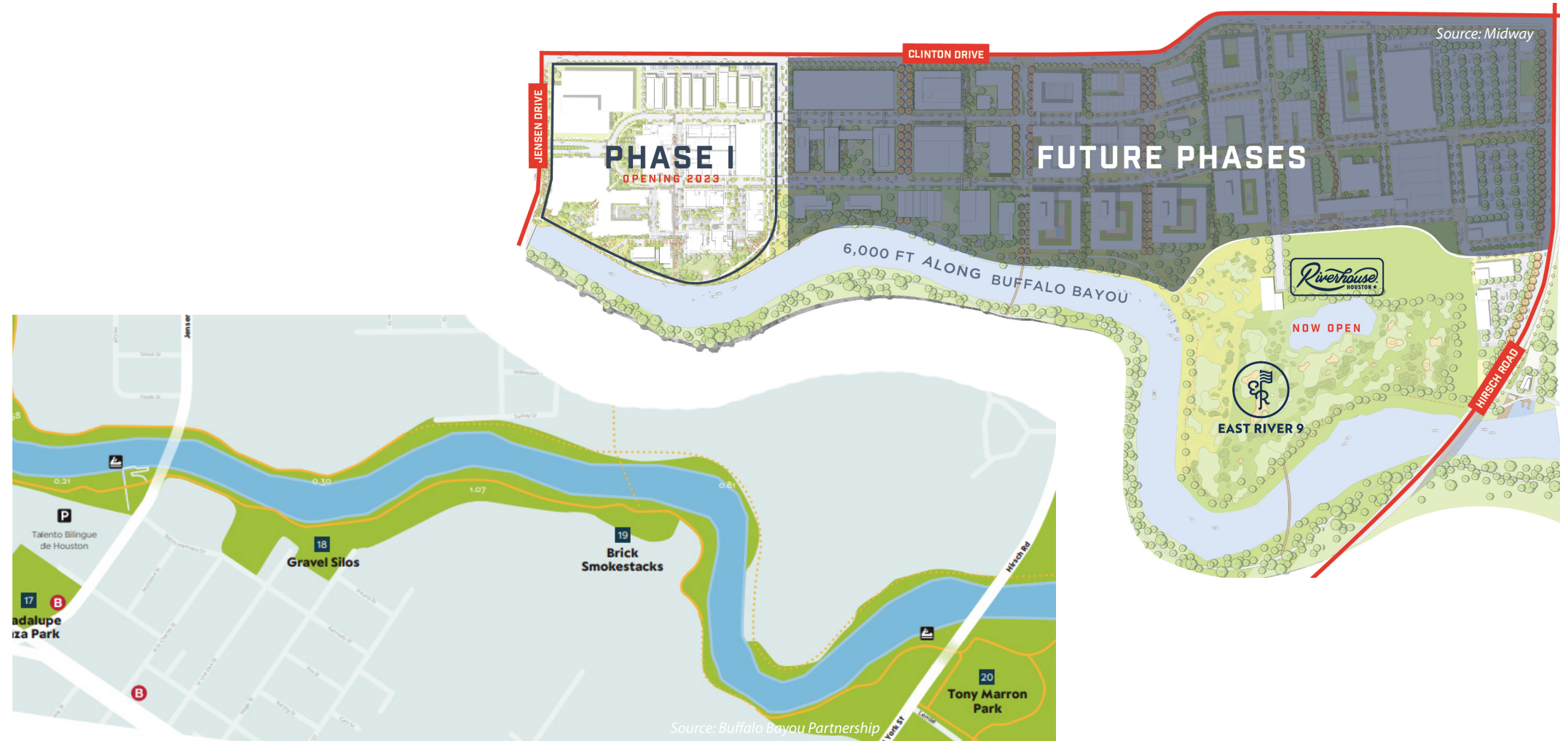
Approximately 500 feet away is The Esplanade at Navigation Blvd, a vibrant park filled with outdoor activities, cultural experiences, and community events.

Less than half a mile from the subject property, The Block is a 42,000 SF mixed-use redevelopment that includes coworking space and two retail/restaurant concepts.

Just a few blocks west of the new mixed-use redevelopment, The Mill, which will include 840,000 SF of multi-family, retail, and office.

Adjacent to Midway's East River, a 150 AC mixed-use development that will integrate a diverse range of housing options, retail, commercial, and recreational spaces.

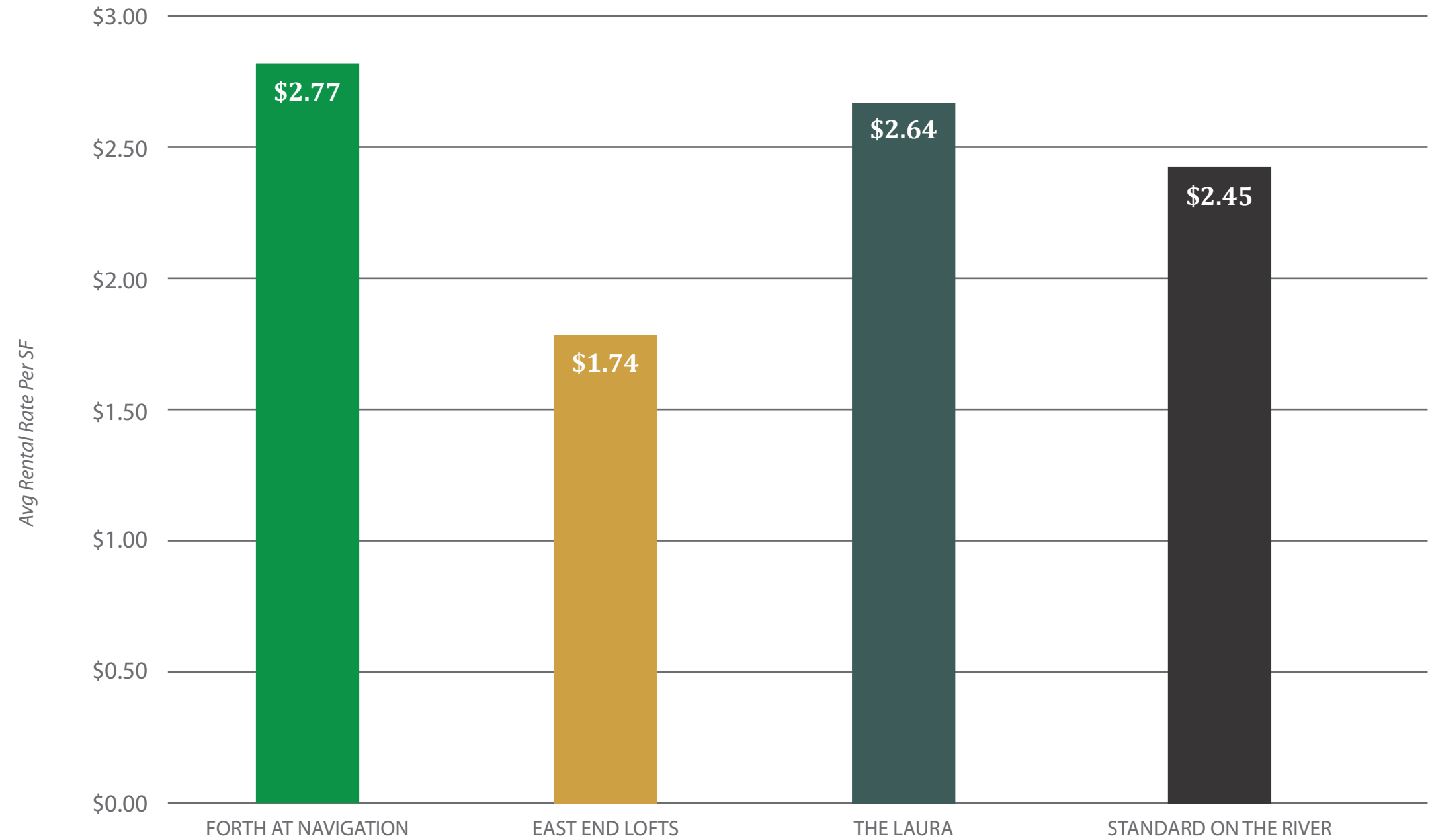
