the receipt whereof We do hereby acknowledge, do hereby give, grant, bargain, sell and convey unto the said PRO CONSTRUCTION AND DEVELOPMENT LLC, its successors and assigns forever,

## 37 MAIN STREET:

A certain lot or parcel of land, together with any and all buildings and other improvements located thereon, situated in the Town of Searsport, County of Waldo, State of Maine, more particularly bounded and described as follows:

"One store in the Merrithew Block, so-called, on the south side of Main Street in said Searsport, bounded on the east by the store occupied now or formerly as a post office and on the west by the store occupied now or formerly by F. A. Curtis and extending from cellar to ridge pole of the building."

Being the same premises as described in the deed from Pamela Riposta to Mark B. Riposta dated July 21, 2000 and recorded in Book 2018 Page 061 Waldo County Registry of Deeds.

The premises are conveyed together with and subject to any and all easements or appurtenances of record, insofar as the same are in force and applicable.

## 39 MAIN STREET:

A certain lot or parcel of land, together with any improvements thereon, situated in Searsport, County of Waldo, State of Maine, more particularly bounded and described as follows:

"Bounded on the north by Main Street; on the east by land of Mrs. Black; on the south by land of Isaac W. Ravoner, and on the west by the Merrithew and Gordon lot on which the brick store then occupied by Foss Hamilton stands; being the same premises described in deed of Charles F. Gordon and Eliza W. Gordon to Ann S. Sheldon dated May 24, 1879, and recorded in the Waldo County Registry of Deeds, Book 195, Page 143, said real estate being situated in Searsport in the County of Waldo and State of Maine."

"PARCEL III: ...BEGINNING at an iron post in the easterly line of the Mt. Ephraim Road, so called, and in line of the southerly boundary of the high school lot, co called; thence along the southerly line of said high school lot, easterly, seventy feet to an iron post; thence southerly parallel with said Mt. Ephraim Road, fifty-three feet, to an iron post; thence westerly, seventy feet to an iron post in easterly line of said Mt. Ephraim Road; thence northerly, along the easterly line of said Mt. Ephraim Road, fifty-three feet to place of beginning."
